



CNI application guidance and checklist

1. Fill in the forms below (on pages 5 and 7). There are examples of completed forms (on pages 3 and 4) to help you fill them in correctly. Ensure an approximate date in the future and place of marriage is specified on the Notice of Marriage. Do not sign them until you are in front of a notary.
2. Take the forms to a notary to sign them and have them 'notarised' (certified).
3. Complete your [online application](#), which will include uploading your notarised forms. Once completed and submitted online, you will receive an application reference number.
4. Write or print your application reference number and your email address on a piece of paper to send with your other documents.
5. Send your original notarised forms and your other documents to:

For security, you should send your documents by courier or registered post. Your application will not be processed until the British Consulate General Madrid gets your documents.



Checklist of documents to post

- ☐ Notarised CNI affirmation
- ☐ Notarised notice of marriage that specifies an approximate date in the future and place of marriage
- ☐ Application reference number and your email address

If you've been married before:

- ☐ The original document that proves any previous marriages or civil partnerships have ended, or a copy certified in the country where it was issued
- ☐ If you only have a digital document to show your marriage or civil partnership ended, an email, letter or other document from the court confirming they issued the document
- ☐ If your divorce or dissolution was outside the UK, evidence you or your ex-partner were a national of or resident in that country when the divorce or dissolution took place
- ☐ If your relationship to your husband, wife or civil partner is not on their death certificate, your marriage or civil partnership certificate

NOTICE OF MARRIAGE EXAMPLE

Print out the notice and fill in your details by hand. It's your responsibility to make sure the document is correct.

You must specify the date and place where the intended marriage is due to take place. If you do not know the exact date, you must provide an approximate month and year in the future. If this is left blank the Notice of Marriage will be rendered invalid.

Do not change the format or layout of the notice. If you do, the embassy or consulate will ask you to complete a new version and get it notarised, delaying your application.

Enter your details on the first row and your partner's details on the second row of the notice.

Enter name, nationality, gender/sex and date of birth exactly as they appear on your UK passport. Enter your partner's details exactly as they appear on their passport – or national identity card if they're not a British national.

AFFIRMATION EXAMPLE

Print out the affirmation and fill in your details by hand.

Make sure your details match what you've entered in your notice of marriage, for example, your name and address. It's your responsibility to make sure the document is correct.

Do not change the format or layout of the affirmation. If you do, the embassy or consulate will ask you to complete a new version and get it notarised, delaying your application.
