#### AB advice:

- Significant geographical distance between Inicio and Sandwich Technology school is a major concern risking less effective support.
- There is a lack of prior experience in turning around schools in special measures.
- Limited evidence of experience of working with highly deprived communities in selective areas.
- School improvement approach appears generic and not tailored to the specific challenges of the school.
- Some progress has been noted by Ofsted since Inicio began supporting Sandwich in January 2025 but, as per the May 2025 Ofsted monitoring report, more work is required for the school to no longer be judged as requiring special measures.
- A further monitoring inspection took place in September; the RD decided to defer a final decision until she has had the opportunity to review Ofsted's findings to inform this decision.
