# **Diplomacy**

UK, with France, is leading the <u>Coalition of the Willing</u> nations to support Ukraine's future security

UK-Ukraine 100 Year Partnership fosters cross-sector collaboration incl. defence & security, science & tech, economy & trade [16 Jan] Supported UNGA resolutions condemning Russia's: invasion [Feb 25, Feb 23, Mar 22]; attempted annexation of 4 Ukrainian regions [Oct 22]; & attacks on Ukraine's energy infrastructure [Jul 24] We use the UNSC to hold Russia to account & reaffirm support for Ukraine. UK used Presidency to mark 1000 days of invasion [Nov 24] At OSCE, we call out Russia weekly & co-fund Support Programme for Ukraine. 5 fact-finding missions reported on human rights abuses At IAEA, we support efforts towards nuclear safety in Ukraine

# **Military**

£10.8bn total & £3bn a year for as long as it takes [Jul 24]

Two thirds of £2.26bn contribution to G7 ERA Loan disbursed [14 Apr] UK therefore expects to provide £4.5bn total support in 2025 [16 Jan] £70m of ERA Loan to fund 350 ASRAAM air defence missiles [25 Jun] >85,000 drones delivered in 6mths & £600m invested in 2025 [14 Oct]

UK & Denmark joint-funding bespoke <u>air defence system</u> [16 Jan]

Defence Industrial Support Treaty [Jul 24] expanded export finance cover incl. £1.6bn for Thales to supply 5,000 LMM missiles [10 Jul]. Hundreds of missiles delivered 5 months ahead of schedule [10 Oct] UK/Ukraine agreement to share battlefield technology will boost UK drone production for Ukraine [23 Jun]

Op INTERFLEX: >60,000 trained; £247m invested in 2025 [4 Jun]; scheme extended until at least end 2026 [24 Aug]

UK-administered International Fund for Ukraine procures equipment: <u>>£2bn</u> pledged to date, incl. <u>£30m</u> Anduril UK drones order [6 Mar]

## **Non-military**

£5.3bn in non-military commitments since Feb 22. This includes:

- up to £4.1bn in fiscal support through World Bank loan guarantees up to £1.2bn in bilateral assistance. Up to £283m in 25/26 will fund

## Humanitarian

>£477m total assistance to Ukraine and the region to end FY 24/25, incl. over £120m in humanitarian assistance in 2024/25

£12.9 million for HALO Trust for mine action, incl. £4.3m for 2025/26. Over 659,000m<sup>2</sup> land cleared (May 22 to end Jun 25)

## **Recovery & Reconstruction**

War risk insurance via MIGA & EBRD boosts inward investment £3.5bn cover limit via UKEF for reconstruction projects supported reconstruction of 6 bridges & delivery of mine countermeasure vessels British International Investment, with EBRD has provided €30m for

MHP to protect jobs & boost resilience in the agriculture sector [10 Jul] Up to  $\underline{\mathfrak{L}10.5m}$  for Governance Reform Programme supports efforts on rule of law, justice and anti-corruption [10 Jul]

## Energy

Over £450m for energy security and resilience through grant, in-kind support and loan guarantees

£128m for the Ukraine Energy Support Fund including £42m for vital electricity network repairs and critical protection for gas & power infrastructure [12 Sep]

£1m for Ukraine's Green Transition Office in 25/26 [10 Jul] £17m to support UK and Ukrainian innovators through a second round of UK's Innovate Ukraine Green Energy Competition [5 Feb]

### **Sanctions**

>2,900 individuals, entities & ships sanctioned under the Russia sanctions regime, incl. >2,600 since Putin's full-scale invasion >520 'Shadow Fleet' vessels sanctioned for transporting Russian energy in violation of the Oil Price Cap. With EU, we are lowering the Oil Price Cap to \$47.60 a barrel, directly hitting revenues [18 Jul]

UK, US and EU sanctions have denied Russia access to at least 450bn since Feb 2022 - equiv. to 2 years funding for the invasion

Russia pays up to 6x more for dual-use items & defence sector components rose 30% over 3 years compared to global prices

This Government has imposed sanctions against:

- 90 targets incl. oil giants Rosneft & Lukoil [15 Oct]
- <u>70 more shadow fleet ships</u> & 30 entities & individuals propping up Putin's war machine [12 Sep]
- <u>8 individuals & 3 organisations</u> forcibly deporting, indoctrinating & militarising Ukrainian children [3 Sep]

# **War Crimes & Justice**

£4.5m new funding to support Ukraine's domestic war crimes investigations - total funding now £11.5m [Dec 24]

Additional £2.3m to the International Criminal Court

Support establishing Special Tribunal for the Crime of Aggression - Ukraine ratified bilateral agreement with CoE [15 Jul]

Register of Damage for Ukrainians to record war-related losses. UK chairs governing body & supports creating Claims Commission - CoE Committee of Ministers approved draft convention [22 Oct]

Our <u>City-Ukraine Hub</u> leverages UK expertise to deliver capacity building projects

Insurance through the UK-developed <u>Unity facility</u> & equipment to deter attacks supported the Black Sea maritime corridor enabling Ukraine to <u>export</u> its goods, incl. all of its 2023 & 2024 harvests

UK-Ukraine Political, Free Trade & Strategic Partnership Agreement enables <u>tariff free trade on all goods</u> until 31 March 2029 (eggs & poultry until 31 March 2026) [Feb 24]

### Ukrainians in the UK

226,600 Ukrainians have arrived in the UK, including 167,300 via Homes for Ukraine [as of 30 Jun]

<u>Ukraine Permission Extension Scheme</u> opened Feb 25 & <u>extended</u> by 24mths [1 Sep]. 80,704 applications granted [as of 30 Jun]
