Monthly Summary

- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of air quality and dust monitoring undertaken in the London Borough of Camden (LBC) during August 2025 and September 2025 respectively.


Figure 1 to Figure 5: Worksites and monitoring locations within the LBC

- 1.1.2 Figure 1 to Figure 5 in Appendix A present the current worksites together with air quality and dust monitoring locations.
- 1.1.3 This summary should be read in conjunction with the overview monitoring report available from www.gov.uk/government/collections/monitoring-the-environmental-effects-of-hs2, which highlights: the applicable standards and guidance, as well as the air quality and dust monitoring methodologies to be implemented by nominated undertakers throughout construction.
- 1.1.4 The current worksites, as presented in Appendix A, Figure 1 to Figure 5, include:


- Completed power supply installation for the ATS monitoring system at Euston Square station.
- Completed recovery of redundant cables and associated equipment in the old Melton street vent shaft.
- Completed the Tranche 4 repair works in Euston Station.
- Completed sewer survey's in Eversholt Street and surrounding areas.
- 1.1.5 Twenty-nine (29) dust monitors are installed around these worksites, where works are underway. These sites returned a medium to high dust risk rating.
- 1.1.6 Dust monitoring locations and results are presented in Appendix B, Table 1, together with line charts of monthly data from each dust monitor in Figure 6. All continuous dust monitoring is undertaken using indicative monitors. Despite being Environment Agency (MCERTS) certified, indicative monitors carry a higher level of uncertainty than reference monitors, and therefore cannot be strictly compared with Air Quality Standards for human health and the environment. The purpose of the monitoring undertaken is to ensure the effectiveness of the on-site mitigation.
- 1.1.7 The trigger level for PM_{10} concentrations of 190 μ g/m³, over a 1-hour period, in accordance with the updated guidance document 'Guidance on Monitoring in the Vicinity of Demolition and Construction Sites (October 2018)' has been applied.
- 1.1.8 No (0) dust trigger alerts were recorded during the monitoring period (September 2025).
- 1.1.9 Data capture was below 90% for multiple monitors:
 - AQ054: Arrangements for a 3rd party contractor to isolate the CCTV column on which the monitor is mounted in order for it to be replaced are yet to be agreed. The currently installed monitor is no longer operating. The monitor should be replaced in October 2025.
 - AQ009: This monitor was removed during the previous monitoring period and returned to the manufacturer to fix an airflow error. The repaired monitor was then reinstalled during a site visit on 12/09/2025.
 - AQ003: A fault with the battery which commenced 02/09/2025 limited the data captured. This was resolved on 12/09/2025 by switching out the faulty monitor for a newly repaired one. The faulty monitor was then sent for repair.




- 1.1.10 Diffusion tube monitoring of Nitrogen Dioxide (NO₂) is undertaken at sixty-four (64) locations around highways within the LBC as part of the management of air quality where significant effects may occur as a result of the scheme.
- 1.1.11 Diffusion tube monitoring results are as provided from the laboratory analysis, and therefore still require various analysis and adjustments to be undertaken. Final corrected results will be presented and described in the annual report. However, based on the results to date, no unexpected values were recorded during the monitoring period.
- 1.1.12 NO₂ monitoring locations and results are presented in Appendix C, Table 2, together with the 2025 running mean.
- 1.1.13 There were no (0) complaints received during the reporting period (September 2025).







