# **Monthly Summary**

- 1.1.1 This Summary Report is published in fulfilment of commitments detailed in the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, Annex 1: Code of Construction Practice, for the nominated undertaker to present the results of air quality and dust monitoring undertaken in Lichfield District Council (LDC) during September 2025.
- 1.1.2 Figures 1 and Figure 2 in Appendix A presents the current worksites together with the dust monitoring locations.




- Decommissioning works.
- 1.1.5 Eight (8) dust monitors are installed around these worksites, where works are underway. These sites returned a negligible to medium dust risk rating.
- 1.1.6 Dust monitoring locations and results are presented in Appendix B, Table 1, together with line charts of monthly data from the dust monitors presented in Figure 3. All continuous dust monitoring is undertaken using indicative monitors. Despite being Environment Agency (MCERTS) certified, indicative monitors carry a higher level of uncertainty than reference monitors, and therefore cannot be strictly compared with Air Quality Standards for human health and the environment. The purpose of the monitoring undertaken is to ensure the effectiveness of the on-site mitigation.

- 1.1.7 The trigger level for  $PM_{10}$  concentrations of 190  $\mu$ g/m<sup>3</sup>, over a 1-hour period, in accordance with the updated guidance document 'Guidance on Monitoring in the Vicinity of Demolition and Construction Sites (October 2018)' has been applied.
- 1.1.8 No (0) dust trigger alerts were recorded during the monitoring period (September 2025).
- 1.1.9 Data capture was below 90% for multiple monitors:
  - SCRS001: This monitor experienced technical issues. A monitor swap out was carried out on 4<sup>th</sup> September 2025. After the site visit, the technical issues were resolved.
  - WCC001: This monitor experienced technical issues. A full dust work up was carried out on 2<sup>nd</sup> October 2025. After the site visit, the technical issues were resolved.
- 1.1.10 There were no (0) complaints received during the reporting period (September 2025).
