Data security is our highest priority

We are committed to safeguarding your LLC information to preserve the integrity of the LLC Register. As part of this commitment, we have completed the first phase of a major upgrade, which transitioned API users from port 9000 to port 443. This change strengthens the connection between the API and the LLC Register, leveraging the advance capabilities of port 443.




Our Service Performance Integration team is already exploring new ways to harness these capabilities further. In the coming months we will share details of new security measures that will deliver even greater resilience against data threats.

Live service survey – next steps

We would like to say thank you to the local authorities (LAs) who completed the Live Service survey. Your feedback is invaluable, so we are pleased that we received 98 responses across the 131 LAs currently in live service.



Our **Service Performance Integration (SPI) team** is currently conducting a detailed analysis of the responses. Following an initial review, several themes have emerged, which are shaping a series of recommendations designed to enhance the live service experience.

Recommendations

- Simplify and streamline reports: provide clearer guidance and summaries that focus on outstanding remedial actions.
- Enhance communication and collaboration: encourage more direct engagement across LA departments, to enable timely, accurate registrations. Encourage better communications between HMLR, LAs and third-party suppliers.
- Technical support and training: offer more targeted technical support and training for complex API or mapping issues.

- Resource and process support: streamline processes and provide tools to help LAs manage their workloads during periods of limited resource.
- Raise Memorandum of Understanding (MOU) awareness: to improve compliance and process efficiency.
- Strengthen communications:
 promote regular meetings and
 reminders about outstanding
 remedial actions. Ensure query
 handling is responsive and
 escalation routes for unresolved
 issues are clear.

We will share details of the next steps when the analysis is completed, and an action log has been developed. This information will be communicated in the LLC newsletter to ensure all LAs are kept informed.

5 top tips for a successful migration

As the Local Land Charges (LLC) Programme advances, we are gaining more valuable insight into the factors that contribute to a smooth and successful migration. Drawing on feedback from local authorities (LAs), Delivery and Relationship Managers, we have compiled some top tips for LAs beginning or currently undergoing their migration.

- Consider a top-down approach

 early engagement and visible support from senior leadership contribute significantly to a well-managed migration. LAs who secure senior level buy-in from the outset typically have smoother, more successful transitions.
- Create a dedicated project team – ensure all relevant departments are engaged and have a clear understanding of the

- project's scope. Define roles and responsibilities early to maintain accountability throughout the process.
- Start data cleansing early –
 assigning a small team to begin
 data cleansing early, or even before
 migration begins, can relieve
 pressure later. It can also free-up
 resource for other critical tasks.
- Learn how to register a charge before going live – migration introduces new systems and processes. Gaining an early understanding of how to register a charge will reduce challenges when the service goes live.
- Communication is key good and consistent collaboration between the LA, HM Land Registry and suppliers is essential for a smooth, successful migration. Regular communications and a willingness to ask for assistance when needed, will help to eliminate issues.

Making progress to complete the programme

This November, the Local **Land Charges Charges** (LLC) Programme together with local authorities (LAs) across England and Wales reached some significant milestones. With over 40% of LAs now live on the LLC Register, we are collectively transforming the property market. The impact on the market is clear, searches that once took days or weeks are now available instantly, saving an average 12.26 days per search.

Since the first local authority went live in July 2018 we have:

- registered over **8.1 million** charges
- recorded more than 2 million search requests on the register
- saved a total of over **£3.8 million**.


Matt Green, CEO of the tmGroup said: "Having worked closely with HM Land Registry for many years, we have seen first-hand the transformative impact of their digitisation efforts.

The LLC Programme represents another significant step forward for the property industry. High-quality, accurate data is vital in conveyancing. Any error or inconsistency can cause delays and

frustration for everyone involved in the transaction chain.

When the programme is completed, the benefits will be clear. Reliable, standardised local land charges data will help conveyancers work more efficiently and give homebuyers greater confidence in their transactions."

The signing of the final LA Collaboration Agreement confirms full participation across England and Wales, ensuring programme benefits are felt nationwide. The programme remains focused on delivering seamless transitions for LAs and a more streamlined experience for the wider property market.



The national LLC Register cost savings

Since it launched in 2018, the LLC Register has

- saved customers over
 £3.6 million for searches
 made in migrated areas
- saved customers an average of 12.26 days to obtain an LLC search result
- migrated more than
 8.1 million charges from
 137 local authorities
 to the register.

358,013 official searches 1.629.844 personal (free) searches 1.987.362 total searches on the register


