Project: The following academies to transfer from University of Brighton Academies Trust to Mulberry Schools Trust:

- The Hastings Academy, URN:136401, East Sussex

- The proposed trust's existing work in East Sussex and knowledge of the area was raised as an important consideration, given the unique challenges in Hastings.
- Some of the trust's existing programmes were highlighted, such as the Changemakers programme and the benefit that this could have in Hastings.
