Summary of Proposed Amendment

Objective: Uplift of named Regulatory Articles as a result of terminology changes and to incorporate outstanding Requests for Change.

Changes made:

RA 1016

Changes to Footnote 3 in line with terminology updates (RPAS > UAS).

Removal of Para 14 as stated where an Air System is operated for less than 6 months then a Mil CAMO may not be required. To operate without a Mil CAMO would require a Waiver against other Regulatory Articles, regardless of period of time.

Changes to Para 15, removing the ability for the Mil CAM to also hold the position of the Head of the Independent System Monitoring.

Alternative wording used in Guidance Material in place of "is to" and "are to".

Removal of Footnote 8 (moved to RA 4945 AMC).

RA 4943

Expansion of Para 15f with the wording "if listed in the CAME as having specified CAw responsibilities".

Alternative wording used in Guidance Material in place of "is to" and "are to"

Change of wording in Annex A from "must" to "should"

Addition of Issue number column in Annex A.

Capitalization of various terms listed in MAA02 since the last issue of RA 4943.

Addition of Para 2 – incorporating the content of the former Footnote 8 of RA 1016. Reword of Para 4 for clarity around delegating Mil CAM responsibilities to DCAMs. Capitalization of various terms listed in MAA02 since the last issue of RA 4945.
