The Board heard an update on the work of its sub-group, the Innovation Delivery Board, including a review of delivery progress for the 2022-25 net zero research & innovation portfolio. The Board provided feedback on the draft progress report for the Net Zero Research & Innovation Framework Delivery Plan (2022-25) which is due to be published in Autumn 2025.
