# Cambridgeshire

#### **Trust changes**

 An application for Abbey College [URN:137377], Ramsey, Cambridgeshire, to transfer from Abbey College, Ramsey SAT to Meridian Trust.

#### **Central Bedfordshire**

### **Trust changes**

 An application for Gilbert Inglefield Academy [URN: 138003], Central Bedfordshire, to transfer from Gilbert Inglefield Academy Trust to Chiltern Learning Trust.

#### Hertfordshire

### Trust changes

 An application for Larkspur Academy [URN:146359], Hertfordshire, to close by mutual consent in August 2026 through termination of the Funding Agreement with Ivy Learning Trust.

#### Luton

### **Converter academy Order**

 An application from Luton Sixth Form College [URN:130600], Luton, to convert and become an academy and form a new trust called Luton Sixth Form Academy Trust (LSFAT).

## Glossary of project types

## **Converter academy orders**

Where the governing body of a local authority maintained school has applied to become an academy and wants to join an existing academy trust or set up a new academy trust with other local authority maintained schools.

## Sponsored academy orders

Where a local authority maintained school is becoming an academy because it has been judged inadequate by Ofsted or is not making the necessary improvements, meaning it is currently judged as requires improvement, having been judged below good in its previous inspection.

## Establishing a new academy through the free school presumption route

Where a local authority has identified a need for a new school in its area and invited applications from trusts to be accountable for the new school.

## Significant changes to an open academy

A change which may have a 'significant' impact on the local school environment, through changing the number and/or type of school places and/or where they are offered.

## **Trust changes**

Where an academy is moving from one academy trust to another, including where two or more academy trusts are coming together and academies within those trusts are moving to the new trust. It also includes where a single academy trust applies to become a multi academy trust.
