INTRODUCTION

HM Inspectorate of Prisons (HMIP) and HM Inspectorate of Probation for England and Wales are independent inspectorates which provide scrutiny of the conditions for, and treatment of prisoners and offenders. They report their findings for prisons, Young Offender Institutions, and effectiveness of the work of probation, and youth offending services across England and Wales to Ministry of Justice (MoJ) and His Majesty's Prison and Probation Service (HMPPS). In response to the report HMPPS / MoJ are required to draft a robust and timely action plan to address the priority and key concerns. Action plans provide specific steps and actions to address the priority and key concerns, that are clear, outcome focussed, measurable, achievable, and relevant with the owner and timescale of each step clearly identified. Action plans are sent to HMIP and published on the GOV.UK website. Progress against the implementation and delivery of the action plans will also be monitored and reported on.

£11.5k of funding for this financial year has been secured to improve the current Incentivised Substance Free Living (ISFL) Unit and these funds will be used to improve the general environment of the unit. £25k has been secured for this financial year to develop the current Drug Recovery Unit on A Wing to support prisoners receiving opiate substitute treatment. The funds are being used to enhance the physical environment to promote wellbeing, reduce triggers and support individuals in addressing substance misuse.	Governor	April 26
