### Nomination/ Revocation of Death Benefit (AFPS05/RFPS05/AFPS15)

#### Important Information:

Submit this form if you wish to make a nomination to an organisation or to someone who is not your spouse, civil partner or eligible partner.

Under the rules of the Armed Forces Pension Scheme (AFPS) 05, the Reserve Forces Pension Scheme (RFPS) 05 and the AFPS 15, if you die without making a valid nomination, your lump sum will normally be paid to your spouse, civil partner or eligible partner. If you are a member of AFPS 05 or RFPS 05, and are not married or in a civil partnership, it will go to your personal representatives/estate. If you are a member of AFPS 15, it will go to an eligible dependent.

Completing a Service (or other) Will does not entitle beneficiaries of that Will to receive your death in service lump sum. You need to complete a nomination form to ensure that the lump sum goes to the right person(s) and/or organisation.

You are responsible for keeping your nomination form up to date so that it takes account of changes in your personal circumstances. These might include: divorce, legal separation, the death of someone you have nominated, or the birth of a child. If you are separated from your spouse or civil partner and you have not changed your nomination form, they will still receive your lump sum payment.

This form must be sent by post. Copies received by e-mail will not be accepted.
