

### Greater Manchester Combined Authority Integrated Settlement – Spending Review 2025

The figures in this table relate to the outcome of Spending Review 2025 and set the Integrated Settlement-quantum for revenue spending until 2028/29, and until 2029/30 for capital investment. There will be scope at Spending Review 2027 to re-examine budgets for years 2028/29 and 2029/30. Further publications will follow the outcome of Spending Review 2027 relating to that period.

Some figures remain outstanding and will be confirmed in due course. These tables will be updated as final amounts are confirmed.
