<sup>6</sup> "Scottish inshore waters" means the sea adjacent to the coast of Scotland and to the landward of a limit of 6 nautical miles from the baseline from which the territorial sea is measured, up to the mean high water mark of ordinary spring tides.

<sup>8</sup> Mackerel caught in ICES Division 4a in the periods between 1 August and 15 February shall be recorded against the Western mackerel quota. All other catches of mackerel in ICES Division 4a shall be recorded against the North Sea mackerel quota and shall be subject to any quota limitations set out at **Part 2** of this **Annex**.
