## **1. Introduction**

This updated guide sets out the Fee Codes for crime lower claims under Submit a Bulk Claim (SaBC) and the Fees, Hourly Rates and Limits/Thresholds for each Fee Code.

Every individual crime lower Fee that may be submitted through SaBC has its own specific Fee Code, which must be used to ensure the correct Fee is paid.

This guide should be read in conjunction with the Guidance on Reporting Crime Lower Work, which sets out the reporting fields that need to be completed to make a crime lower claim under SaBC. The Guidance for Reporting Crime Lower Work, and other guidance on submitting claims on SaBC, is available at [Submit a Bulk Claim \(SaBC\) - GOV.UK](#).

Section 3 of this guide is a summary of the Fee Codes under each Class of Work. Sections 4, 5, 6 & 7 set out for each Class of Work the individual Fee Codes and Fees, Hourly Rates and Limits/Thresholds (as appropriate).

Crime Lower claims with a UFN/representation order date before 1 April 2016 cannot be submitted through the SaBC. The Guidance on Reporting Crime Lower Work will be updated in due course as to the position relating to any such outstanding claims.

## 4. Criminal Investigations

### 4.1 - Freestanding Advice and Assistance

A Claim for (stand-alone) Freestanding Advice and Assistance must be submitted under Fee Code **INVA**.

The total actual costs should be entered using the relevant hourly rates in table 1. The total actual costs (including disbursements) must not exceed the relevant Upper Limit in the table 2, unless an extension to the Upper Limit has been granted in accordance with 5.5 to 5.16 of the 2025 Standard Crime Contract Specification.

## 4.2 - Police Station Telephone Advice Fixed Fee

A Claim for a Police Station Telephone Advice Fixed Fee must be submitted under either Fee Code **INVB1 (in London)** or **INVB2 (outside London)**. The relevant Fixed Fee should be entered in the profit costs field (there are no hourly rates for this Fee with which to calculate actual costs).

## 4.3 - Police Station Attendance Fixed Fee

A Claim for a Police Station Attendance Fixed Fee must be submitted under Fee Code **INVC** (including for an investigation by the Services Police or an Immigration Offence covered under Police Station Advice and Assistance).

Actual costs should be entered using the hourly rates in table 1. The actual costs will be replaced by the Fixed Fee payable and be used to calculate whether the Escape Fee Threshold has been met. Table 2 sets out the Fixed Fee and Escape Fee Threshold payable in all Police Station Schemes for UFNs dated 22/12/2025 onwards.

For UFNs dated up to and including 21/12/2025, the Fixed Fee and Escape Fee Threshold vary by Police Station Scheme (determined by the Police Station ID in which the attendance took place). These Fixed Fees and Escape Fee Thresholds are set out in the 'New Fee Codes' spreadsheet at [Submit a Bulk Claim \(SaBC\) - GOV.UK](#).

## Destination Police Stations

For cases with a UFN on or after 6 December 2024, travel to a limited number of specified Police Stations (Destination Police Stations) from an Office within an Attending Duty Scheme may be claimed for Duty and Own Client attendances. This travel may be claimed in addition to the relevant Fixed Fee and is claimed at the relevant National travel hourly rates in the above table. This travel must be claimed in accordance with the process set out at Annex A1 of the [Guidance on Reporting Crime Lower Work](#) which also lists the applicable Destination Police Station schemes and Attending Duty Schemes.

### **CDS Direct Acceptance Fee**

The CDS Direct Fixed Acceptance Fee is £8.40 for UFNs dated 30/09/2022 onwards (and £7.30 for UFNs dated 01/04/2016 to 29/09/2022). This fee is not claimed separately to the Police Station Attendance Fixed Fee but is included as Profit Costs to determine whether a case breaches the escape fee threshold.

## **4.4 - Advocacy Assistance on a Warrant of Further Detention Hearing or an Armed Forces Custody Hearing**

A Claim for Advocacy Assistance on a Warrant of Further Detention or Armed Forces Custody Hearing must be submitted under Fee Code **INVE**.

The total actual costs should be entered using the relevant hourly rates in tables 1 & 2. The total actual costs (including disbursements) must not exceed the relevant Upper Limit in table 3, unless an extension to the Upper Limit has been granted in accordance with 5.5 to 5.16 of the 2025 Standard Crime Contract Specification.

The total actual costs (including disbursements) must not exceed the relevant Upper Limit in table 2, unless an extension to the Upper Limit has been granted in accordance with 5.5 to 5.16 of the 2025 Standard Crime Contract Specification.

The total actual costs (including disbursements) must not exceed the relevant Upper Limit in table 2, unless an extension to the Upper Limit has been granted in accordance with 5.5 to 5.16 of the 2025 Standard Crime Contract Specification.

## **5. Criminal Proceedings**

### **5.1 - Advice and Assistance and Advocacy Assistance by a court Duty Solicitor**

A Claim for Advice and Assistance and Advocacy Assistance by a court Duty Solicitor must be submitted under Fee Code **PROD**.

The total actual costs should be entered using the relevant hourly rates in the table below.

## 5.2 - Standard Fees - Representation in the Magistrates Court

A claim for a standard fee for Representation in the Magistrates' Court must be submitted under the correct Fee Code listed in this section. There are 20 individual Fee Codes covering each combination of the following four factors that determine the standard fee payable:

- whether an undesignated area or designated area standard fee is payable;
- the category of the case (1A, 1B or 2 as per paragraph 5 of Schedule 4 of the Remuneration Regulations);
- whether a lower or higher standard fee is payable, using the profit costs hourly rates in table 1 to calculate the total value of the case, and then applying that value to the lower and higher standard fee limits in table 2\*;
- whether it is a second claim for a deferred sentence (category 1A or 1B only).

See 10.47 to 10.94 of the 2025 Standard Crime Contract Specification for further information on standard fee claims.

Actual profit costs should be entered into the profit costs field, but the correct Fee Code must be used to ensure the correct standard fee is paid. Where you are not in a position to enter the actual profit costs into SaBC, the value of the standard fee may be entered instead, but again, the correct Fee Code must be used to ensure that standard fee is paid.

Actual travel and waiting costs, as per the hourly rates in table 3, are payable in addition to undesignated area standard fees. Actual travel and waiting costs may be reported on designated area standard fee claims, but are not paid.

\*Where the total value of the case exceeds the higher standard fee limit, the case is remunerated on an hourly rates basis as a non-standard fee. The claim is not made through SaBC. Instead, the claim is submitted either online through the Claim a Non-Standard Magistrates Court fee online service or by submitting a paper copy of the CRM7 form to the relevant processing centre.

## 7.2 - Prison Law Advocacy Assistance

A claim for a standard fee for Advocacy Assistance must be submitted under the correct Fee Code listed in this section. There are 8 individual Fee Codes, two for each of the following 4 types of Prison Law Advocacy Assistance:

- Disciplinary Cases

- Sentence Cases
- Parole Board Hearings
- Parole Board Reconsideration Hearings & Parole Board Set Aside Hearings

Each type of Prison Law Advocacy Assistance has a Fee Code for its Lower Standard Fee and a Fee Code for its Higher Standard Fee. The total value of the case should be calculated using the hourly rates (excluding the travel hourly rate) in the first table. The total value should then be applied against the relevant lower and higher standard fee limits in the subsequent tables to determine whether a lower or higher standard fee is payable.

The correct Fee Code, as set out in the tables below, must then be used to submit the claim, determined by the type of Prison Law Advocacy Assistance and whether a lower or higher standard fee is payable.

Actual costs should be entered, but the correct Fee Code must be used to ensure the actual costs are replaced by the correct Standard Fee.
