#### Camden

##### Convertor Academy Order

**An application for St Eugene De Mazenod Roman Catholic Primary School (100047) and Our Lady Roman Catholic Primary School (100048) to convert and become academies and join All Saints' Trust (TR03162)**

**Representations received:** Yes - concerns were raised about the potential impact of academisation on the schools' strong collaborative ties within Camden Learning, as well as wider issues including financial sustainability. The Regional Director (RD) and Advisory Board (AB) noted the concerns but concluded that joining All Saints' Trust provides a strong framework for sustaining the schools' ethos, educational outcomes and financial viability underpinned by credible financial forecasts.

**Decision:** Approved with an expectation that the schools will continue their collaboration with the Camden Learning partnership, which supports positive outcomes.

## **Hammersmith and Fulham and Westminster**

### **Converter Academy Order**

**An application for St Thomas of Canterbury Catholic Primary School (100357) in Hammersmith and Fulham and St Vincent's Catholic Primary School (101143) and St Vincent De Paul Catholic Primary School (101144) in Westminster to convert and become academies and join Saint John Southworth Catholic Academy Trust (TR03141)**

**Representations received:** None

**Decision:** Approved subject to a School Resource Management Adviser (SRMA) being appointed (subject to availability).

## **Tower Hamlets**

### **Trust Change**

**An application for all three academies in Canary Wharf College Ltd (TR00383) to transfer into University Schools Trust (TR02349)**

**Representations received:** Yes - around 100 representations were received. These were shared with all attendees in advance of the meeting and considered alongside the application.

The Regional Director (RD) and Advisory Board (AB) noted the concerns raised in the representations and the strength of feeling from a number of CWC families, notably regarding operational matters such as the timing of the school day and year. It was also noted, however, that operational issues such as these are a matter for the academy trust, based on the authority devolved through legislation and the funding agreement. The RD concluded that CWC and UST trusts had made the case that the transfer will contribute to maintaining and improving the performance of all schools in the amalgamated trust.

**Decision:** Approved on the condition that support is provided to the Chief Executive Officer of UST by an experienced CEO of a larger, established multi-academy trust (MAT) to share good practice and ensure that the trust's growth is successfully embedded. DfE to review progress with integrating the two trusts. UST to implement any changes recommended by their recently commissioned external review of governance arrangements.

**An application for Wandle Valley Academy (137507), part of Parallel Learning Trust (TR02687), to transfer into Alternative Learning Trust (TR03900)**

1. Trust to provide confirmation that all key roles, currently not salaried, are on the payroll by summer term 2026.
2. School Resource Management Adviser (SRMA) to be appointed and a date agreed (subject to availability) by 1 April 2026.
3. Trust to consolidate for the remainder of this academic year. No further applications for growth will be considered this year except for schools planning to join the trust from September 2026 onwards. To be reviewed on a rolling 12-month basis.
