How to use this form

- This Supplementary Form must be completed if your EWCO application includes common land or shared grazing. It will form part of your application.
- The individual who will sign a EWCO Agreement on behalf of the common land or shared grazing group or association must complete Sections 1 and 2 and sign Section 4. This person, whose details will be listed at Section 1 of this form, will be referred to as 'the applicant'.
- The owner of the common land or shared grazing must sign Section 3 (unless there is no owner, or the owner is the applicant listed at Section 1, in which case Section 3 should be left blank).
- If you require more space for any section please continue on a separate sheet, ensuring that you label this clearly with the section of the form it relates to and sign and date each additional sheet.

A full list of rightsholders (from the local authority commons register and your own investigations) and their rights must be included with the application and it must show participants and non-participants, identifying non-participants who actively exercise their rights.

By checking this declaration box, you are confirming that you have read, understood, and agree to each declaration below (1 to 7). If you do not accept these declarations your EWCO application will be rejected. Failure to comply with any obligations below could lead to payments being stopped and reclaimed.

1. In respect of my EWCO application, the customer registration (SBI¹) for the common land or area of shared grazing includes the names of all persons who will benefit from or contribute to the delivery of any resulting EWCO Agreement (the Forestry Commission will not offer a EWCO Agreement until this has been confirmed).

4. I have contacted all graziers or other persons who are entitled to exercise grazing rights over the common or area of shared grazing that is included in my EWCO application (from information recorded on the local authority commons register and from my own other reasonably exhaustive enquiries).
5. I acknowledge that, if this application leads to a EWCO Agreement, I will be responsible for doing whatever is reasonably practical to ensure that all such relevant persons now known to me under declaration 4 comply with the Grant Funding Agreement Terms and Conditions.
6. I understand and accept that the Forestry Commission will not become involved in any disputes between rightsholders in relation to this application or any subsequent Agreement; the distribution or use of the Grant; or any dispute that arises from such distribution or use.
7. I am/we are not aware of any reason why it would not be possible for the Standard Cost Items or Actual Cost Items to be delivered for the duration of any EWCO Agreement on the common or area of shared grazing.
