# Non-Technical Summary

This Noise and Vibration Monitoring Report fulfils HS2 Limited's commitment detailed in the Environmental Minimum Requirements (EMRs), Annex 1, Code of Construction Practice, to present the results of noise and vibration monitoring carried out within the London Borough of Ealing (LBE) during the month of October 2025.

In addition, select monitoring locations in the London Borough of Hammersmith and Fulham (LBFH) and London Borough of Brent (LBB) associated with HS2 sites within LBE are presented in this report.

Within this period monitoring was undertaken at the following worksites:

- Mandeville Road Ventilation Shaft worksite (ref.: MRVS), where pile trimming, excavation, earthworks, concrete element construction, installation of steel elements, basement slab works, compound operation works and spoil removal were underway.
- Green Park Way Ventilation Shaft worksite (ref.: GPWVS), where general site operations, utility works, maintenance of shaft dewatering system and tunnel boring machine works were underway.
- Westgate Ventilation Shaft (ref.: WVS), where general site maintenance, cladding, steelwork and brackets installation, removal of backfill, construction of secondary lining, concrete cutting and site security were underway.
- Atlas Road worksite (ref.: AR) where general maintenance works, tunnel bore machine construction support, transfer of tunnel boring machine back up and conveyor components, grout jetting and general support tasks were underway.
- Willesden EuroTerminal worksite (ref.: WET), where general site maintenance, spoil removal, tunnel segments delivery and general support tasks were underway.
- Victoria Road Crossover Box worksite (worksite ref.: VRCB), where support works for tunnelling, removal of tunnelling infrastructure, operation of craneage, ventilation fans and water treatment plant, installation of steel elements, tunnelling works, tunnel strip out, concrete invert, tunnel demobilisation and secondary lining construction were underway.
- Flat Iron compound (worksite ref.: FIC), where support works for tunnelling, removal of tunnelling infrastructure, operation of craneage, ventilation fans and water treatment plant, installation of steel elements, tunnelling works, tunnel strip out, concrete invert, tunnel demobilisation and secondary lining construction were underway.
- Old Oak Common depot worksite (ref.: OOC), where materials management and haulage, steel fixing, formwork, falsework, concrete works, excavation, backfilling,

trench boxes fitting, pipe installation, road sweeping, road works, installation of modules, blockwork, piling, store set up, and striking were underway.

Further works, where monitoring did not take place, were also undertaken at the following location:

- On network works (south of Wells House Road), where overhead line equipment and civil works were underway.
- Northolt Tunnels East and East Cross Passage, where removal of tunnelling infrastructure, conveyors, pipework, cabling and temporary walkways, segment repair, leak sealing, secondary lining and cross passage construction works were underway.

The HS2 threshold levels for significant noise impacts, which are defined in Information Paper E23 (<https://www.gov.uk/government/publications/hs2-information-papers-environment>), were exceeded eight (8) times during the reporting period.

There were no exceedances of trigger levels as defined in Section 61 consents during the reporting period.

Two (2) complaints were received during the monitoring period. A description of complaints, the results of investigation and any actions taken are detailed in Table 8 of this report.

Acronym/Term	Definition
$L_{Aeq,T}$	See equivalent continuous sound pressure level
Ambient sound	A description of the all-encompassing sound at a given location and time which will include sound from many sources near and far. Ambient sound can be quantified in terms of the equivalent continuous sound pressure level, $L_{pAeq,T}$
Decibel(s), or dB	Between the quietest audible sound and the loudest tolerable sound there is a million to one ratio in sound pressure (measured in Pascal (Pa)). Because of this wide range, a level scale called the decibel (dB) scale, based on a logarithmic ratio, is used in sound measurement. Audibility of sound covers a range of approximately 0-140dB.
Decibel(s) A-weighted, or dB(A)	The human ear system does not respond uniformly to sound across the detectable frequency range and consequently instrumentation used to measure sound is weighted to represent the performance of the ear. This is known as the 'A weighting' and is written as 'dB(A)'.
Equivalent continuous sound pressure level, or $L_{Aeq,T}$	An index used internationally for the assessment of environmental sound impacts. It is defined as the notional unchanging level that would, over a given period of time (T), deliver the same sound energy as the actual time-varying sound over the same period. Hence fluctuating sound levels can be described in terms of an equivalent single figure value, typically expressed as a decibel level.
Exclusion of data	Measurement of noise levels can be affected by weather conditions such as prolonged periods of rain, wind speeds higher than 5m/s and snow/ice ground cover. Noise levels measured during these periods are considered not representative of normal noise conditions at the site and, for the purposes of this report, are excluded from the assessment of exceedances and calculation of typical noise levels and are also greyed out in charts. Identifiable incongruous noise and vibration events not attributable to HS2 construction noise are also excluded.
Façade	A facade noise level is the noise level 1m in front of a large reflecting surface. The effect of reflection, is to produce a slightly higher (typically +3 dB) sound level than it would be if the reflecting surface was not there.
Free-field	A free-field noise level is the noise level measured at a location where no reflective surfaces, other than the ground, lies within 3.5 metres of the microphone position.
LOAEL	Lowest Observed Adverse Effect Level - the level above which adverse effects on health and quality of life can be detected.
Peak particle velocity, or PPV	Instantaneous maximum velocity reached by a vibrating element as it oscillates about its rest position. The PPV is a simple indicator of perceptibility and risk of damage to structures due to vibration. It is usually measured in mm/s.
SOAEL	Significant Observed Adverse Effect Level - the level above which significant adverse effects on health and quality of life occur.
Sound pressure level	The parameter by which sound levels are measured in air. It is measured in decibels. The threshold of hearing has been set at 0dB, while the threshold of pain is approximately 120dB. Normal speech is approximately 60dB at a distance of 1 metre and a change of 3dB in a time varying sound signal is commonly regarded as being just detectable. A change of 10dB is subjectively twice, or half, as loud.
Vibration dose value, or VDV	An index used to evaluate human exposure to vibration in buildings. While the PPV provides information regarding the magnitude of single vibration events, the VDV provides a measure of the total vibration experienced over a specified period of time (typically 16h daytime and 8h night-time). It takes into account the magnitude, the number and the duration of vibration events and can be used to quantify exposure to continuous, impulsive, occasional and intermittent vibration. The vibration dose value is measured in m/s <sup>1.75</sup> .

# 1 Introduction

1.1.1 HS2 is required to undertake noise (and vibration) monitoring as necessary to comply with the requirements of the High Speed Rail (London-West Midlands) Environmental Minimum Requirements, including specifically Annex 1: Code of Construction Practice, in addition to any monitoring requirements arising from conditions imposed through consents under Section 61 of the Control of Pollution Act, 1974 or through Undertakings & Assurances given to third parties. Such monitoring may be undertaken for the following purposes:

- monitoring the impact of construction works;
- to investigate complaints, incidents and exceedance of trigger levels; or
- monitoring the effectiveness of noise and vibration control measures.

1.1.2 Monitoring data and interpretive reports are to be provided to each relevant local authority on a monthly basis and shall include a summary of the construction activities occurring, the data recorded over the monitoring period, any complaints received, any periods in exceedance of agreed trigger levels, the results of any investigations and any actions taken or mitigation measures implemented. This report provides noise data, and interpretation thereof, for monitoring carried out by HS2 within the London Borough of Ealing (LBE) during the month for the period 1<sup>st</sup> to 31<sup>st</sup> October 2025.

1.1.3 Select monitoring locations in the London Borough of Hammersmith and Fulham (LBFH) and London Borough of Brent (LBB) associated with HS2 sites within LBE are presented in this report.

1.1.4 Active construction sites in the local authority area, where noise and vibration monitoring were conducted during this period, include:

- Mandeville Road Ventilation Shaft worksite, reference MRVS (see plan 1 in Appendix A), where work activities included:
  - Pile trimming.
  - Excavation.
  - Earthworks.
  - Concrete element construction.
  - Installation of steel elements.
  - Basement slab works.
  - Compound operation works.

- Spoil removal including lifting operations.
- Green Park Way Ventilation Shaft worksite, reference GPWVS (see plan 2 in Appendix A), where work activities included:
  - General site operations, including maintenance and road sweeping.
  - Utility works.
  - Maintenance of shaft dewatering system.
  - Tunnel boring machine works including section removal and dismantling.
- Westgate Ventilation Shaft worksite, reference WVS (see plan 3 in Appendix A), where work activities included:
  - General site maintenance.
  - Cladding, including blockwork.
  - Steelwork and brackets installation.
  - Removal of concrete backfill.
  - Construction of secondary lining.
  - Concrete cutting.
  - Site security.
- Atlas Road worksite, ref. AR (see plan 4 in Appendix A), where work activities included:
  - General maintenance works.
  - Tunnel bore machine construction support.
  - Transfer of tunnel boring machine back up, delivery of tunnel segments and conveyor components.
  - Grout jetting.
  - General support tasks.
- Willesden EuroTerminal worksite, ref. WET (see plan 4 in Appendix A), where work activities included:
  - General site maintenance.
  - Spoil removal.
  - Tunnel segments delivery.
  - General support tasks.

- Victoria Road Crossover Box worksite, ref. VRCB (see plan 4 in Appendix A), where work activities included:
  - Support works for tunnelling.
  - Removal of tunnelling infrastructure, including removal of conveyors, pipework and cabling.
  - Operation of craneage, ventilation fans and water treatment plant.
  - Installation of steel elements, including steel decking.
  - Tunnelling works.
  - Secondary lining construction.
  - Tunnel strip out.
  - Concrete invert construction.
  - Tunnel demobilisation.
- Flat Iron compound, worksite ref. FIC (see plan 4 in Appendix A), where work activities included:
  - Support works for tunnelling.
  - Removal of tunnelling infrastructure, including removal of conveyors, pipework and cabling.
  - Operation of craneage, ventilation fans and water treatment plant.
  - Installation of steel elements, including steel decking.
  - Tunnelling works.
  - Secondary lining construction.
  - Tunnel strip out.
  - Concrete invert construction.
  - Tunnel demobilisation.
- Old Oak Common depot worksite, located in the London Borough of Hammersmith and Fulham (LBHF), ref. OOC (see plan 4 in Appendix A), where work activities included:
  - Materials management and haulage.
  - Steel fixing.
  - Formwork, including erection.
  - Falsework.

- Concrete works, including concrete pours.
- Excavation.
- Backfilling.
- Trench boxes fitting.
- Pipes installation.
- Road sweeping.
- Road works including levelling, road surfacing, clearing and excavations.
- Installation of modules.
- Blockwork.
- Piling.
- Store set up.
- Striking.

Further works, where monitoring did not take place, were also undertaken at the following location:

- On network works (south of Wells House Road), where overhead line equipment and civil works were underway.
- Northolt Tunnels East and East Cross Passage, where removal of tunnelling infrastructure, conveyors, pipework, cabling and temporary walkways, segment repair, leak sealing, secondary lining and cross passage construction works were underway.

## 2 Summary of Results

### 2.1 Summary of Measured Noise and Vibration Levels

## 2.2 Exceedances of the SOAEL

2.2.1 The significant observed adverse effect level (SOAEL) is defined in the 'Planning Practice Guidance – Noise' as the level above which "noise causes a material change in behaviour and/or attitude, e.g. avoiding certain activities during periods of intrusion; where there is no alternative ventilation, having to keep windows closed most of the time because of the noise. Potential for sleep disturbance resulting in difficulty in getting to sleep, premature awakening and difficulty in getting back to sleep. Quality of life diminished due to change in acoustic character of the area."

2.2.2 HS2 Phase One Information Paper E23: Control of Construction Noise and Vibration sets out the SOAELs for construction noise.

2.2.3 Where reported construction noise levels exceed the SOAEL, relevant periods will be identified. Summary statistics to evaluate ongoing qualification for noise insulation and temporary rehousing are also presented where relevant.

2.2.4 Table 5 presents a summary of recorded exceedances of the SOAEL at each measurement location over the reporting period, including the number of exceedances during each time period.

2.2.5 There were exceedances of the SOAEL due to HS2 construction works at three (3) monitoring locations during weekday daytime and night periods.

2.2.6 For the purpose of assessing eligibility for noise insulation or temporary rehousing, multiple exceedances of the SOAEL in a 24-hour period would be counted as a single exceedance during that day. Over the reporting period, the overall number of SOAEL exceedances at each measurement location is shown in Table 6 and may be lower than the total sum of individual exceedances reported in Table 5 for each location.
