





Improving the Maintain local land charges service


We have launched several improvements to how local authorities search for and manage local land charges (LLC) when in live service. As a result of recent feedback, the 'Find, update or cancel a charge' function has been redesigned to alleviate common frustrations.


What has changed?

The map page now focuses on navigating to and capturing your search area.

- the viewable map is larger
- we have removed the mapping tool icons from the map itself
- a scrollable section to the left of the map now contains the search options and the mapping tools
- a new 'Confirm area' button completes the streamlined layout.

A dedicated results page will now display all charges within your search area. Using the new set of filters found at the top of the page you can refine results quickly. Each charge listing includes more information than before and a thumbnail of the charge extent. The charge can be viewed in more detail using their reference link.

Additional information

Currently, selecting ‘Back to search results’ when viewing a charge will direct you back to the map page rather than the list of search results. This will be fixed in a forthcoming release.

The old view search page can still be accessed by selecting ‘View all charges on the map’ at the top of the web page.

Bug fixes

— Adding a charge extent by address now works as expected

A local authority's top tips for a successful migration

South Hams District Council and West Devon Borough Council went live on 15 April 2025 after a complex migration. Here are their three top tips to a smoother migration journey.

1 Open communication:

Open and honest communication between the local authority (LA) and HM Land Registry (HMLR) is crucial. Having conversations earlier will provide important transparency to build a realistic project plan to prevent disruption or unnecessary delays at a later stage of the project.

2 Positive morale:

Having a thorough understanding of the project structure before starting and setting expectations of the potential challenges will help maintain an optimistic outset.

3 Connecting with advocates:

Make use of the HMLR advocate programme and engage with other LAs earlier in the project to gain a better understanding of the degrees of implementation. While there is no single 'right way' to approach migration, recognising the phases of the process and preparing accordingly is essential.



The national LLC Register cost savings

Since it launched in 2018, the LLC Register has

- saved customers over **£4 million** for searches made in migrated areas
- saved users an average of **13.18 days** to obtain an LLC search result
- migrated more than **8.3 million charges** from **140 local authorities** to the register.


