Details of the pre-application advice received

Whilst arranging the current HMO Licence for the 6no. occupiers (granted - expires 03/01/2027); the Applicant discussed the possibility of HMO bedrooms within the outbuilding, as part of the existing HMO at No.33 Brockworth Crescent, essentially increasing the capacity by two bedrooms. In terms of HMO Licensing, this was commented that the shared facilities and the potential rooms within the outbuilding would likely be suitable for a HMO of up to 8no. occupants (in terms of floor space, amenity, facilities etc.) as long as the communal facilities within the main house were available to all 8no. occupants.
