1. General notes for users of the SEN2 COLLECT reports

- 1.1. The COLLECT reports show information on the validation rule queries, errors and notes associated with their 2026 SEN2 return. They also provide each local authority with a summary of their key headline statistics, which the Department for Education (DfE) will publish in summer 2026.
- 1.2. Reports can be run from the 'launch reports' option within the SEN2 COLLECT blade.
- 1.3. The reports will be available to the Collector (DfE) and local authority contacts with COLLECT access. The DfE can access the reports for each local authority. Each local authority has access only to their own reports.
- 1.4. The reports show the current position.
- 1.5. All reports are exportable.
- 1.6. The collection year is 1 January 2025 (CollectionYearStart) to 31 December 2025 (CollectionYearEnd).
- 1.7. Census day is 15 January 2026 (CensusDate).
- 1.8. SEN2 2026 reports activity such as EHC assessments and new EHC plans for the collection year and caseload of EHC plans maintained as at census day.
- 1.9. Symbols used in the Data summary report specification:
 - = 'equal to'
 - >= 'greater than or equal to'
 - <= 'less than or equal to'
 - < 'less than'

2.0 New additions and changes in 2026

- A section covering request source, compulsory for the first time in 2026, has been added to the requests report.
- A section covering duplicated UPNs in the named plans table has been added.
- Amendments have been made to the annual reviews report
- Phase transfer reviews have been added to the annual reviews report

2. LA error count report

2.1. Report description

This report provides local authorities with a count of their validation rule errors and queries.

We may be unable to amend any errors that are not identified by our automated and manual validation checks prior to publication.

5. Not in named plan provision

5.1. Report description

This report identifies children and young people where an establishment attended on census day differs from the establishment(s) recorded in the EHC plan. The report should be used to identify any mistakes in the IDs for URN, UKPRN or SEN setting and confirm the local authority is aware of reasons where cases do not match.

This report is not intended to replicate the aggregate collection 'Awaiting provision' measure although it is likely a sub-set of the information will appear in the summer 2023 EHC plan publication.

7. Duplicate record report

7.1. Report description

List of duplicate persons with active EHC plan on census day within the SEN2 return.

Two lists are provided

- where two or more records have the same UPN or ULN
- where any two or more records have a) different UPNs and ULNs, b) have an identical match on both Surname and Forename and c) have the same combination of Date of Birth and Gender
- Where all plans are recorded as active on the census date in each LA. An active plan is defined as one where:
 - <StartDate> is on or before the census date, for 2026 this is 15 January
 - <CeaseDate> is after the census date of 15 January 2026 or is null

These will be shown as two separate lists.

Notes:

Matching of both Surname and Forenames is independent of case, i.e. john and JOHN do match

Testing a Forename is on the basis of whole words only, and part words are not matched. (For example, “Jon”, “Nathan” or “Nat” **are not** matched with “Jonathan”.)

Plans should only be flagged as a duplicate when each record is active, if a plan has a cease date for the named plan in one authority they **should not** be flagged as a duplicate as they are not an active plan.

- <CeaseDate> is after the census date of 15 January 2026 or is null
