On completion of the Flying Display Season (DS), the MAA Display Team (DT) review RA 2335 to ensure it remains fit for purpose. The DT looks at lessons identified during the DS

to adapt the RA to meet future requirements. Additionally, RA 2335 takes account of changes that will be made to CAA CAP 403 and CAP 660 as it is essential these documents remain closely aligned.

The key changes made to Issue 14 of RA 2335 are the introduction of a requirement for all MOD flying display events to use a Public Address System, the requirement to notify the MAA of all Foreign Military Aircraft conducting flypasts at displays and adding the requirement for all Foreign Military Parachute Display Team (PDT) to obtain a CAA Article 90 permission. Clarification has been added regarding the requirement for Military Parachute Display teams to use a Safe Usable Area (SUA) and the introduction of requirement for PDTs to maintain a minimum separation distance of 15 metres from Spectators when landing in the SUA. Further guidance on the management and limitations for parachuting Role Demonstrations has been added.

Other changes include providing new definitions for Display Parachutist and Parachute Display, removing the requirement Military Flying Display Directors to have a mentor and replacing references to Remotely Piloted Air Systems (RPAS) with Uncrewed Air Systems (UAS).

There will be an enhanced safety impact with regard to the use of Public Address Systems and the introduction of a minimum separation distance from spectators for PDT. Some short term impact to Team Managers and DH / ADH as current documentation will require review to ensure compliance; however, this should be minimal as the regulation has been written to take into account the core documentation in use with the Teams, including CAA CAP 403 and CAP 660.
