

FINAL NOTICE OF RELEASE OF REMEDIES

1. Undertakings and orders are the primary means by which the Competition and Markets Authority (**CMA**) implements remedies to resolve any competition concerns it finds following a merger investigation under the Enterprise Act 2002 (the **Act**). Remedies can take different forms such as the prohibition of a merger, the divestiture of a business or behavioural commitments to do or refrain from doing certain things.
2. The CMA has a statutory duty under section 92 of the Act to keep undertakings and orders under review.¹ From time to time, the CMA must consider whether, by reason of any change of circumstances:²
 - (a) undertakings are no longer appropriate and need to be varied, superseded or one or more parties released; or
 - (b) an order is no longer appropriate and needs to be varied or revoked.
3. In 2025, the CMA conducted a strategic review of 37 merger remedies in our portfolio. A strategic review enables the CMA to review and vary, release or revoke remedies efficiently, thereby reducing the regulatory burden on businesses subject to those remedies, and enabling the CMA to focus on monitoring and enforcing those remedies for which there is still a need.
4. On 8 December 2025 we published our Notice of Intention to release these remedies. The consultation ended on 7 January 2026.

NOTICE

5. The CMA discharged its duty under Schedule 10 of the Act by publishing a notice of intention to release such remedies and to consult on that notice for

a minimum of 15 days (in the case of the undertakings) or 30 days (in the case of the one order included within the strategic review).

6. The CMA received no representations objecting to the release of these remedies.
7. In all 37 cases our final decision is that the remedies should be released or revoked for the reasons given in the notice of intention to release.
8. The CMA gives final notice of release or revocation of the merger remedies in all 37 cases under review.
9. The CMA's public register will be updated accordingly.
