IV. Health Information

I, the undersigned, certify that the birds described above meet the following requirements:

- a) *the hatchery is not subject to any official restriction for the control of **highly pathogenic avian influenza** or **Newcastle disease**, and it is not situated in an area subject to such restrictions; OR
*the hatchery is an approved premises in the Great Britain compartment scheme which is free of **highly pathogenic avian influenza** and **Newcastle disease**;
- b) there has been no history or clinical evidence of the following diseases on the premises of origin during the past 12 months:
Newcastle disease (including velogenic, viscerotropic strains), fowl cholera, Salmonella pullorum (pullorum disease), Salmonella gallinarum (fowl typhoid), chicken infectious anaemia, paratyphoid infections (S. typhimurium and S. enteritidis), mycoplasmosis, infectious bronchitis, infectious laryngotracheitis, highly pathogenic avian influenza (fowl plague), egg drop syndrome (adenovirus 127), infectious bursal disease and reoviral arthritis;
- c) the flocks from which the day old chicks originate:
- (i) *are not situated in an area subject to restrictions for the control of **highly pathogenic avian influenza**; OR *are in approved premises in the Great Britain compartment scheme which are free from **highly pathogenic avian influenza**;
- (ii) are not vaccinated for **highly pathogenic avian influenza**;
- (iii) have not shown any clinical signs of **avian influenza** infection during the last 21 days immediately prior to consignment of the day old chicks;

- e) the day old birds have been vaccinated against **Marek's** disease using one full dose of HVT strain vaccine / Rispens strain / a trivalent vaccine having HVT as one component*;
- f) the eggs from which the day old chicks were hatched were incubated in a hatchery which is a member of the government supervised Poultry Health Scheme, either in one batch or together with other eggs of the same zoosanitary health status;
- g) no new birds have been added to the flock(s) of origin within 30 days prior to despatch;
- h) the intended route from the hatchery to the airport of departure will not cross any areas which are subject to official restrictions for the control of **highly pathogenic avian influenza** or **Newcastle disease**.
- j) on (date) being within 24 hours of export, I inspected the day old chicks and found them to be free from clinical signs of infectious or contagious disease, and in my opinion fit for the intended journey.
