RULE 22 JUDGMENT

1. The claim form was sent to the respondent in accordance with rule 16 of the Employment Tribunal Rules 2024. If it was not sent to the respondent's registered address, it was sent to an appropriate address.
2. The respondent did not present a response to the claim. The claimant provided further information by correspondence to the Tribunal, upon which a determination could properly be made of the claims set out below pursuant to rule 22 of the Employment Tribunal Rules 2024.
3. The claim for unauthorised deductions from wages (Employment Rights Act 1996 section 13) is well founded. The respondent must pay to the claimant the following gross sums within 14 days:
 - a. For unpaid wages: £2221.13
 - b. For holiday accrued but untaken and not paid on termination: £3849.98
4. The claim for a redundancy payment (Employment Rights Act 1996 section 135) is well founded. The respondent must pay to the claimant within 14 days a redundancy payment of £17,150, calculated in accordance with Employment Rights Act 1996 section 162.
