PROMOTION AND PROTECTION OF INVESTMENTS DONE AT VILNIUS

Her Britannic Majesty's Embassy in Vilnius presents its compliments to the Ministry of Foreign Affairs of the Republic of Lithuania and has the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Lithuania (together "the Parties") for the Promotion and Protection of Investments done at Vilnius on 17 May 1993 ("the Agreement").

Further to discussions which have taken place between the Embassy and the Ministry, the Embassy has the honour to propose on behalf of the Government of the United Kingdom of Great Britain and Northern Ireland ("the United Kingdom") the following:

1. The Parties agree to expressly terminate the Agreement; and
2. Notwithstanding Article 16 of the Agreement, following the termination of the Agreement, the provisions of the Agreement shall cease to have effect in respect of investments made while the Agreement was in force.

If the aforementioned proposal is acceptable to the Government of the Republic of Lithuania, the Embassy has further the honour to propose that this Note together with the Note of the Republic of Lithuania in reply shall constitute the Agreement between the United Kingdom of Great Britain and Northern Ireland and the Republic of Lithuania on Termination of the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Lithuania for the Promotion and Protection of Investments done at Vilnius on 17 May 1993 ("the Termination Agreement").

Each of the Parties shall notify the other in writing, through diplomatic channels, of the completion of the procedures required by its law for the entry into force of the Termination Agreement. The Termination Agreement shall enter into force 30 days after the date of the later notification.

Her Britannic Majesty's Embassy in Vilnius avails itself of this opportunity to renew to the Ministry of Republic of Lithuania the assurances of its highest consideration.

The Ministry of Foreign Affairs of the Republic of Lithuania presents its compliments to the British Embassy in Vilnius and has the honour to refer to Note No 09 of the United Kingdom, dated 18 May 2021, which reads as follows:

*'As Above'*

In reply, the Ministry of Foreign Affairs of the Republic of Lithuania has the honour to inform the British Embassy that the Government of the Republic of Lithuania accepts the foregoing proposal and confirms that Note No 09 of the United Kingdom of 18 May 2021 and this Note in reply shall constitute the Agreement between the Republic of Lithuania and the United Kingdom of Great Britain and Northern Ireland on Termination of the Agreement between the Government of the Republic of Lithuania and the Government of the United Kingdom of Great Britain and Northern Ireland for the Promotion and Protection of Investments, done at Vilnius on 17 May 1993, which shall enter into force 30 days after the date of the later of the notifications by which each of the Parties has notified the other that it has completed the legal procedures required by its law.

The Ministry of Foreign Affairs of the Republic of Lithuania avails itself of this opportunity to renew to the British Embassy Vilnius the assurances of its highest consideration.
