



## **One Post Available for the Medicines for Women's Health Expert Advisory Group (MWHEAG)**

The Commission on Human Medicines (CHM) is looking to appoint an expert to the Medicines for Women's Health Expert Advisory Group.

The MWHEAG is an Expert Advisory Group of the Commission on Human Medicines which advises the Licensing Authority (Health Ministers) on the safety, quality and efficacy of medicines for human use and to promote the collection and investigation of adverse drug reactions. The Medicines and Healthcare products Regulatory Agency seeks independent advice from the CHM.

The MWHEAG remit covers applications for new medicines and safety issues arising with medicines which are already in clinical use for the following:

- contraception • assisted reproduction • obstetrics and gynaecology • menopause • osteoporosis • endocrinology (for men or women) • safety of use of medicines during pregnancy

As a member of the Committee, you will possess or develop a working knowledge and understanding of the UK medicines regulatory procedures and be able to contribute to recommendations for a range of relevant issues, not just your own area of specialism. You will consider and contribute to the work of the committee by drawing on your own individual expertise and judgement to frame clear advice to CHM.

We are looking for experienced researchers, academics or academic clinicians who can provide neonatal medicine and / or prenatal genetic perspective on studies and reports relevant to medicine use in pregnancy.

### **Expertise Required**

- Neonatologist / Clinical geneticist

### **Essential Criteria**

The Member must be able to demonstrate the qualities, skills and experience to meet all the essential criteria for appointment.

- knowledge and experience of evaluating reports of congenital anomalies for genetic or teratogenic origins
- recognised expertise in their field;
- be skilled communicators;
- be able to assimilate and interpret complex scientific information and formulate evidence-based comments / advice at short notice;
- be able and prepared to contribute actively to wider aspects of the work of the Medicines for Women's Health Expert Advisory Group beyond their own specialism;
- possess or prepared to develop a working knowledge and understanding of the UK medicines regulations framework and procedures;
- maintain strict confidentiality with respect to the work of the EAG;
- be willing to declare conflicts of interest;



- be committed to the values of selflessness, integrity, objectivity, accountability, professionalism, impartiality and consistency.

### **Desirable Criteria**

- Familiarity with congenital anomalies registers
- Be willing to provide specialist input on review of Yellow Card reports of medicine use in pregnancy

Remuneration will be £200 per meeting, for a time commitment of up to 10 meetings per year. The MHRA determines the length of appointment, which will be two years initially with the possibility to extend to four years thereafter.
