Authorized Amendment

On completion of the Flying Display Season (DS), the MAA Display Team (DT) review RA 2335 to ensure it remains fit for purpose. The DT looks at lessons identified during the DS to adapt the RA to meet future requirements. Additionally, RA 2335 takes account of changes that will be made to

CAA CAP 403 and CAP 660 as it is essential these documents remain closely aligned. In addition to making changes to the RA, the display forms associated with RA2335 are also updated. The key changes made to the Issue RA 2335 14 displays forms are:

- a. Paragraph reference numbers in all forms have been updated to reflect the numbering in Issue 14 of RA 2335.
- b. RA 2335 Form 4: Flying Display Director Post Event Feedback Form, added requirement to state if Uncrewed Aerial System Detection Systems was used.
- c. RA 2335 Form 6: Display Parachuting Public Display Authority (PDA) Form, added requirement to notify MAA that CAA Article 90 Permission has been issued.
- d. RA 2335 Form 7: Foreign Military Parachute Display Team Application Form, added requirement to notify MAA that CAA Article 90 Permission has been issued.
- e. RA 2335 Form 9: Parachute Display or Role Demonstration Notification Form, added requirement for MAA to be notified of parachute Role Demonstrations.

There will be an enhanced safety impact regarding the notification of Parachute Role Demonstrations, as the MAA can now track these events. There will be some short-term impact to Team Managers and DH / ADH as current documentation will require review to ensure compliance; however, this should be minimal as the regulations and forms have been written to take into account the core documentation in use with the Teams, including CAA CAP 403 and CAP 660.
