GENERAL TERMS AND CONDITIONS

It is agreed as follows.

1 Definitions

1.1 In this Contract the following terms shall have the meaning set out in the table below:

"Agreement Date"	means the date on which the Contractor accepts these terms and conditions in accordance with Clause 3.2.
"Appendix 1"	means the information at Appendix 1 of this Contract which constitutes the summary of the Department funding, the value of the funding provision for specified periods, and the monthly breakdown value of the detailed funding provision.
"Apprentice"	means any Apprentice to whom the Contractor is required to deliver any of the Services.
"Apprenticeship"	means the training and (where applicable) End-Point Assessment for an employee as part of a job with an accompanying skills development programme.
"Apprenticeship Accountability Framework"	means the framework set out by the Department at Apprenticeship training provider accountability framework - GOV.UK that includes Quality Indicators and Supplementary Indicators to which the Contractor must adhere as updated and amended from time to time.
"Apprenticeship Provider and Assessment Register (APAR)"	means the Apprenticeship Provider and Assessment Register (APAR) which is a record of organisations that are eligible to receive government funding to train Apprentices, and/or can

	undertake End-Point Assessments, or any register which replaces the APAR.
"Apprenticeship Workforce Development Programme"	means the programme for Contractors delivering Apprenticeships to develop the skills, knowledge and ability to deliver such Apprenticeships.
"Background Intellectual Property"	means any Intellectual Property, other than Foreground Intellectual Property, which is used in performing the Services or comprises part of the Work.
"Brokerage"	means the provision by a third party of services, for a fee, to source Subcontractors to provide the Services on behalf of the Contractor.

"Child"	means a person under the age of 18.

"Confidential Information"	means any information, including Personal Data as defined by the Data Protection Legislation, and any information, however it is conveyed, that relates to the business, affairs, developments, trade secrets, know-how, personnel, and suppliers of the Parties including all IPRs, together with all information derived from any of the above, and any other information clearly designated as being confidential or which ought reasonably be considered to be confidential (whether or not it is marked "confidential").
"Contract"	means the Contract between the above named parties consisting of the Terms and Conditions, the Schedules, the

	specification and any other documents (or parts thereof) specified in the Contract and any variations to the Contract agreed in writing and signed by both Parties.
"Contractor Personnel"	means all persons employed or engaged by the Contractor together with the Contractor's servants, agents, consultants and Subcontractors (and all persons employed by any Subcontractor together with the Subcontractor's servants, consultants, agents, Contractor's and Subcontractors) used in the performance of its obligations under this Contract.
"Contractor Related Parties"	means any employee, officer, consultant, agent or any other person whatsoever acting for or on behalf of The Contractor or otherwise under the Contractor's control and direction (including but not limited to Subcontractors).
"Contracts Finder"	means the Government's publishing portal for public sector procurement opportunities.
"Crown Body"	means any department, office or agency of the Crown, including Ofsted, the Care Quality Commission, the Charity Commission, the Office for Students, any and all Local Authority or Combined Authority bodies.

"Data Sub-Processor"	means any third Party appointed to process Personal Data on behalf of that Data Processor related to this Contract.
"Department"	means the Secretary of State for Education acting through the Department for Education.
"Department Data"	<p>means any data (including metadata), record, document or information howsoever stored which is either:</p> <ul style="list-style-type: none"> (a) communicated by the Department, its staff, Subcontractors and agents to the Contractor in writing, orally, electronically or by any other means relating to the Apprentices and/or Services provided to the Apprentices; or (b) is obtained, gleaned, compiled or processed by the Contractor during the course of the Contractor providing the Services relating to or provided to the Apprentices including Personal Data for which the Department is the Data Controller <p>including but not limited to ILR Data, e-portfolios and Apprentice Files.</p>
"Department Policies"	the policies of the Department including but not limited to the Department's policy on Funding Higher Risk Organisations and Subcontractors in force as at the Agreement Date and amended from time to time.
"Disclosure and Barring Service"	means the non-departmental public body established pursuant to the Protection of Freedoms Act 2012.

"Earnings Adjustment Statement"	means <u>Earnings adjustment statement (EAS) - GOV.UK</u> as updated and amended from time to time.
"EIR"	means the Environmental Information Regulations 2004.
"End-Point Assessment"	means the independent assessment of the Apprentice's knowledge, skills and behaviours carried out by an End-Point Assessment Organisation, after the Apprentice has passed their gateway assessment, to confirm that they have met the requirements of any relevant Apprenticeship Standard.
"End-Point Assessment Organisation" or "EPAO"	means any organisation on the Apprenticeship Provider and Assessment Register which is selected by the Contractor, or the Employer (should they wish to retain responsibility) to carry out an End-Point Assessment.
"Evidence Packs" / "Apprentice Records" / "Apprentice Files"	means any information relating to an Apprentice generated by the Contractor, the Apprentice or a third party for the purpose of the delivery of the Apprenticeship.

"Expiry Date"	means 31 March 2026 or such later date as is notified in writing by the Department in accordance with Clause 2.5.
"External Quality Assurance Organisation"	means the relevant organisation undertaking an external quality assurance of End-Point Assessments.
"FOIA"	means the Freedom of Information Act 2000 and all regulations made there from time to time or any superseding or amending enactment and regulations, and words and expressions defined in the FOIA shall have the same meaning in Clause 7 (Freedom of Information and Confidentiality).
"FOIA Notice"	means a decision notice, enforcement notice and/or an information notice.

"Foreground Intellectual Property"	means any Intellectual Property that arises or is obtained or developed by, or on behalf of, the Contractor in respect of the Work in the course of or in connection with the provision of the Services excluding Apprentice Files.

"Funding Period"	means the period set out on page 1 of this Contract.

"Regulatory Body"	means those government departments and regulatory, statutory and other entities, committees, ombudsmen and bodies which, whether under statute, rules, regulations, codes of practice or otherwise, are entitled to regulate or investigate the matters dealt with in this Contract or any other affairs of the Contractor or the Department, including, without limitation Ofsted.
"Restricted Transfer"	a transfer of Personal Data which is undergoing processing or which is intended to be processed after transfer, to a country or territory to which such transfer is prohibited or subject to any requirement to take additional steps to adequately protect the Personal Data processed under this Contract for the transfer to be lawful under the Data Protection Legislation.
"Restricted Share Transfer"	any transfer of shares or ownership in the Contractor or its holding company or in the senior management (including shadow directors) of the Contractor or its holding company to a person who had a significant influence as a director and/or a shareholder over another contractor and in respect of which within the last three years the Department has terminated one or more contract for similar Services as are being delivered under this Contract or the Department would have terminated the Contract had the contractor not pre-emptively terminated the relevant contract.
"Service Commencement Date"	means the date on which the delivery of the Services commences, which shall be 1 January 2018, or such later date as is notified by the Department.

"Services"	means the services to be provided in accordance with the Funding Rules and the Specification.
"Specification"	means the documents setting out the Department's requirements for the Services to be provided under this Contract.
"Subcontract"	means an agreement entered into between the Contractor and a Subcontractor for the purposes of engaging the Subcontractor to deliver part of the Services on behalf of the Contractor.
"Subcontracting"	means the delivery of learning by a separate legal entity to the Contractor, irrespective of whether such learning is provided by a third party recruited to deliver on site (travel to teach), online learning or whether it is described as a service.
"Subcontracting Funding Rules"	means Subcontracting post-16 education and training - GOV.UK
"Subcontracting Threshold"	means 25% of funding received as a lead used in subcontracted activity using the financial information in the Subcontractor Declaration.
"Subcontractor"	means a separate legal entity or an individual (not an employee) that has an agreement (called a Subcontract) with the Contractor to deliver any element of the Services paid for by the Funding. A separate legal entity includes but is not limited to companies in the Contractor's group, other associated companies and sole traders. An individual could include a person who is a sole trader, self-employed, a freelancer or someone who is employed by an agency, unless those individuals are working under the Contractor's direct management and control in the same way as the Contractor's own employees. This does not include relationships between the Contractor and other third parties providing services such as marketing.
"Subcontractor Declaration"	means the declaration that the Department requires a Contractor to complete specifying whether or not the Contractor is Subcontracting any of the Services and, if so, which elements of the Services are subcontracted and the amount of Funding attributed to the same.
"Subcontractor Policies"	means the Department's policies that apply to Subcontracting and Subcontractors as set out at Subcontracting post-16 education and training - GOV.UK

"Successor Contractor"	means the person nominated by the Department to undertake the services substantially the same as the Services after the termination of this Contract.
"Subsidy Control"	means the UK Government's rules on the provision of subsidies.
"Technical Funding Guide"	means the Apprenticeship Technical Funding Guide as revised and amended from time to time and available at Apprenticeship technical funding guide - GOV.UK .
"Termination Date"	means any date on which this Contract terminates in accordance with Clause 24 (Termination).
"UK GDPR"	the General Data Protection Regulation (Regulation (EU) 2016/679) as transposed into United Kingdom national law by operation of section 3 of the European Union (Withdrawal) Act 2018, together with the Data Protection, Privacy and Electronic Communications (Amendments etc.) (EU Exit) Regulations 2019.
"Work"	means all materials created by the Contractor as a result of the provision of the Services including Confidential Information.
"Working Day"	a day (other than a Saturday or Sunday) on which banks are open for domestic business in the City of London.

- 1.2 Unless the context otherwise requires, words in the singular shall include the plural, and in the plural shall include the singular.
- 1.3 Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- 1.4 A reference to a statute or statutory provision is a reference to it as amended, replaced, extended or re-enacted from time to time.
- 1.5 A reference to a person or body includes a reference to its successor.
- 1.6 Any words following the terms including, include, in particular, for example or any similar expression shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.
- 1.7 The headings in this Contract are inserted for convenience only and shall not affect the interpretation or construction of this Contract.
- 1.8 References to "Clauses" and "Schedules" are, unless otherwise provided, references to the clauses and schedules of this Contract and references in any Schedule to paragraphs and appendices are, unless otherwise provided,

references to the paragraphs and appendices of the Schedule in which these references appear.

2 Commencement and Continuation

- 2.1 The Contract will come into force on the Agreement Date.
- 2.2 The delivery of the Services shall commence on the Service Commencement Date.
- 2.3 Between the Agreement Date and the Service Commencement Date, the Department may require the Contractor to undertake Readiness Activities. Failure of the Contractor to undertake any such Readiness Activities shall constitute a breach of contract.
- 2.4 Subject to Clause 2.5 the Contract shall expire on the Expiry Date, or in the event of earlier termination the Termination Date.
- 2.5 The Department may extend the Contract on the following basis;
 - 2.5.1 On any number of occasions up to a maximum period of 12 months in order to ensure continuity of delivery of the Services, in any circumstances in which the Department consider this to be necessary; and/or
 - 2.5.2 For such a period or periods as may be necessary for Apprentices recruited by the Contractor, during the Initial Contract Period, to complete their Apprenticeships;

any extension under Clause 2.5.1 shall have the effect of extending the Initial Contract Period and in each case of an extension under Clause 2.5.1 and/or 2.5.2 a new Expiry Date will be agreed in writing and the definition of Expiry Date shall be updated accordingly.

- 2.6 The Contractor must not recruit any new Apprentices onto any Apprenticeship after 31 March 2021. The Department is not responsible and will not assume responsibility for any Apprentice recruited after 31 March 2021. For the avoidance of doubt, the Apprenticeship Funding in Appendix 1 must not be used to Fund Apprentices recruited after 31 March 2021.

3 Contract Management

- 3.1 The Department and the Contractor shall each nominate a contact for the purpose of dealing with queries and issues under this Contract and advise the other of the contact details.
- 3.2 The Contractor must ensure appropriate members of staff register as users on the user role management system at [DfE Sign-in](#) to enable the Contractor to digitally sign and agree the Contract online. It is the Contractor's responsibility to maintain appropriate user roles on an on-going basis.

3.3 The Contractor will inform the Department if directors, or any other person who has powers of representation, decision or control, meet the characteristics set out in the Funding Higher Risk Organisations and Subcontractors document, [Funding higher risk organisations and subcontractors - GOV.UK](#). Failure to inform the Department will be a material breach of contract.

4 Service Delivery

4.1 The Contractor shall deliver the Services in accordance with the Funding Rules and as set in Appendix 1.

4.2 The detailed requirements in respect of each Apprenticeship are set out in the Funding Rules which for the avoidance of doubt form part of the terms and conditions of this Contract.

4.3 The Services are to be delivered in accordance with the specific requirements of the Department, the Contractor's completed Specification Questionnaire from its tender response and Appendix 1 which sets out the activity and/or scheduled payment profiles for the Services agreed by the Parties, which all form part of the terms and conditions of the Contract.

4.4 The Contractor must complete the Apprentice's qualification on or before the planned end date in the data submitted in the ILR. Where the Contractor misses this date, the Department may consider this a breach of contract.

4.5 The Department will monitor the performance of the Contractor in accordance with the Apprenticeship Accountability Framework. An outline of the Apprenticeship Accountability Framework is set out at Schedule 6 of this Contract.

4.6 The Contractor will comply and will ensure that any Subcontractor complies with the Department Policies.

4.7 The Contractor must ensure that End-Point Assessment Organisation (EPAOs) have sufficient processes in place to carry out all required duties to deliver high quality End-Point Assessments. If the selected EPAO does not have sufficient processes in place it is the Contractors responsibility to source alternative End-Point Assessment provision.

5 Subcontracting

5.1 The Contractor may enter into Subcontracts provided it does so in compliance with Schedule 5 (Subcontracting) of this Contract and the [Apprenticeship funding rules - GOV.UK](#).

5.2 Notwithstanding any arrangements the Contractor has entered into with any Subcontractor, the Contractor shall not be relieved or excused of responsibility or liability under this Contract nor shall performance of its obligations be affected by the appointment of any Subcontractor.

- 5.3 If the Contractor does not Subcontract any of the Services, the Contractor must still provide a nil return via the Subcontractor Declaration to confirm this.
- 5.4 Failure to comply with any of the requirements under Clauses 5.1 to 5.3 may result in the Department taking such actions as it deems appropriate, which may include, but is not limited to, action under Clause 23 (Withholding, Suspension and Repayment of Funding) and/or termination under Clause 24 (Termination).

6 Change of Control and Change in Name

- 6.1 The Contractor represents and warrants to the Department that at the Agreement Date the legal and beneficial ownership of the Contractor is as set out in any tender information or register information supplied by the Contractor and that no arrangements are in place that will result in any sale, transfer or disposal of any legal, beneficial, equitable or other interest in any or all of the shares in the Contractor.
- 6.2 The Contractor will inform the Department in writing if there is a change in its name at least one month prior to the change taking effect unless to do would put the Contractor in breach of the Law. If that is the case the Contractor will inform the Department of the change in its name within 10 Working Days of it becoming lawful to do so.
- 6.3 The Contractor will inform the Department as soon as reasonably practicable and, in any event 12 weeks before any proposed Change of Control of the Contractor unless to do would put the Contractor in breach of the Law. If that is the case the Contractor will inform the Department of the Change of Control of the Contractor within 10 Working Days of it becoming lawful to do so.
- 6.4 For the avoidance of doubt if there is a Change of Control in the Contractor, this will be considered by the Department under Regulation 72 of the Public Contracts Regulations 2015 as it could potentially constitute a contract modification. The Department will, upon receipt of a notification under Clause 6.3 consider if the requested change is permissible under Regulation 72 of the Public Contracts Regulations 2015. The Department may terminate this Contract in accordance with Clause 24.1 (Termination) where the change is not permissible.
- 6.5 The Department may, at any time, request that the Contractor informs it of the details of any Change of Control and the Contractor will comply with such a request as soon as reasonably practicable and in any event within twenty (20) Working Days of receipt of the Department's request.
- 6.6 The Department will consider any Change of Control in the context of all available information including that provided by the Contractor. The Department will consider the criteria set out in the Funding Higher Risk Organisations and Subcontractors document which is published on the Department's website [Funding higher risk organisations and subcontractors - GOV.UK](#).

- 6.7 If the Change of Control or change in name breaches this Contract or any policies and criteria referred to in this Contract then, without prejudice to its other rights under this Contract or otherwise, the Department reserves the right to take action against the Contractor in accordance with Clauses 23 (Withholding, Suspension and Repayment of Funding) and/or termination under Clause 24 (Termination) of this Contract.
- 6.8 If there is a Restricted Share Transfer of the Contractor:
 - 6.8.1 the Contractor will give the Department notice of such Restricted Share Transfer;
 - 6.8.2 the Department reserves the right to take whatever actions it deems necessary; and
 - 6.8.3 the Department may terminate this Contract in accordance with Clause 24.1 (Termination) within three (3) months of the Restricted Share Transfer taking place.

7 Freedom of Information and Confidentiality

7.1 Freedom of Information

- 7.1.1 The Contractor acknowledges and agrees that the Department is subject to legal duties under the FOIA and the EIR, which may require the Department to disclose on request information relating to this Contract or otherwise relating to the Contractor.
- 7.1.2 The Contractor acknowledges and agrees that the Department is required by Law to consider each and every request made under the FOIA and/or the EIR for information.
- 7.1.3 The Contractor acknowledges and agrees that all decisions made by the Department pursuant to a request under the FOIA and/or the EIR are solely a matter for and at the discretion of the Department.
- 7.1.4 Notwithstanding anything in this Contract to the contrary (including without limitation any obligations of confidentiality), the Department shall be entitled to disclose information in whatever form pursuant to a request made under the FOIA and/or the EIR, save that in relation to any information that is Exempt Information the Department shall use reasonable endeavours (but shall not be obliged) to consult the Contractor and shall not:
 - 7.1.4.1 confirm or deny that information is held by the Department;
 - 7.1.4.2 disclose information requested to the extent that in the Department's opinion the information is eligible in the circumstances for an exemption and therefore the Department may lawfully refrain from disclosing such information.

7.1.5 In relation to information relating to the Contractor or the Contract which the Contractor requests should be exempt under the FOIA and/or the EIR, the Contractor shall indemnify the Department for any and all costs (including legal fees) incurred by the Department in:

- 7.1.5.1 assessing the application of any exemption under the FOIA and/or the EIR; and/or
- 7.1.5.2 responding to any FOIA notice; and/or
- 7.1.5.3 lodging any appeal against a decision of the Information Commissioner in relation to disclosure where such costs are incurred pursuant to efforts by the Department to withhold Exempt Information;

7.1.6 The Department shall in no event be liable for any loss, damage, harm or detriment, howsoever caused, arising from or in connection with the disclosure under the FOIA and/or the EIR of any Exempt Information or other information whether relating to this Contract or otherwise relating to the Contractor.

7.1.7 The Contractor shall assist the Department as reasonably necessary to enable the Department to comply with its obligations under the FOIA and/or the EIR.

7.2 Confidentiality

The Contractor hereby warrants and undertakes that:

- 7.2.1 any person employed or engaged by it (in connection with this Contract in the course of such employment or engagement) shall treat all Confidential Information belonging to the Department as confidential, safeguard it accordingly and only use such Confidential Information for the purposes of this Contract; and
- 7.2.2 any person employed or engaged by it (in connection with this Contract in the course of such employment or engagement) shall not disclose any Confidential Information to any third party without prior written consent of the Department, except where disclosure is otherwise expressly permitted by the provisions of this Contract.

7.3 The Contractor shall take all necessary precautions to ensure that all Confidential Information obtained from the Department is treated as confidential and not disclosed (without prior written approval from the Department's Contract Manager) or used other than for the purposes of this Contract by any of its employees, servants, agents or Subcontractors.

7.4 The provisions of Clauses 7.2 and 7.3 shall not apply to any information:

- 7.4.1 which is or becomes public knowledge (other than by breach of Clauses 7.2 and 7.3 or any other duty of confidentiality);

- 7.4.2 which was in the possession of the receiving party, without restriction as to its disclosure, before the date of receipt from the disclosing party;
- 7.4.3 which must be disclosed pursuant to a statutory, legal or parliamentary obligation placed upon the party making the disclosure, including any requirements for disclosure under the FOIA or the EIR.

7.5 Nothing in this Clause 7 shall be deemed or construed to prevent the Department from disclosing any Confidential Information obtained from the Contractor:

- 7.5.1 to any other Crown Body;
- 7.5.2 to Parliament and Parliamentary Committees or if required by any Parliamentary reporting requirement;
- 7.5.3 to any professional adviser, consultant, Contractor or other person engaged by the Department directly in connection with this Contract, provided that such information is treated as confidential by the receiving consultant, Contractor or any other person;
- 7.5.4 on a confidential basis to any proposed successor body in connection with any assignment disposal of its rights, obligations or liabilities under this Contract.

7.6 In order to ensure that no unauthorised person gains access to any Confidential Information or any data obtained in the course of the Services, the Contractor undertakes to maintain adequate security arrangements that meet the requirements of professional standards and best practice.

7.7 The Contractor must immediately notify the Department of any breach of security in relation to Confidential Information and all data obtained in the course of the Services and must keep a record of such breaches. The Contractor must use its best endeavours to recover such Confidential Information or data however it may be recorded. The Contractor must co-operate with the Department in any investigation that the Department considers necessary to undertake as a result of any breach of security in relation to Confidential Information or data.

7.8 The Contractor shall, at its own expense, alter any security systems at any time during the Contract Period at the Department's request if the Department reasonably believes the Contractor has failed to comply with Clause 7.6.

7.9 The Department reserves the right to publish details of this Contract and the payments made under it to comply with the Government's transparency requirements.

7.10 The provisions of this Clause 7 will apply for the duration of the Contract and after its termination.

8 Equality of Opportunity

- 8.1 The Contractor shall not unlawfully discriminate within the meaning and scope of the provisions of the Equality Act 2010 or any statutory modification or re-enactment thereof or any other statutory provision relating to discrimination in employment or the provision of services. The Contractor shall take all reasonable steps to ensure the observance of these provisions by all servants, employees or agents of the Contractor and all Subcontractors employed in the execution of the Contract. The Contractor must comply with the detailed requirements in relation to equality of opportunity set out in Clauses 8.2 to 8.4.
- 8.2 The Contractor will, in delivering the Services under this Contract, demonstrate that it has had regard to the duties placed on the Department and the Contractor by the Equality Act 2010. The Contractor must take all reasonable steps to ensure the observance of these provisions by all servants, employees or agents of the Contractor and all Subcontractors employed to deliver the Services.
- 8.3 The Contractor shall ensure that equality of opportunity is built into all aspects of Services; the business planning process; and the self-assessment process. The Contractor shall use analysis of data to inform future planning to improve the representation, participation and success of underrepresented and underachieving groups and challenge stereotyping. The Contractor shall use appropriate, specific and measurable objectives. These will be proportionate, relevant and aligned to the Services the Contractor is funded to deliver.
- 8.4 The Department may use a variety of equality information and data to support judgements about quality and eligibility for funding. These may include, but are not limited to inspection judgements for equality and diversity, judgements from the Equality and Human Rights Commission, and the success and participation rates of different groups of Apprentices.

9 Apprentice Health, Safety & Welfare

- 9.1 In order to ensure that the Services are provided with a view to safeguarding and promoting the welfare of Apprentices and persons that the Apprentices will come into contact with during the provision of the Services, the Contractor will comply with:
 - 9.1.1 The Safeguarding Vulnerable Groups Act 2006;
 - 9.1.2 The Further Education (Providers of Education) (England) Regulations 2006; and
 - 9.1.3 Part 2 (The Management of Safeguarding) and Part 3 (Safer Recruitment) of [Keeping children safe in education - GOV.UK](#) statutory guidance (as updated from time to time),

(together the "**Apprentice Health, Safety & Welfare Legislation**")

9.2 The Apprentice Health, Safety & Welfare Legislation sets out requirements relating to the safeguarding and welfare of children and vulnerable adults, but not High Needs Apprentices. Accordingly, in complying with Clause 9.1 above:

- 9.2.1 if Services are provided to Apprentices under the age of 18, they are considered as children under the Apprentice Health, Safety & Welfare Legislation;
- 9.2.2 if Services are provided to High Needs Apprentices, the Contractor will construe references to children in the Apprentice Health, Safety & Welfare Legislation as if they were to High Needs Apprentices as defined in this Contract; and
- 9.2.3 if the Contractor provides an Apprentice with Services that comprise a Regulated Activity, the Contractor will comply with the Regulated Activity Provider requirements set out in section 6 of the Safeguarding Vulnerable Groups Act 2006,

whether at the Contractor's Premises or in an environment outside the direct control but under the auspices of the Contractor. This must include the adoption of safer recruitment procedures.

9.3 The Contractor will have regard to any guidance published, from time to time, by the Secretary of State for Education which sets out the expectations in relation to safeguarding practices within further education institutions. References to 'must' in any such guidance will be treated as 'should' for the purposes of this Contract. The Contractor is also required to follow any legal requirements arising from the Safeguarding Vulnerable Groups Act 2006 in respect of referrals to the Disclosure and Barring Service. Failure to do so may constitute a material breach of contract.

9.4 The Contractor must comply with the guidance entitled [Criminal records checks for overseas applicants - GOV.UK](#) in respect of all potential Contractor Personnel from overseas who in connection with the Contractor's provision of the Services will or is likely to be in contact with Apprentices or who will have access to Apprentices information (other than the Department's employees).

9.5 In working with other organisations/bodies, the Contractor shall make arrangements to co-ordinate and co-operate effectively for reasons of safeguarding and Apprentice health, safety and welfare. In particular, respective responsibilities shall be clearly identified and documented as appropriate, to ensure understanding between the relevant parties.

9.6 In providing the Services, the Contractor must ensure it actively promotes the fundamental British values of democracy, the rule of law, individual liberty, and mutual respect and tolerance of those with different faiths and beliefs, and promote principles that support equality of opportunity for all.

9.7 In providing the Services the Contractor must comply with the general duty on specified authorities in section 26 of the Counter-Terrorism and Security Act 2015 (the Prevent duty) and must have regard to statutory guidance issued

under section 29 of the Counter-Terrorism and Security Act 2015. [Prevent duty guidance: England and Wales \(2023\) - GOV.UK](#). Failure to do so may constitute a material breach of contract.

9.8 In providing the Services, the Contractor must comply with the duty on partners of a panel in section 38 of the Counter-Terrorism and Security Act 2015 (the Channel co-operation duty). Failure to do so may constitute a material breach of contract.

9.9 Where the Contractor or one of the Contractor Related Parties:

9.9.1 is aware of an incident, or pattern of incidents, which undermines the promotion of British fundamental values as referred to in Clause 9.6 or the ability of the Contractor or the Contractor Related Parties to comply with the Prevent duty, or

9.9.2 makes a referral of an individual member of Contractor Personnel for the purposes of determining whether that member of Contractor Personnel should be referred to a panel for the carrying out of an assessment under section 36 of the Counter-Terrorism and Security Act 2015 of the extent to which that individual is vulnerable to being drawn into terrorism,

the Contractor will ensure it notifies the Department via the Customer Help Portal: [Home - Customer Help Portal](#) of that incident(s) and/or that a referral has been made.

9.10 When employing or engaging a person to carry out teaching work (as defined in regulation 3 of the Teachers' Disciplinary (England) Regulation 2012), in respect of any Apprentices under the age of 19 and High Needs Apprentices aged up to 25 (as if those Apprentices were pupils for the purposes of the definition of teaching work in regulation 3 of the Teachers' Disciplinary (England) Regulations 2012), the Contractor must comply with Part 3 (Safer Recruitment) of [Keeping children safe in education - GOV.UK](#).

9.11 The Contractor shall, in circumstances where it Subcontracts the management and/or delivery of the services under this Contract, ensure that all the clauses in respect of safeguarding and Apprentice Health, Safety and Welfare under this Clause 9 are included in its contract with Subcontractors.

9.12 The Contractor shall inform the Department of the death of any Apprentice which is a result of work undertaken whilst in employment and who is undertaking a related Learning Programme. This shall be done by informing the Department's representative by telephone or email immediately upon the Contractor becoming aware of the event.

9.13 The Contractor shall report all RIDDOR reportable incidents in line with the Regulations, and shall investigate or assess the circumstances of all Apprentice incidents within the scope of RIDDOR and follow HSE guidance 'Investigating accidents and incidents: A workbook for employers, unions, safety representatives and safety professionals' (HSG245) ISBN 0717628272, the

Contractor shall only use persons competent to investigate/assess Apprentice incidents with a view to identifying the causes of any incident and lessons to be learned.

- 9.14 The Contractor shall also monitor, and act on, any other harm to Apprentices to the extent that the Contractor could reasonably be expected to do so and/or where the harm could affect the quality of the learning experience. Harm includes (but is not limited to) incidents that cause absence from learning, any loss to the Apprentice of any physical or mental faculty or any disfigurement and incidents of bullying and harassment.
- 9.15 The Contractor shall co-operate with the Department and Department for Work and Pensions for the purposes of the Industrial Injuries Disablement Benefit (IIDB) in respect to those Apprentices to which it applies.
- 9.16 The Contractor and/or the Contractor Related Parties must be able to demonstrate that they have robust record-keeping procedures in respect of health, safety and safeguarding through checks on record keeping undertaken. Failure to do so will constitute a material breach of contract.
- 9.17 Where the Contractor or one of its Subcontractors refer:
 - 9.17.1 a safeguarding concern related to sexual violence to Local Authority children's social care/adult social care and/or the police, or
 - 9.17.2 an allegation of abuse made against a teacher or other member of staff to the designated officer(s) (at the local authority),the Contractor must, as soon as practicable, inform the Department via the Customer Help Portal: [Home - Customer Help Portal](#). Such notification must include the name of the institution, a high level summary of the nature of the incident (without sharing personal information about victims or alleged perpetrators) and confirmation of whether it is, or is scheduled to be, investigated by the Local Authority and/or the police.
- 9.18 In so far as permitted by Law, where the Contractor has made a referral or provided information to the Disclosure and Barring Service in compliance with any duties of the Contractor under the Safeguarding Vulnerable Groups Act 2006, the Contractor shall ensure that it informs the Department via the Customer Help Portal: [Home - Customer Help Portal](#) that a referral has been made / information has been provided.
- 9.19 Where it applies:
 - 9.19.1 the Contractor must comply with the Modern Slavery Act 2015 and must have in place throughout the Contract Period policies and procedures to ensure full compliance.
 - 9.19.2 the Contractor must ensure that all Subcontracts that it enters into include an obligation for the Subcontractor to comply with the Modern

Slavery Act 2015 with special emphasis on express anti-slavery and anti-human trafficking provisions.

9.19.3 the Contractor shall implement due diligence procedures to ensure that there is no slavery or human trafficking in any part of its supply chain.

10 Liability

10.1 Neither Party limits its liability for death or personal injury cause by the negligence of itself or any of its servants, employees to agents acting in the course of their employment or in respect of misrepresentations made fraudulently in respect of any breach of an implied terms in respect of title to goods.

10.2 Subject to Clause 10.4 the Contractor shall indemnify and keep indemnified the Department, their servants, employees, and agents against all loss, damage or liability (whether civil or criminal), claims, demands, costs and expenses incurred by or made against the Department, their servants, employees, or agents in respect of any loss or damage or personal injury (including death) which arises out of or in the course of or caused by the negligent act or omission or wilful default of the Contractor, their servants or agents in the delivery of the Service except to the extent (if any) that it was also caused or contributed to by the negligent act or omission or wilful default of the Department or their servants or agents.

10.3 The Contractor warrants to the Department that to the best of its knowledge and belief all works carried out under the Contract will not infringe, in whole or in part, any copyright or any other intellectual property right of any person and agrees to indemnify the Department against any and all claims, demands, proceedings, expenses and losses, including any of a consequential nature, arising directly or indirectly out of any act of the foregoing in relation to any works, where such an act is, or is alleged to be, an infringement of a third party's copyright or other intellectual property right. This warranty and indemnity shall survive the termination of the Contract and shall exist for the life of the copyright or other intellectual property right.

10.4 The Contractor's liability under Clause 10.2 shall be limited as follows.

10.5 In accordance with Clause 10.1 it shall be unlimited;

10.6 Otherwise it shall not exceed twice the value of the Contract or £1,000,000 (one million pounds), whichever is the greater.

10.7 Notwithstanding anything to the contrary contained in the Contract, the Department's liability whether arising from breach of contract tort including negligence breach of statutory duty or otherwise shall be limited as follows;

10.8 In accordance with Clause 10.1 it shall be unlimited;

10.9 In respect of all other liability falling outside of Clause 10.1 arising out of or in connection with its obligations (other than its obligation to pay for the Services) under this Contract and all actions claims demands proceedings costs and expense arising in respect of it to a maximum aggregate value of £100,000 (one hundred thousand pounds). This maximum liability limit shall apply to the whole of the period of the contact term and all claims made within the contract term being the Initial Contract Period and any extension of it in accordance with Clause 2 (Commencement and Continuation), and any and all claims made within that period.

10.10 The Department shall not be liable to the Contractor for any Indirect Losses.

10.11 The Department reserves the right to require the Contractor to secure the provision of an appropriate guarantee (in the form as specified by the Department) in respect of the Contractor's liabilities under this Contract.

11 Insurance

11.1 The Contractor shall maintain at its own cost a policy or policies of insurance to cover the liability of the Contractor in respect of any act or default for which it may become liable to indemnify the Department under this Contract. The Department reserves the right to require the Contractor to insure against any act or default which arises as a result of fraud or other criminal activity by the Contractor, its employees, agents or Subcontractors. The Contractor should provide copies of any insurance certificates to the Department including professional indemnity, employers' liability and public liability insurance following a written request from the Department.

12 Access and Monitoring

12.1 When appropriate the Department shall give the Contractor reasonable advance notice in writing of proposed visits to the Contractor or its Subcontractors, to observe the delivery of the Services, by any person who has taken or will take no direct part in the conduct or content of the Services.

12.2 For monitoring and evaluation purposes, the Department or their representatives, the Secretary of State or their representatives, the National Audit Office, the Inspectorates and HM Treasury shall have the right to visit all or any site(s) and view operations relating to the provision and to inspect relevant documents and interview Apprentices and the Contractor's staff during these visits in order to:

12.2.1 examine, audit or take copies of any original or copy documentation, accounts, books and records of the Contractor and its Subcontractors that relate to the Contract;

12.2.2 visit, view or assess the design, management and delivery relating to the Contract at any Premises where those operations are carried out (including those of Subcontractors) and conduct relevant interviews, including interviews with Apprentices, during these visits at any reasonable time;

- 12.2.3 carry out examinations into the economy, efficiency and effectiveness with which the Contractor has used the Department's resources in the performance of the Contract.
- 12.3 The Contractor shall, if required by any of the representatives stated at Clause 12.2 provide appropriate oral or written explanations.
- 12.4 The Contractor shall promptly notify (or shall procure that its auditors promptly notify) the Department in writing in the event of any of the following circumstances:
 - 12.4.1 any downgrade in the credit rating issued by any rating agency of the Contractor or Subcontractor (and in any event within five (5) Working Days of the occurrence of the downgrade);
 - 12.4.2 any suspected or actual fraud or financial irregularity in accordance with Clause 20.1 (Fraud and Irregularity);
 - 12.4.3 any fact, circumstance or matter which could cause an Insolvency Event of the Contractor or a Subcontractor to arise (and in any event within ten (10) Working Days of the date on which the Contractor first becomes aware of the fact, circumstance or matter which could cause an Insolvency Event to arise); and
 - 12.4.4 the occurrence of an Insolvency Event of the Contractor or a Subcontractor, in which case the Contractor shall immediately notify the Department in writing.
- 12.5 The Department reserves the right, at any reasonable time, and as it may deem necessary to require the Contractor at its own cost to:
 - 12.5.1 provide evidence of financial resources and the level of turnover sufficient to enable it to continue to perform the Contract;
 - 12.5.2 provide such assurance as the Department may require that the delivery of the Services complies with the requirements of the Contract;
 - 12.5.3 obtain a report by an independent accountant of the Department's choice on;
 - 12.5.3.1 the financial systems and controls operated by the Contractor or its Subcontractors;
 - 12.5.3.2 the accuracy and regularity of funding claims in respect of payments claimed or received under the Contract;
 - 12.5.3.3 the evidence held by the Contractor or its Subcontractors to support delivery of the Services in accordance with the terms of the Contract;

12.5.3.4 any issue in connection with the Apprenticeship Accountability Framework.

The Contractor must agree the instructions for the work with the Department and this may include the Department discussing the terms of reference directly with the independent accountant where necessary. The report and the work required in order to produce the report shall be carried out to the satisfaction of the Department, and the Department must be able to place reliance on it. The Contractor shall provide a copy of any draft report at all stages of reporting and the final report to the Department as soon as they are available. The Department reserves the right to require the Contractor to publish the final report.

- 12.5.4 provide a copy of The Contractor's latest audited Accounts and submit further copies of the audited Accounts as they become available;
- 12.5.5 submit any claim for payment or management information provided to support a claim for payment to be audited by an independent auditor chosen by the Department;
- 12.5.6 provide any additional evidence to support payments made under this Contract, as the Department shall reasonably require.
- 12.6 The Contractor shall in performing the Services comply fully with all relevant rules and regulations of the Department in force from time to time especially when on the Department's premises.
- 12.7 In addition to the other requirements to provide information set out in this Contract the Department reserves the right to request information from the Contractor in order to exercise its responsibilities and/or to fulfil requirements to provide information to the Secretary of State and to account to Parliament. On occasion, the Department will require urgent information from the Contractor.
- 12.8 The Contractor shall provide the Department or agents acting on its behalf with the information it requires under Clause 12.7 at the times and in the formats specified by the Department. This information shall be of sufficient quality to meet the purposes for which it has been requested.
- 12.9 Failure to comply with any request for information under Clause 12.7, at all or in the required timescales, will constitute a breach of contract.
- 12.10 Where the Department has undertaken an investigation or received a report from an independent accountant (the cost of which may be recharged to the Contractor) or otherwise, in relation to the Contractor, it may, as a consequence of that investigation or report, impose additional Contract obligations upon the Contractor.
- 12.11 The Department and/or a Crown Body may at any time conduct (whether itself or by its agents, consultants or advisers) audits.

- 12.12 The Parties agree that they will bear their own respective costs and expenses incurred in respect of compliance with their obligations under Clause 12.11, unless the audit identifies a material breach or malpractice by the Contractor and/or a Contractor Related Party in which case the Contractor will reimburse the Department for all the Department's reasonable costs incurred in the course of the audit.
- 12.13 If the findings of an audit conducted pursuant to this Clause 12 results in the requirement for ILR data to be corrected and re-submitted the Contractor will re-submit the data to the Department, as set out in Clause 17 (Submission of Apprentice Data), within two months. Failure to do so will be a breach of contract.
- 12.14 The Contractor must comply with any additional Contract obligations imposed under Clause 12.10.
- 12.15 If the Department assesses that the Contractor has failed to comply with any additional Contract obligations imposed under Clause 12.10 within such time as the Department deems reasonable, the Department may take such actions as it deems appropriate which may include, but is not limited to, terminating the Contract in accordance with Clause 24 (Termination).
- 12.16 The Contractor must act in accordance with any requests made by the Department under the Apprenticeship Accountability Framework.

13 Funding and Payment

- 13.1 Subject to Clause 13.2 and in consideration of the Contractor delivering the Services in accordance with Clause 4 (Service Delivery), the Department agrees to pay the Contractor the amounts set out in Appendix 1 ("the Contractor's Allocation") and such payments are to be made in accordance with the Funding Rules, on condition that the Contractor delivers the Services in accordance with the terms and conditions of the Contract.
- 13.2 Payment will not be made in accordance with Clause 4 (Service Delivery) where the Department has reasonably concluded that the Contractor is at serious risk of failure to deliver the Services following a review of the quality of the Services by the Department.
- 13.3 In the event that the Contractor exceeds its Contractor's Allocation without the prior express authorisation of the Department it does so at its own risk. There is no obligation on the Department to make any payment in excess of the Contractor's Allocation unless this has been specifically authorised by the Department in accordance with Clauses 13.4, 13.6 or otherwise.
- 13.4 The Contractor's Allocation may be varied by the Department in accordance with the Funding Rules. Any such variation may result in a reduction or an increase in the Contractor's Allocation, in accordance with the Funding Rules. Any such variation will take effect only when notified by the Department and Appendix 1 shall be updated accordingly to reflect the variation.

- 13.5 Where the Department identifies that the Contractor is failing to deliver the value of learning of this Contract, it reserves the right in its absolute discretion to reduce the Contractor's Allocation for that Learning Programme.
- 13.6 The Department restricts delivery of the Contract against the Contractor's Allocation up to the Expiry Date as detailed in Appendix 1. Appendix 1 confirms the element of the Contractor's Allocation as available between the following periods:
 - 13.6.1 the Service Commencement Date and 31 March 2018; and
 - 13.6.2 1 April 2018 and 31 July 2018; and
 - 13.6.3 1 August 2018 and 31 March 2019; and
 - 13.6.4 1 April 2019 and 31 March 2020; and
 - 13.6.5 1 April 2020 and 31 March 2021; and
 - 13.6.6 1 April 2021 and 31 March 2022; and
 - 13.6.7 1 April 2022 and 31 March 2023; and
 - 13.6.8 1 April 2023 and 31 March 2024; and
 - 13.6.9 1 April 2024 and 31 March 2025; and
 - 13.6.10 1 April 2025 and the Expiry Date.

Where the Contractor's delivery between the Service Commencement Date and 31 March 2026 fails to meet the minimum levels of performance over that period, or results in the Contractor's Allocation over that period being exceeded then the Department reserves the right, at its absolute discretion, to vary the Contractor's Allocation accordingly.

- 13.7 In accordance with the Technical Funding Guide, the Department will calculate on a monthly basis the payment of Funding due that month to the Contractor.
- 13.8 In delivering the Services to Apprentices starting an Apprenticeship at any time during this Contract the Department reserves the right to give at least 8 weeks' notice in writing of its intention to cease funding for any new Apprentices recruited on an Apprenticeship from the date specified in the notice. The Department will not be liable to make payments in respect of any Apprentices recruited after the date specified in the notice.
- 13.9 The Department reserves the right to give three months' notice to reduce the Contractor's Allocation without the need to give a reason.
- 13.10 Payment by the Department will be without prejudice to any claims or rights, which the Department may have against the Contractor and will not constitute any admission by the Department as to the performance by the Contractor of its obligations under the Contract. Prior to any such payment, the Department

shall be entitled to make deductions or deferments in respect of any disputes or claims whatsoever with or against the Contractor, arising from this Contract or any other Contract between the Contractor and the Department.

- 13.11 Where the Department carries out a review, investigation or audit of a sample of the evidence which the Contractor is required to provide under the Contract to support the payments made by the Department and identifies errors in that evidence which it deems are material, the Department reserves the right at its absolute discretion to require the Contractor at the Contractor's cost to procure an independent 100% audit of all or part of the Services by a deadline specified by the Department and/or to require the Contractor to repay Funding equivalent to the full amount of the Funding that has been wrongly claimed or paid. If only a sample of the Services has been audited, the Department reserves the right to calculate an error rate based on the said sample and claim repayment from the Contractor of an extrapolated amount based on the error rate identified and the total value of the Contract. Such amounts may be recovered by making adjustments to data submitted by the Contractor under the Contract, or by raising an invoice for payment by the Contractor, or making deductions from future payments due to the Contractor under the Contract. Failure to settle such amounts by the Contractor will constitute a breach of contract. The decision of the Department as to the amount of recovery under this clause is final.
- 13.12 Where the Department, in accordance with Clause 13.11, identifies errors it may at its discretion review the Contractor's controls and processes to gain assurance the errors will not occur again. Where further assurance work is required this will be at the Contractor's cost (or the Department will procure and recharge to the Contractor at its sole discretion). Where a full funding audit results in a "qualified" rating this will constitute a breach of contract.
- 13.13 The Department may implement a reduction in funding as set out in the Funding Rules through a notification and not a variation pursuant to Clause 42 (Entire Contract/Amendments).
- 13.14 All payments by the Department will be made via BACS.
- 13.15 The Department is generally unable to recover any Value Added Tax charged. The maximum sum payable under this Contract, as set out in Appendix 1 includes the cost of the service and any other VAT or taxes to be charged, where they apply.
- 13.16 Under the provision of Item 5A to Group 6 of Schedule 9 of the VAT Act 1994, the supply of education or vocational training funded by the Department and the supply by the person providing that education or vocational training, of any goods or services essential to that provision, is considered to be an exempt supply for VAT purposes.

14 Review of Contractual Performance and Reconciliation of Contracts

- 14.1 Where the Contractor's actual delivery, as against the Contractor's Allocation, will result or has already resulted in an overpayment to The Contractor by the Department, the Department will withhold from, or deduct the amount owed

from, payments due to the Contractor under the Contract for current or subsequent months or years accordingly.

- 14.2 Where the Contractor's actual delivery, as against the Contractor's Allocation, has resulted in an underpayment to the Contractor by the Department, the Department will adjust the amount due to the Contractor accordingly. This adjustment shall not exceed the Contractor's Allocation as set out in Appendix 1 of this Contract.
- 14.3 Should there be an under or over payment to the Contractor, the Department will consider the underlying causes for that, in accordance with the Funding Rules and, may at its absolute discretion require a Contract variation to amend the Contractor's Allocation.
- 14.4 The evidence required in respect of each Apprenticeship is set out in the Funding Rules and the Contractor must retain such evidence for inspection on demand.

15 Prohibited Activities

- 15.1 The Contractor shall not offer or give, or agree to give, to any member, employee or representative of the Department any gift or consideration of any kind as an inducement or reward for doing or refraining from doing, or for having done or refrained from doing, any act in relation to the obtaining or execution of this or any other Contract with the Department or for showing or refraining from showing favour or disfavour to any person in relation to this or any such Contract. The Contractor's attention is drawn to the criminal offences created by the Bribery Act 2010. Any offence by the Contractor or its employees or by anyone acting on its behalf under the Bribery Act 2010 in relation to this or any Contract with the Department or His Majesty's Government shall entitle the Department to terminate the Contract and recover from the Contractor the amount of any loss resulting from such termination and/or to recover from the Contractor the amount of value of any gift, consideration or commission.
- 15.2 The Contractor shall not enter into any contract with any political or religious organisation using any Funding provided by the Department under this Contract if the effect of that contract would be to promote a particular political or religious point of view.
- 15.3 The Contractor shall not hold itself out as acting on behalf of the Department.

16 Data Protection and Protection of Personal Data

- 16.1 The Parties acknowledge that for the purposes of the Data Protection Legislation, the Department on behalf of the Secretary of State for Education is the Data Controller and the Contractor is the Data Processor only for the processing set out in Schedule 2 (Processing, Personal Data and Data Subjects) (i.e. submission of Apprentice data to the Department). Any other processing of Personal Data (i.e. Apprentice enrolment or delivering education & training, e.g. e-portfolios) undertaken by the Contractor will be as a data controller and not on behalf of the Department. Clauses 16.2 to 16.14 below

apply only in relation to the processing of Personal Data on behalf of the Department as set out in Schedule 2 (Processing, Personal Data and Data Subjects), and the only processing that the Data Processor is authorised to do on behalf of the Department is listed in Schedule 2 (Processing, Personal Data and Data Subjects) by the Department and may not be determined by the Data Processor.

- 16.2 The Data Processor shall notify the Data Controller immediately if it considers that any of the Data Controller's instructions infringe the Data Protection Legislation.
- 16.3 The Data Processor shall provide all reasonable assistance to the Data Controller in the preparation of any Data Protection Impact Assessment prior to commencing any processing. Such assistance may, at the discretion of the Data Controller, include:
 - 16.3.1 a systematic description of the envisaged processing operations and the purpose of the processing;
 - 16.3.2 an assessment of the necessity and proportionality of the processing operations in relation to the Services;
 - 16.3.3 an assessment of the risks to the rights and freedoms of Data Subjects; and
 - 16.3.4 the measures envisaged to address the risks, including safeguards, security measures and mechanisms to ensure the protection of Personal Data.
- 16.4 If requested by the Department's nominated contact, the Data Processor shall, in relation to any Personal Data processed in connection with its obligations under this Contract:
 - 16.4.1 process that Personal Data only in accordance with Schedule 2 (Processing, Personal Data and Data Subjects), unless the Data Processor is required to do otherwise by Law. If it is so required the Data Processor shall promptly notify the Data Controller before processing the Personal Data unless prohibited by Law;
 - 16.4.2 ensure that it has in place Protective Measures, which are appropriate to protect against a Data Loss Event, which the Data Controller may reasonably reject (but failure to reject shall not amount to approval by the Data Controller of the adequacy of the Protective Measures), having taken account of the:
 - 16.4.2.1 nature of the data to be protected;
 - 16.4.2.2 harm that might result from a Data Loss Event;
 - 16.4.2.3 state of technological development; and

16.4.2.4 cost of implementing any measures;

16.4.3 ensure that:

- 16.4.3.1 the Data Processor Personnel do not process Personal Data except in accordance with this Contract (and in particular Schedule 2 (Processing, Personal Data and Data Subjects));
- 16.4.3.2 it takes all reasonable steps to ensure the reliability and integrity of any Data Processor Personnel who have access to the Personal Data and ensure that they:
 - (A) are aware of and comply with the Data Processor's duties under this clause;
 - (B) are subject to appropriate confidentiality undertakings with the Data Processor or any Data Sub-Processor;
 - (C) are informed of the confidential nature of the Personal Data and do not publish, disclose or divulge any of the Personal Data to any third Party unless directed in writing to do so by the Data Controller or as otherwise permitted by this Contract; and
 - (D) have undergone adequate training in the use, care, protection and handling of Personal Data; and

16.4.4 not make a Restricted Transfer unless the prior written consent of the Data Controller has been obtained and the following conditions are fulfilled:

- 16.4.4.1 the destination country has been recognised as adequate by the UK government in accordance with Article 45 UK GDPR or section 74 of the DPA 2018;
- 16.4.4.2 the Data Controller or the Data Processor has provided appropriate safeguards in relation to the transfer (whether in accordance with UK GDPR Article 46 or section 75 of the DPA 2018) as determined by the Data Controller;
- 16.4.4.3 the Data Subject has enforceable rights and effective legal remedies;
- 16.4.4.4 the Data Processor complies with its obligations under the Data Protection Legislation by providing an adequate level of protection to any Personal Data that is transferred (or, if it is not so bound, uses its best endeavours to assist the Data Controller in meeting its obligations); and

- 16.4.4.5 the Data Processor complies with any reasonable instructions notified to it in advance by the Data Controller with respect to the processing of the Personal Data;
- 16.4.5 at the written direction of the Data Controller, delete or return Personal Data (and any copies of it) to the Data Controller on termination of the Contract unless the Data Processor is required by Law to retain the Personal Data.

16.5 Subject to Clause 16.6, the Data Processor shall notify the Controller immediately if it:

- 16.5.1 receives a Data Subject Access Request (or purported Data Subject Access Request) in relation to the processing of their data under this Contract only (submission of ILR Data);
- 16.5.2 receives a request to rectify, block or erase any Personal Data processed through the submission of ILR Data. Notification in such cases should be given via the nominated contact;
- 16.5.3 receives any other request, complaint or communication relating to either Party's obligations under the Data Protection Legislation;
- 16.5.4 receives any communication from the Information Commissioner or any other regulatory authority in connection with Personal Data processed under this Contract;
- 16.5.5 receives a request from any third Party for disclosure of Personal Data where compliance with such request is required or purported to be required by Law; or
- 16.5.6 becomes aware of a Data Loss Event.

16.6 The Data Processor's obligation to notify under Clause 16.5 shall include the provision of further information to the Data Controller in phases, as details become available.

16.7 Taking into account the nature of the processing, the Data Processor shall provide the Data Controller with full assistance in relation to either Party's obligations under Data Protection Legislation and any complaint, communication or request made under Clause 16.5 (and insofar as possible within the timescales reasonably required by the Data Controller) including by promptly providing:

- 16.7.1 the Data Controller with full details and copies of the complaint, communication or request;
- 16.7.2 such assistance as is reasonably requested by the Data Controller to enable the Data Controller to comply with a Data Subject Access Request within the relevant timescales set out in the Data Protection Legislation;

- 16.7.3 the Data Controller, at its request, with any Personal Data it holds in relation to a Data Subject;
- 16.7.4 assistance as requested by the Data Controller following any Data Loss Event;
- 16.7.5 assistance as requested by the Data Controller with respect to any request from the Information Commissioner's Office, or any consultation by the Data Controller with the Information Commissioner's Office.

16.8 The Data Processor shall maintain complete and accurate records and information to demonstrate its compliance with this clause. This requirement does not apply where the Data Processor employs fewer than 250 staff, unless:

- 16.8.1 the Data Controller determines that the processing is not occasional;
- 16.8.2 the Data Controller determines the processing includes special categories of data as referred to in Article 9(1) of the UK GDPR or Personal Data relating to criminal convictions and offences referred to in Article 10 of the UK GDPR; or
- 16.8.3 the Data Controller determines that the processing is likely to result in a risk to the rights and freedoms of Data Subjects.

16.9 The Data Processor shall allow for audits of its Data Processing activity by the Data Controller or the Data Controller's designated auditor.

16.10 Each Party shall designate its own Data Protection Officer if required by the Data Protection Legislation.

16.11 Before allowing any Data Sub-Processor to process any Personal Data related to this Contract (submission of ILR Data), the Data Processor must:

- 16.11.1 notify the Data Controller's nominated contact in writing of the intended Data Sub-Processor and processing;
- 16.11.2 obtain the written consent of the Data Controller's nominated contact;
- 16.11.3 enter into a written agreement with the Data Sub-Processor which give effect to the terms set out in this Clause 16 such that they apply to the Data Sub-Processor; and
- 16.11.4 provide the Data Controller with such information regarding the Data Sub-Processor as the Data Controller may reasonably require.

16.12 The Data Processor shall remain fully liable for all acts or omissions of any of its Data Sub-Processors.

16.13 The Data Controller may, at any time on not less than 30 Working Days' notice, revise this clause by replacing it with any applicable Data Controller to Data Processor standard clauses or similar terms forming part of an applicable

certification scheme (which shall apply when incorporated by attachment to this Contract).

- 16.14 The Parties agree to take account of any guidance issued by the Information Commissioner's Office. The Data Controller may on not less than 30 Working Days' notice to the Data Processor amend this Contract to ensure that it complies with any guidance issued by the Information Commissioner's Office.
- 16.15 Where the Contractor is providing the Services to Apprentices who are subject to claiming Industrial Injuries Disablement Benefit (IIDB), the Department for Work and Pensions (or their successor) is the data controller in relation to Personal Data, which the Contractor is required to provide to the Secretary of State for Education. This Clause 16 will be enforceable by the Secretary of State for Work and Pensions in relation to any Personal Data processed by the Contractor on its behalf.
- 16.16 The Data Processor will comply with any further written instructions or additional conditions from the Department's Data Controller in relation to the data processing.
- 16.17 In the circumstances set out in Clause 25.13, the Department may elect to take the role of Data Controller.

17 Submission of Apprentice Data

- 17.1 Where required, the Contractor must supply the Department data on each individual Apprentice, in accordance with the 'Data Collections Timetable' set out in the 'Appendices, validation rules and schema' as amended and updated, and in accordance with the 'Provider Support Manual' as amended and updated, which are published on the Department's website [Individualised Learner Record \(ILR\) technical documents, guidance and requirements](#).
- 17.2 The Contractor must supply the Department with data in accordance with the following:
 - 17.2.1 in line with agreed audit arrangements;
 - 17.2.2 in adherence with the Data Protection Legislation;
 - 17.2.3 to support payments to be made;
 - 17.2.4 to enable reconciliation to take place;
 - 17.2.5 to support the contract management and allocation processes; and
 - 17.2.6 any written request from the Department.
- 17.3 The Contractor will report new Apprentice starts within 2 months of the Apprentice starting, or within 3 months of the Apprentice finishing for all withdrawals and achievements. The Contractor will report all changes by the final collection of the Funding Year. Failure to report withdrawals by this time will result in the recovery of the Funding.

17.4 Data collected must be transmitted to the Department through the Department's web portal [Submit learner data](#). Access to the Department's web portal is restricted and the Contractor agrees to comply with the conditions of use regarding the supply of data to the Department set out in this Clause 17 and in the 'ILR Specification' and the 'Provider Support Manual' as amended and updated from time to time, via [Individualised Learner Record \(ILR\) technical documents, guidance and requirements](#).

17.5 Where the Department is concerned about the quality of the data, including the completeness or accuracy of the data, provided by the Contractor, the Department may require the Contractor to supply data more frequently for such a period as the Department shall require, and the Department may audit, or instruct a third party to audit, at the Contractor's cost, the Contractor's data and controls to gain assurance that the quality improvements have been made.

17.6 The Department reserves the right to require the Contractor, at its own cost, to carry out such work as the Department deems necessary to improve the quality of data.

17.7 Without prejudice to any other provision of this Clause 17 the Department reserves the right to suspend payments to the Contractor under the Contract where data quality gives rise to concern about the accuracy of the data provided by the Contractor and take action under the Apprenticeship Accountability Framework.

17.8 Failure to transmit complete and accurate data to the Department in accordance with this Clause 17 will constitute a breach of contract.

17.9 Where the Contractor is providing the Services to Apprentices claiming state benefits, it must provide data to the Secretary of State with responsibility for unemployment or their nominated representative in accordance with the requirements notified to the Contractor. Failure to transmit complete and accurate data under this Clause 17 will constitute a breach of contract and may result in payments for this part of the Services being suspended and/or withdrawn in accordance with Clause 23 (Withholding, Suspension and Repayment of Funding) and/or termination under Clause 24 (Termination).

17.10 The Contractor must update the course information with details of all of the Services they offer which are funded by the Department within their [Apprenticeship Service Training Provider Account](#) unless the Contractor is an Employer-Provider. The Contractor must regularly review this information and keep it updated. For the avoidance of doubt an Employer-Provider is not required to update or review the course information.

17.11 The Contractor shall register with UKRLP ([UK Register of Learning Providers](#)) and Get Information About Schools where appropriate ([Get Information about Schools - GOV.UK](#)) and maintain contact details on an on-going basis.

17.12 The Contractor must submit data about any member of its Contractor Personnel in the format and to the timescales as required by the Department.

17.13 The Department will monitor and review the data submitted under this Clause 17 (Submission of Apprentice Data) of this Contract to ensure that payments are made in accordance with the requirements set out in [Financial assurance: monitoring post-16 funding - GOV.UK](#).

17.14 The Department will publish monitoring reports on [View your education data](#). The Contractor must access the monitoring reports every month and amend any errors for the next submission by taking the actions specified in the report user guide. Failure to amend the data as required will constitute a breach of contract in accordance with Clause 23 (Withholding, Suspension and Repayment of Funding) of the Contract.

17.15 If served with notice of a breach, the Contractor must correct data or supply the Department with evidence within the period specified in the notice. This evidence can include digital copies of documents such as Apprentice files, commitment statements or employer declarations. Annotated spreadsheets or notes are not acceptable as evidence.

17.16 Where data is incorrect in the final data submission of the academic year the Department will recover the payments associated with the incorrect data.

17.17 Without prejudice to the Department's rights under Clauses 23 (Withholding, Suspension and Repayment of Funding) and 24 (Termination) and to any other express rights under this Contract, where the Contractor has been found to be fraudulent or have recklessly submitted erroneous reports, claims and/or Apprentice data (including Evidence Packs), or the Department reasonably believes such reports to be fraudulent or erroneous the Department may, by notice to the Contractor, increase the level of its monitoring of the Contractor, or (at the Department's option) require the Contractor to increase the level of the Contractor's monitoring of its own performance of its obligations under this Contract in respect of the relevant Services which are the subject of such fraudulent, erroneous or misleading reporting until such time as the Contractor will have demonstrated to the reasonable satisfaction of the Department that it will perform (and is capable of performing) its obligations under this Contract and, in which case, the following provisions will apply:

17.17.1 any such notice to the Contractor will specify in reasonable detail the additional measures to be taken by the Department or by the Contractor (as the case may be) in monitoring the performance of the Contractor;

17.17.2 if the Contractor (acting reasonably) objects to any of the specified measures on the grounds that they are excessive it will notify the Department in writing within five (5) Working Days of the receipt of the notice of the measures objected to (and of any Changes necessary in order to prevent prejudice to the Contractor's performance of its obligations under this Contract);

17.17.3 the measures to be taken by the Department and the Contractor (as the case may be) will be agreed between the Parties or, in the absence of agreement within ten (10) Working Days of the Department's receipt

of the Contractor's objection, determined pursuant to Clause 35 (Dispute Resolution); and

- 17.17.4 the Contractor will bear its own costs and indemnify and keep the Department indemnified at all times from and against all costs and expenses reasonably and properly incurred by or on behalf of the Department in relation to such increased level of monitoring.

18 Quality Assurance and Raising Standards

- 18.1 The Contractor warrants and undertakes to the Department that it and any Contractor Related Party has and will continue to have the resources and skills necessary to carry out the Contractor's obligations pursuant to this Contract.
- 18.2 The Contractor shall comply with the Funding Rules published by the Department as amended from time to time and any other requirements, which may from time to time be issued by the Department, Ofsted, the awarding organisations and other Regulatory Bodies and of which the Contractor is made aware.
- 18.3 The Contractor shall ensure that all activities carried out pursuant to this Contract shall be documented in accordance with the requirements of the Department and shall provide such documentation to them as the Department shall request from time to time.
- 18.4 The Contractor shall continuously seek to improve the Services and raise standards to benefit the Apprentice. The Contractor shall have the primary responsibility for improving standards and will need to demonstrate to The Department satisfaction that it has an effective quality assurance system based on the implementation of its own quality improvement process. The Department reserves the right to require the Contractor to provide the Department or Ofsted with evidence to support the quality improvement processes.
- 18.5 The Contractor shall use all reasonable endeavours to:
 - 18.5.1 minimise dropout rates and deliver high completion and achievement rates and appropriate progression;
 - 18.5.2 meet the minimum quality standards published by the Department and/or the Department that apply to the appropriate Services purchased;
 - 18.5.3 ensure competent and appropriately qualified staff deliver and assess learning. The Contractor shall be responsible for the continuing professional development and training of its staff;
 - 18.5.4 offer equality of access to learning opportunities and close equality gaps in learning and outcomes;
 - 18.5.5 provide a safe, healthy and supportive environment, which meets the needs of Apprentices;

- 18.5.6 provide good management and leadership of the learning process;
- 18.5.7 deliver value for money and financial probity; and
- 18.5.8 ensure all Subcontractors delivering Services under the Contract on behalf of the Contractor comply with the requirements set out in Clauses 18.5.1 to 18.5.7 above.

18.6 The Contractor shall continuously seek to improve the Provision and raise standards to benefit the Apprentice. The Contractor shall have the primary responsibility for improving standards and will need to demonstrate to the Department satisfaction that it has an effective quality assurance system based on the implementation of its own quality improvement process. The Department reserves the right to require the Contractor to provide the Department or an Inspectorate evidence to support the quality improvement processes.

18.7 The Contractor must take all reasonable steps to meet the relevant requirements for data gathering for the Learner and employer satisfaction data in line with the Department's requirements that are in place at the relevant time. Contractors should note that the Department is currently considering the most useful information to collect from Learners. Information will be updated when it becomes available at [Learner and employer satisfaction surveys - GOV.UK](#) and in any subsequent updates to these web pages.

18.8 Where appropriate, the Contractor shall confirm in writing to the Department that their Centre Approval Status is still current. The written statement will need to confirm approved centre status for the specific Regulated Qualification Framework ("RQF") titles and levels, including awarding body name(s).

18.9 The Contractor must notify the Department immediately in writing via the Customer Help Portal: [Home - Customer Help Portal](#) if it receives any sanction from an awarding body including but not limited to the suspension and/or removal of Centre Approval Status and/or the removal of the ability to register or certificate Apprentices.

18.10 The Department may assess the quality and delivery of the Services and the Contractor's compliance with the requirements in Clauses 18.5.1 to 18.5.8 during the term of the Contract. The Contractor will be informed of the outcome of that process. Where the Department assesses the Contractor to be in breach of contract following such assessment the Department will issue a notice which may:

- 18.10.1 require the Contractor to meet improvement indicators to improve the quality of its Services. The Department will meet with the Contractor to discuss and reach agreement on implementation of these actions and improvement indicators and to agree arrangements for monitoring and reviewing progress. In such cases reviews will take place at the frequency specified by the Department and in agreement with the Contractor; and/or

- 18.10.2 agree detailed improvement plans and measures that set out clearly the expected timescale for improvement; and/or
- 18.10.3 agree arrangements for more frequent monitoring of quality improvement plans.

Financial Health

- 18.11 The Department will undertake an assessment of the Contractor's financial health and control ([DfE financial health assessment - GOV.UK](#)). The Department will require the Contractor to use and comply with all processes and systems used by the Department for gathering financial information. Should the Department, at its absolute discretion, consider:
 - 18.11.1 that the Contractor's ability to comply with its obligations under this Contract is or may be declining and/or has become or may become inadequate; and/or
 - 18.11.2 that the outcome of any financial health and/or control assessment in relation to the Contractor indicates that the Contractor's financial health is or may be declining and/or is or may be inadequate,then the Department may, in its absolute discretion, take one or more of the following actions:
 - 18.11.3 require the Contractor to, and the Contractor shall, accept and comply with additional Contract obligations relating to the improvement of financial health and/or control arrangements; and/or
 - 18.11.4 require the Contractor to suspend the recruitment of Apprentices to the Services and/or cap any growth in Apprentice numbers; and/or
 - 18.11.5 give consideration to what changes, if any, are required in its allocations when finalising the amount of funding in any subsequent contract between the parties; and/or
 - 18.11.6 engage directly with Apprentices and/or Employers to ascertain the Contractor's performance of its obligations under this Contract; and/or
 - 18.11.7 serve notice to the Contractor that the Department is transferring all or some of the learning and/or, where applicable, End-Point Assessments provided by the Contractor to another contractor nominated by the Department, and require the Contractor to comply with its obligations set out in Clause 25 (Transfer of Responsibility on Notice, Expiry or Termination) to effect an orderly transition of the Services from the Contractor to the Department and/or any Successor Contractor; and/or
 - 18.11.8 terminate this Contract in accordance with Clause 24.1 (Termination) if:

- 18.11.8.1 the Contractor fails to comply with requirements imposed under Clauses 18.11.3, 18.11.4, 18.11.7; and/or
- 18.11.8.2 the Contractor fails to respond to any of the Department's communications regarding the Contractor's financial health; and/or
- 18.11.8.3 the Contractor fails to cooperate with the Department with regard to any of the matters contained in this Clause 18 (Quality Assurance and Raising Standards); and/or

18.11.9 terminate the Contract in accordance with Clause 24.1 (Termination).

18.12 Failure to submit accounts for assessment when requested will automatically deem the assessment under Clause 18.11 as 'inadequate' and Clauses 18.11.3 to 18.11.9 will apply.

18.13 Where the outcome of a financial assessment illustrates a deterioration from the previous assessment the Department may in its absolute discretion (and without prejudice to its rights under Clause 18.11) request such further assurance or information from the Contractor as it deems necessary.

18.14 The Contractor must notify the Department immediately if it, or any Contractor Related Party, is experiencing or forecasting any financial difficulties and the Department may ask for additional financial information to obtain assurance of continuity of delivery of the Services.

18.15 The Department may require the Contractor to procure an independent business review of the Contractor's financial health at the Contractor's cost (or the Department may procure such a review and recharge the costs to the Contractor, at its sole discretion) if the Department has concerns over the financial health of the Contractor.

18.16 The Department can at any time require the Contractor at its own cost to provide a copy of the Contractor's latest accounts, any historic accounts as requested, and submit further copies of the accounts as soon as they become available and to provide, upon request:

- 18.16.1 the Contractor's up to date management accounts, including financial performance against delivery;
- 18.16.2 financial forecasts of the Contractor's financial position for the next 12 months;
- 18.16.3 cash flow forecasts for the next 12 months;
- 18.16.4 any additional financial information the Department deems necessary.

18.17 Where the further information required from the Contractor under Clauses 18.13, 18.14, 18.15 and 18.16 does not provide adequate assurance

to the Department then the Department may in its absolute discretion take one or more of the actions set out in Clauses 18.11.3 to 18.11.9.

- 18.18 The Department reserves the right to request that the Contractor provide a guarantee or other form of security on terms that will be notified to the Contractor.
- 18.19 In addition to the other requirements to provide information set out in this Contract, the Department reserves the right to request information from the Contractor in order to exercise its responsibilities and/or to fulfil requirements to provide information to the Secretary of State and to account to Parliament. On occasion, the Department will require urgent information from the Contractor.
- 18.20 The Contractor will provide the Department or agents acting on its behalf with the information it requires under Clause 18.19 at the times and in the formats specified. This information will be of sufficient quality to meet the purposes for which it has been requested.

Ofsted Inspections relating to the provision of Services

- 18.21 Ofsted may, at any time during the term, undertake an inspection of the Contractor. When the Contractor receives notification from Ofsted that the Services are to be inspected, the Contractor shall inform the Department of the same and, on request, provide the Department with details of its quality improvement activity, and any other relevant information in accordance with the required timescale of Ofsted. The Contractor must promptly notify the Department of the date of the meeting at which Ofsted will give feedback on the inspection and allow the Department's nominated representative to attend the meeting. The Contractor must confirm to the Department in writing the outcome of the inspection within 5 Working Days of receiving the feedback from Ofsted.

Ofsted-Related Interventions

- 18.22 Clause 18.24 below sets out the circumstances in which various rights and actions are available to the Department following an Ofsted inspection. This Clause 18.22 sets out those rights and actions which comprise the Department's rights to:

- 18.22.1 terminate this Contract in accordance with Clause 24.1 (Termination) and/or;
- 18.22.2 remove the Contractor from the Apprenticeship Provider and Assessment Register; and/or
- 18.22.3 suspend the payment of Funding to the Contractor for a specified period; and/or
- 18.22.4 require the Contractor to suspend the recruitment of Apprentices to, and/or cap any growth in, the Services which are assessed as Urgent Improvement or Safeguarding Not Met;

- 18.22.5 reduce and/or recover from the Contractor Funding paid by the Department; and/or
- 18.22.6 require the Contractor to accept and comply with additional Contract obligations relating to the improvement of the Services; and/or
- 18.22.7 give consideration to the Ofsted Evaluation Areas which have been assessed as Urgent Improvement or Not Met when considering access to Funding in relation to any subsequent contracts between the Parties; and/or
- 18.22.8 require the Contractor to inform all of its existing employers, main providers and employer-providers, as applicable, about the outcome of the Ofsted visit and Ofsted assessment; and/or
- 18.22.9 require the Contractor to enter into a Subcontracting arrangement with another training provider or employer-provider in order to ensure that there is minimal disruption to the training delivered to the Contractor's current Apprentices.

Exercising the Ofsted-Related Interventions

- 18.23 Where the Department has the right to exercise any one or more of the Ofsted-Related Interventions, the Department shall take into account the factors set out in Clause 18.24 and may discuss options with the Contractor and other relevant co-funding Regulatory Bodies where appropriate.
- 18.24 In the event of any of the following, the Department may, in its absolute discretion, exercise any one or more of the Ofsted-Related Interventions:

18.25 Where the Department is made aware that Ofsted has assessed a Subcontractor to the Contractor as having made 'insufficient progress' during an Ofsted Monitoring Inspection, the Contractor shall suspend the delivery of

the Services under the Subcontract and shall not Subcontract any further Services to the Subcontractor until permitted to do so by the Department.

- 18.26 The failure of the Contractor, as assessed by the Department, to comply with any decision of the Department to exercise its rights under Clause 18.22.4 (requirement to suspend the recruitment of Apprentices to, and/or cap any growth in, the Services) within such time as the Department may deem reasonable may lead to the Department taking such actions as it deems appropriate which may include, but is not limited to, terminating this Contract in accordance with Clause 24.1 (Termination).
- 18.27 The failure of the Contractor, as assessed by the Department, to comply with any decision of the Department to exercise its rights under Clause 18.22.6 (requirement to accept and comply with additional Contract obligations relating to the improvement of the Services) within such time as the Department may deem reasonable may lead to the Department taking such actions as it deems appropriate which may include, but is not limited to, terminating this Contract in accordance with Clause 24.1 (Termination).
- 18.28 The Department will take action based on Ofsted's published outcomes as set out in Clause 18.24. Where the Department is made aware that the Contractor has made a complaint about the graded outcome of the overall assessment by Ofsted, the Department will continue to consider what action it needs to take under this Contract but will be mindful of the implications arising from the outcome of a complaint. The Department will review any decisions made at such time as outcomes of any complaint are made known.

Apprenticeship Provider and Assessment Register (APAR) Registration

- 18.29 Upon being invited to do so by the Department by way of a written notice the Contractor should apply for registration on the Apprenticeship Provider and Assessment Register. In the event that the Contractor does not make an application for registration or is unsuccessful in their application for such registration the Department will usually, in accordance with its published policy [Apply to the APAR as an apprenticeship training provider - GOV.UK](#) remove the Contractor from the Apprenticeship Provider and Assessment Register and terminate this Contract by written notice to the Contractor pursuant to Clause 24.1. Where the Department considers that there are exceptional circumstances and the Contractor is actively delivering Apprenticeships, the Department may decide to prohibit the Contractor from starting any new Apprenticeships as an alternative to termination and this Contract shall be deemed to have been varied accordingly to remove the right for the Contractor to start any new Apprenticeships until the Department lifts the prohibition in accordance with Clause 18.32 or this Contract comes to an end (either through termination or expiry) whichever is the earlier. Exceptional circumstances include, but are not limited to:
 - 18.29.1 the proximity for the planned end dates for existing Apprenticeships being such that moving the affected Apprentices to alternative provision would cause significant disadvantage to them;

- 18.29.2 the size or complexity of the Contractor's Apprenticeship programme would require additional time (in excess of three months) to transfer the existing Apprentices to other providers;
- 18.29.3 a suitable alternative provider is not available due to the niche nature of the provision or the delivery location.

18.30 Where the Department decides to prohibit the start of any new Apprenticeships, pursuant to Clause 18.29 as an alternative to termination it shall give written notice of its decision to the Contractor accordingly and shall set out in the written notice the date from which the prohibition shall take effect. Subject to Clause 18.32 the prohibition shall take effect until the date of expiry or earlier termination of this Contract in accordance with Clause 24 (Termination).

18.31 In the event that the Contractor fails to comply with a notice served by the Department pursuant to Clause 18.29 requiring registration on the Apprenticeship Provider and Assessment Register the Department may terminate this Contract in accordance with Clause 24 (Termination).

18.32 Subsequent to the service of a notice pursuant to Clause 18.29, and where the Contract has not been terminated pursuant to Clause 24 (Termination) and where the Contractor makes a successful application and is registered on the Apprenticeship Provider and Assessment Register the Department may, upon further written notice to the Contractor, lift the suspension on the Contractor starting new Apprenticeships and the Contractor may recommence delivery from the date specified in any such further notice.

19 Information for Apprentices

- 19.1 As part of the delivery of the Services, the Contractor must provide high quality and easily accessible information and advice to help Apprentices to understand the opportunities and support available to them about education, training or connected matters (including employment);
 - 19.1.1 where one of the main objectives of the Services to be provided under this Contract is to deliver information and advice, the Contractor will have to have or attain the matrix Standard accreditation within six months of the Contract being awarded; and
 - 19.1.2 if the information and advice is embedded as part of the delivery of the Services the Contractor must work towards achieving the matrix Standard accreditation within 12 months of the start of the Contract.
- 19.2 Where the Services are delivered by a Subcontractor on behalf of the Contractor, the requirements set out in Clauses 19.1.1 and 19.1.2 must be applied to the Subcontractor. This does not apply where the Contractor retains responsibility for the delivery of information and advice to the Apprentices.
- 19.3 Once achieved, matrix Standard accreditation is valid for three years. The Contractor must continue to demonstrate their continuous improvement via annual continuous improvement checks with the matrix Standard assessor.

20 Fraud and Irregularity

20.1 The Contractor must immediately notify the Department in writing where the Contractor becomes aware of any instance of suspected fraud or financial irregularity in the delivery of the Contract including, but not limited to, cases of:

- 20.1.1 collusion with members of staff of the Department or employees of the Department;
- 20.1.2 computer fraud;
- 20.1.3 the submission to the Department of inaccurate, incomplete, misleading or falsified information for the purpose of a claim for Funding;
- 20.1.4 fraud involving awarding organisations;
- 20.1.5 fraud involving Subcontractors; and
- 20.1.6 any reported financial irregularities, ILR Data errors and/or funding errors that have been identified either internally or externally by a third party through internal/external audit or other reviews;

provided that nothing in this Clause 20 shall require the Contractor to do anything, which may cause it to infringe any Law.

20.2 Where the Department has reasonable cause to suspect that fraud or irregularity has occurred in relation to the delivery of the Contract and payments made hereunder, the Department shall have:

- 20.2.1 right of access to the Contractor's premises (or that of any of its Subcontractors) at any reasonable time with or without notice to examine and remove or copy all relevant documents and records including electronic records;
- 20.2.2 the right to require the Contractor to provide written authority to enable the Department to obtain such documents, records and/or information directly from third parties; and
- 20.2.3 the right to interview the Contractor's servants or agents engaged with the delivery of the Contract.

20.3 Failure to comply with Clause 20.2 will constitute a breach of contract.

20.4 Where the Department has reasonable cause to suspect that fraud or irregularity has occurred in relation to the delivery of the Contract and payments made hereunder, the Department may require the Contractor to procure the services of an independent accountant or equivalent professional to investigate at the Contractor's cost (or the Department will procure such an independent accountant and recharge the costs to the Contractor at its sole discretion).

20.5 Where the Department has reasonable cause to suspect that fraud or irregularity has occurred in relation to:

- 20.5.1 the delivery of this Contract; or
- 20.5.2 the delivery of any other contract between the Department and the Contractor; or
- 20.5.3 the payments made under this Contract or any other contract between the Department and the Contractor;

the Department shall have the right to suspend payments and/or require the Contractor to suspend recruitment of Apprentices under this Contract and any other contract between the Parties.

20.6 The Parties shall co-operate in the identification of Apprentices who may be unlawfully claiming benefits. The Department may from time to time brief the Contractor as to the co-operation and assistance it reasonably requires including the provision of information regarding fraud by Apprentices. The Department shall provide a named contact or telephone answering machine for receiving such information.

21 Additional Contractual Obligations

21.1 The Department reserves the right to impose additional contractual obligations where it considers it is necessary to do so to secure the delivery of education and training and/or End-Point Assessments of a reasonable quality by the Contractor, or to ensure that the resources provided by the Department are being used effectively and efficiently or to require the Contractor to address concerns about its financial viability or to ensure that the Contractor complies with requests made by the Department under the Apprenticeship Accountability Framework.

22 NOT USED

23 Withholding, Suspension and Repayment of Funding

23.1 Without prejudice to the Department's other rights and remedies, under this Contract or otherwise, the Department may at its discretion withhold, suspend or recover payment of Funding if one or more of the following applies:

- 23.1.1 the Contractor materially breaches any of the terms or conditions of this Contract;
- 23.1.2 the Department, acting reasonably, has concerns:
 - 23.1.2.1 about the standard of Services that the Contractor and/or a Subcontractor is delivering or has delivered including in respect of one or more standard or framework; and/or

- 23.1.2.2 that the quality of leadership at the Contractor is such that one or more Apprentice has no reasonable prospect of achieving their training objective; and/or
- 23.1.2.3 that Apprentices may be at risk on safeguarding grounds;
- 23.1.3 an Awarding Organisation or an External Quality Assurance Organisation is taking remedial and/or enforcement action against the Contractor and/or a Subcontractor;
- 23.1.4 the Department has reasonable grounds to suspect fraud, financial irregularity, dishonesty, negligence or malpractice by any of the Contractor and/or one or more Contractor Related Party;
- 23.1.5 the Department has concerns about the completeness, accuracy or promptness of the data submitted by the Contractor on the ILR in relation to this Contract or, subject to Clause 23.5, any other agreement;
- 23.1.6 any employee of the Contractor or any other Contractor Related Party has acted or failed to act in a way which, as a result, in the reasonable opinion of the Department, brings or is likely to bring the Department's name, brand or reputation or the Apprenticeships brand into disrepute;
- 23.1.7 the Contractor was not entitled to Funding under the Funding Rules in relation to one or more Apprenticeship;
- 23.1.8 there occurs, in respect of the Contractor, any Insolvency Event or Change of Control which, in the reasonable opinion of the Department, may affect the Contractor's ability to comply with its obligations under this Contract; and/or
- 23.1.9 the Contractor fails to comply with any of the provisions set out in this Contract (including the provisions in the Funding Rules and/or any requirements under the Apprenticeship Accountability Framework) and fails to rectify any such failure within 30 days of receiving written notice from the Department (or such other timescale specified in the notice) detailing the failure and requiring it to rectify the failure.

23.2 The Department is entitled to withhold or suspend payment of Funding under any other provisions in this Contract.

23.3 Without prejudice to or limiting the provisions of Clause 23.1.1, where more than one breach (which are not material breaches) have occurred, those breaches (taken together) may be regarded as a material breach.

23.4 Rights to withhold, suspend and/or require repayment of the Funding are set out in other provisions in this Contract and in the Funding Rules (as amended from time to time).

23.5 If under Clause 23.1.5 some or all of the Department's concerns about the completeness, accuracy or promptness of data relate to data submitted under an agreement other than this Contract, then such concerns are relevant to the extent that they undermine the Department's confidence in the Contractor's ability to comply with its obligations to submit complete or accurate or prompt data in relation to this Contract.

23.6 The right to suspend Funding in accordance with Clause 23.1 includes the right to:

- 23.6.1 suspend the payment of Funding to the Contractor in part and/or for a specified period in relation to current Apprenticeships; and/or
- 23.6.2 not consider any applications or pay any Funding for new Apprenticeships for a specified period.

23.7 Where the Department suspends Funding in accordance with the terms of this Contract, it shall notify the Contractor in writing of the suspension and its duration as well as the intervals at which the suspension will be reviewed for the Department to determine whether the suspension should be withdrawn or extended.

23.8 The Department reserves the right to recover from the Contractor any Funding paid to a Contractor where the payment of Funding or any arrangement between the employer of Apprentices under an Apprenticeship and the Contractor breaches the Funding Rules or the entitlement to Funding was based on wrong, inaccurate or misleading information.

24 Termination

24.1 The Department may terminate this Contract, in full or in part, without liability to the Contractor by giving to the Contractor, or where relevant their representatives, written notice, having effect immediately or after such notice period as the Department may determine on one or more of the following grounds:

- 24.1.1 the occurrence of an Insolvency Event of the Contractor;
- 24.1.2 if the Contractor fails to comply with any of the requirements agreed with the Contractor under Clauses 18.10.1, 18.10.2 and/or 18.10.3 (Quality Assurance and Raising Standards);
- 24.1.3 if Regulation 73(1)(b) of The Public Contracts Regulations 2015 applies to the Contractor;
- 24.1.4 where the Department is entitled to exercise the right to terminate this Contract as set out in Clauses 6.4, 6.7 and 6.8 (Change of Control);
- 24.1.5 within three (3) months of a Restricted Share Transfer in accordance with Clause 6.8.3.

- 24.1.6 where the Contractor is an individual, if they shall die or are adjudged incapable of managing their affairs within the meaning of Part VII of the Mental Health Act 1983;
- 24.1.7 the Contractor commits material breach of any of its obligations under this Contract which is incapable of remedy;
- 24.1.8 the Contractor commits material breach of any of its obligations under this Contract which is capable of remedy and fails to remedy it or persists in such breach after 10 Working Days of having been required in writing to remedy or desist;
- 24.1.9 if the Contractor ceases to be on the Apprenticeship Provider and Assessment Register;
- 24.1.10 the Contractor or any of its employees shall have committed any offence under the Bribery Act 2010;
- 24.1.11 in accordance with section 78 and/or section 79 (where applicable) of the Procurement Act 2023;
- 24.1.12 where it is entitled to exercise the right to terminate this Contract as set out in Clause 18.11 (Financial Health);
- 24.1.13 where it is entitled to exercise the right to terminate this Contract as set out in Clause 13.12 (if the Contractor receives a "qualified" rating in two consecutive full funding audits);
- 24.1.14 where it is entitled to exercise the right to terminate this Contract in accordance with Clause 18.24 (Ofsted-Related Interventions);
- 24.1.15 where it is entitled to exercise the right to terminate this Contract as set out in Clause 18.26 (failure to suspend the recruitment of Apprentices and/or cap any growth in the Services);
- 24.1.16 where it is entitled to exercise the right to terminate this Contract as set out in Clause 18.27 applies (failure to accept and comply with additional Contract obligations relating to the improvement of the Services);
- 24.1.17 the Department assesses that the Services delivered under this Contract, in whole or part, are below any performance expectations set out in the Apprenticeship Accountability Framework;
- 24.1.18 where it is entitled to exercise the right to terminate this Contract as set out in Paragraph 5.2.13 of Schedule 6 (Apprenticeship Accountability Framework);
- 24.1.19 the OfS has assessed the Contractor as having "not met" one or more of the conditions;

- 24.1.20 where it is entitled to exercise the right to terminate this Contract as set out in Clause 5.4 (Subcontracting);
- 24.1.21 if any of the circumstances set out in Clauses 23.1.1 to 23.1.9 (Withholding, Suspension and Repayment of Funding) occur which amount to a material breach of this Contract.

24.2 In addition to the rights of termination under any other clauses of this Contract, the Department shall be entitled to terminate this Contract in respect of all or part of the Services provided under the Contract by giving to the Contractor not less than three months' written notice to that effect.

24.3 If the Department considers in its absolute discretion that on receipt of a notice pursuant to Clause 6 (Change of Control and Change in Name) that the proposed change in name and/or proposed or actual Change of Control would prejudice the Contractor's ability to deliver the Services, the Department shall be entitled to terminate this Contract in accordance with Clause 24.7.

24.4 This Contract will be voidable where, following an evaluation of the last three (3) years' data submissions relating to any other contract with the Department, the Department concludes that the Contractor was in material breach of that contract or contracts and if the Department had known at the time of awarding and/or entering into this Contract that the Contractor had committed a material breach, it would not have awarded and/or entered into this Contract.

24.5 If the circumstances set out in Clause 24.4 arise and the Contract is declared void, the parties will be deemed to have subsequently entered into a new legally binding agreement that includes the provisions set out in the table at Clause 41 (Continuing Obligations).

24.6 If the Department terminates another contract with the Contractor on fault grounds where a similar right of termination also exists in this Contract in relation to similar provisions, the Department, acting reasonably, may immediately give notice of termination of this Contract in writing to the Contractor.

24.7 Where the Department terminates the Contract under any of Clauses 24.1 to 24.3 it shall do so by serving a written notice on the Contractor specifying the Termination Date.

24.8 Termination under Clause 24 shall not prejudice or affect any right of action or remedy, which shall have accrued or shall thereupon accrue to the Parties under this Contract.

24.9 Where the Contractor goes into administration or liquidation, the Department must be assumed to be a creditor of the Contractor. The Contractor must take steps to ensure that the Department is provided with details of the administrator or liquidator and receives notification of any creditors meetings. The Department will confirm whether in fact it is a creditor within 8 weeks of being notified that the Contractor is in administration or liquidation.

24.10 The Contractor shall upon termination of the Contract immediately deliver up to the Department all correspondence, documents, specification papers and other property belonging to the Department, which may be in its possession or under its control.

24.11 Notice of Termination of this Contract under Clauses 18 (Quality Assurance and Raising Standards), 23 (Withholding, Suspension and Repayment of Funding) or this Clause 24 (Termination) shall result in the Contractor being removed from the Apprenticeship Provider and Assessment Register maintained by the Department.

24.12 For the avoidance of doubt, after notice of termination and/or an Insolvency Event affecting the Contractor, the Contractor must not share any information about Apprentices, including but not limited to Department Data, with another contractor unless the Department provides written authorisation for the Contractor to do so. In addition, the Contractor shall not recruit Apprentices from another contractor that has been issued with a notice of termination and/or in relation to whom an Insolvency Event has occurred, without the permission of the Department.

24.13 The Contractor must not recruit new Apprentices including Apprentices that have transferred from another Contractor after notice of termination of the Contract has been given. The Department will not be liable to make payments in respect of any Apprentices recruited in breach of this clause.

25 Transfer of Responsibility on Notice, Expiry or Termination

25.1 The Parties agree that if upon termination of this Contract or any part of the Service being provided under the Contract, circumstances arise in which the Transfer of Undertakings (Protection of Employment) Regulations 2006 are applicable, the Parties shall in good faith co-operate with each other in the disclosure of information and the provision of other assistance and comply with the provisions of Paragraph 1 in Schedule 1 of this Contract so as to facilitate such outcome in relation to the relevant employees as may be acceptable to the Parties.

25.2 On termination (in whole or in part) or expiry of this Contract for any reason, the Contractor shall do its utmost to minimise disruption caused to Apprentices and to assist the implementation of any contingency plan proposed by the Department either prior to or after the termination or expiry of this Contract, to deal with the effects of such termination or expiry. The Contractor is required to ensure it performs its obligations to assist in the orderly transition of the Services from the Contractor to the Department and/or any Successor Contractor in the event of termination (including partial termination) or expiry of this Contract. This will include the transition of the Services to a follow-on contract with the same Contractor if applicable. In so far as it is practicable to do so the Department will not be liable for any costs incurred by the Contractor in complying with this Clause 25.2.

25.3 On expiry or termination of this Contract for any reason, the Contractor shall do its utmost to minimise any disruption to Apprentices and shall co-operate fully

with any reasonable requests made by the Department relating to this. For the avoidance of doubt the Department will be entitled to request that where the Contractor cannot complete Apprentices that it will co-operate in transferring the Apprentices to a new provider even if this is prior to the termination or expiry of this Contract. The Department will not be liable for any costs prior to or after the Termination Date or Expiry Date incurred by the Contractor in complying with this Clause 25.3.

25.4 Three (3) months prior to the Expiry Date of this Contract (or where this Contract is terminated within the timescale notified by the Department, the Contractor will upon request:

- 25.4.1 provide for transfer to the Department and/or the Successor Contractor of all knowledge reasonably required for the provision of the Services which may, as appropriate, include information, records and documents including that relating to configuration of software; and
- 25.4.2 provide the Department and/or Successor Contractor with reasonable access to such members of the Contractor's or its Subcontractors' personnel as have been involved in the development, provision or management of the Services and who are still employed or engaged by the Contractor or its Subcontractors.

25.5 On termination or expiry of this Contract for any reason the Evidence Packs will become the property of the Department. The Contractor shall allow the Department their servants or agent to have access to its premises to remove Evidence Packs or otherwise comply with a request by the Department to transfer Evidence Packs to any third party nominated by the Department.

25.6 The Contractor shall, at no cost to the Department, promptly provide such assistance and comply with such timetable as the Department may reasonably require for the purpose of ensuring an orderly transfer of responsibility for provision of the Services (or its equivalent) upon receipt of notice or the expiry or other termination of this Contract. The Contractor shall use all reasonable endeavours to ensure that its employees and its Subcontractors are under a similar obligation. The Department shall be entitled to require the provision of such assistance both prior to and after the expiry or other termination of this Contract.

25.7 The Contractor will:

- 25.7.1 with respect to learning or training in progress, document the current status and stabilising for continuity during transition;
- 25.7.2 provide assistance and expertise as necessary to examine all governance and reports in place for the provision of the Services;
- 25.7.3 answer all reasonable questions from the Department and/or its Successor Contractor regarding the Services;

25.7.4 agree with the Department and/or the Successor Contractor a plan for the migration of the Department Data to the Department and/or the Successor Contractor. The Contractor will fully co-operate in the execution of the agreed plan, providing skills.

25.8 Such assistance may include, (without limitation) delivery of documents and data in the possession or control of the Contractor or its Subcontractors, which relate to performance, monitoring, management and reporting of the Programme, including the documents and data, if any, referred to in the Schedules.

25.9 The Contractor undertakes that it shall not knowingly do or omit to do anything which may adversely affect the ability of the Department to ensure an orderly transfer of responsibility for provision of the Services, performance of its role in relation to End-Point Assessments and/or, where applicable, the delivery of End-Point Assessments.

25.10 If the Contractor does not co-operate with the Department in relation to exit in accordance with this Clause 25 and the Department incurs additional expenditure of any description as a result, the Department reserves the right to require the Contractor to reimburse the Department for this additional expenditure.

25.11 The termination or expiry of this Contract shall be without prejudice to rights of either Party accrued prior to the Termination Date or Expiry Date and shall not affect the continuing rights of the Parties under any provision of the Contract that either expressly or by implication has effect after the Termination Date or the Expiry Date.

25.12 The Department reserves the right to retain Funding that would otherwise be paid to the Contractor prior to the Termination Date, and/or to demand repayment of Funding as relevant, in order to reconcile what has already been paid to the Contractor under Appendix 1 with the amount the Contractor is entitled to under this Contract (including the Funding Rules).

25.13 Where the Contract is terminated or expires, the Department may elect to take the role of Data Controller to secure and protect Apprentice Files, Apprentice Records and/or Evidence Packs, including e-portfolios until the Apprentice information can be transferred to a new Contractor, the Apprentice, or destroyed in accordance with defined retention periods. If the Department elects to assume this role, the Contractor shall co-operate fully to facilitate this.

26 Force Majeure

26.1 Neither party shall be liable for any delay or failure to meet its obligations under this Contract due to any cause outside its reasonable control, including (without limitation), inclement weather, Acts of God, war, riot, malicious acts of damage, civil commotion, strike, lockout, industrial dispute, refusal of licence, power failure or fire. If performance of the service is substantially prevented for a continuous period of 6 months by virtue of any of the aforesaid events, then either party may terminate this Contract by written notice to the other.

27 Public Reputations of the Parties/Press Releases

- 27.1 Both Parties recognise their respective public reputations and legal responsibilities. Each Party shall use all reasonable endeavours not to harm or compromise these.
- 27.2 The text of any press release or other communication to be published by or in the media concerning the subject matter of this Contract shall require the approval of each Party which shall not be unreasonably withheld or delayed.
- 27.3 In addition to the other requirements to provide information set out in this Contract, the Department reserves the right to request information from the Contractor in order to exercise its responsibilities and/or to fulfil requirements to provide information to the Secretary of State and to account to Parliament. On occasion, the Department will require urgent information from the Contractor.
- 27.4 The Contractor shall provide the Department or agents acting on its behalf with the information it requires under Clause 27.3 at the times and in the formats specified. This information shall be of sufficient quality to meet the purposes for which it has been requested.
- 27.5 Failure to comply with any request for information under Clause 27.3, at all or in the required timescales, will constitute a breach of contract.

28 Retention of Documents

- 28.1 The Contractor and its Subcontractors shall maintain original invoices; management information returns and all other documents necessary to verify the Services in relation to this Contract for 6 years from the end of the financial year in which the last payment is made.
- 28.2 Confirmation of the document destroy date will be notified in writing by the Department.
- 28.3 The provisions of this Clause 28 shall apply during the continuance of this Contract and after its termination howsoever arising.

29 Variation

- 29.1 This Contract shall not be varied or amended unless such variation or amendment has been issued by the Department in writing.

30 Status of Contract

- 30.1 Nothing in this Contract shall have the effect of making the Contractor, the servant or agent of the Department, the Contractor (if an individual) represents that they are regarded by both the Inland Revenue and the Department for Work and Pensions as self-employed and accordingly shall indemnify the Department against tax, national insurance contributions or similar imposed for which the

Department may be liable in respect of the Contractor by reason of this Contract.

31 Waiver

31.1 No failure or delay on the part of any Party hereto to exercise any right or remedy under this Contract shall be construed or operate as a waiver thereof nor shall any single or partial exercise of any right or remedy as the case may be. The rights and remedies provided in this Contract are cumulative and are not exclusive of any rights or remedies provided by Law.

32 Third Party Rights

32.1 Save as specifically provided in the Contract none of the terms of this Contract are intended to be enforceable by any Apprentices or other third party.

33 Notice

33.1 Any notice or other document to be given under this Contract must be in writing and personally delivered, e-mailed, sent through the Department's electronic portal or sent by first class post to the address of the relevant party, as referred to above or in the case of an email address or correspondence address, as notified by the relevant party in writing from time to time. The notice or communication will be considered delivered as follows:

- 33.1.1 if personally delivered, when handed over to the addressee;
- 33.1.2 if sent by email or through the Department's electronic portal, on the day the email is sent if sent on a Working Day and before 5.00 pm, otherwise the email will be deemed delivered at 9.00 am on the next Working Day;
- 33.1.3 if sent by first class post, on the second Working Day after the day on which it is posted.

33.2 All such notices and documents must be in the English language. To prove the giving of a notice or other document it will be sufficient to show that it was despatched.

34 Governing / Jurisdiction

34.1 This Contract shall be governed by and construed in accordance with English Law.

35 Dispute Resolution

35.1 Any dispute, difference or question arising between the Parties either during the currency of this Contract or afterwards shall be referred to the nominated contacts for the Department and the Contractor for discussion and review in order to try to resolve the same.

- 35.2 In the event of the nominated contacts being unable to resolve the relevant issue, either party may request in writing that the matter is referred to the Department's nominated representative and the Contractor's representative nominated for this purpose (jointly "the Dispute Resolution Panel") for formal review and consideration. Any request for referral to the Dispute Resolution Panel must include details of the dispute and any proposals to resolve it.
- 35.3 The Dispute Resolution Panel will meet within 28 days of receiving a request for referral made in accordance with Clause 35.2 above.
- 35.4 For the avoidance of doubt, the Department shall not be obliged to follow the Dispute Resolution Procedure in circumstances where it wishes to terminate this Contract under Clause 24 (Termination).

36 Feedback and Complaints

- 36.1 The Contractor shall have a policy and process in place, which is acceptable to the Department and available to the Department on request, to gather and act upon Apprentice feedback, including feedback from Apprentices who did not complete their Apprenticeship, to improve the experience of Apprentices in general while they are on the Contractor's programmes, and to support more general improvements. The Contractor must ensure that Apprentices are aware of the process and the Contractor shall use Apprentice feedback to ensure training programmes meet Apprentices' needs. The Contractor must arrange for and operate a plan to deliver continuous improvement in relation to the training and should include aggregated Apprentice feedback to inform that plan.
- 36.2 The primary responsibility for investigating complaints promptly and thoroughly in respect of the Services shall rest with the Contractor. The Contractor shall have procedures in place, which are acceptable to the Department to act upon complaints from Apprentices and/or their representatives and employers and the wider community. The Contractor must ensure that Apprentices are made aware of its procedure for dealing with complaints and that the procedure is clear and accessible to Apprentices who wish to complain.
- 36.3 The Contractor shall be responsible for resolving complaints in accordance with its own procedures and any guidance issued by the Department.
- 36.4 Where a complaint has not been resolved to the satisfaction of the complainant the Contractor must advise the complainant of their right to complain to the Department and co-operate with any investigation carried out by the Department and act on any recommendations made by the Department following the investigation.
- 36.5 The Contractor will ensure that it has in place and complies with an effective whistleblowing procedure, approved by the body responsible for the management of the Contractor, whereby staff may raise in confidence concerns about possible malpractice without fear of victimisation, subsequent discrimination or disadvantage. The procedure must be published on the Contractor's public-facing website. The Contractor will regularly review the

procedure, including securing approval from the body responsible for the management of the Contractor of any amended procedure.

37 Subsidy Control

- 37.1 The Contractor should obtain its own advice as to whether the Subsidy Control Rules apply to the Funding received in relation to the Services delivered under this Contract. Guidance on this can be found at [Complying with the UK's international obligations on subsidy control: guidance for public authorities - GOV.UK](#).
- 37.2 Where the rules on Subsidy Control apply, the Contractor must:
 - 37.2.1 comply with the relevant notification requirements; and
 - 37.2.2 collect and retain appropriate records and will supply those records to the Department on its request.
- 37.3 The Department reserves the right to require the Contractor to obtain a contribution towards the cost of the Services delivered under this Contract from the employer of any Apprentice. Where a contribution is required, the Department will confirm to the Contractor in writing the exact percentage of the contribution.
- 37.4 Where the Department requires the Contractor to obtain a contribution towards the cost of the Services under Clause 37.3 above, the Contractor must provide evidence that the contribution has been received.
- 37.5 If a recovery order or any other enforcement measure is taken under the Subsidy Control Act 2022, the Contractor will repay the relevant subsidy to the Department within 28 days or such other timescale that the Department agrees with the Contractor.

38 Intellectual Property Rights

- 38.1 In consideration of the Department making the payments to the Contractor in connection with the Services the Contractor hereby grants (and, where relevant, shall procure from any necessary third parties the grant) to the Department a non-exclusive, irrevocable, worldwide, royalty-free licence (with the right to license others) of any of the Contractor's Foreground Intellectual Property that the Department may reasonably require to be able fully to exploit, develop and commercialise the results of the Services, including, without limitation, the Work.
- 38.2 The provisions of this Clause 38 shall apply during the continuance of this Contract and after its termination howsoever arising.

39 Disposal of Assets and Change of Use

- 39.1 In respect of Assets whose value exceeds £2,500 including VAT the following provisions shall apply.

39.2 For the purposes of this section:

- 39.2.1 'Asset' shall mean any property, real or personal, tangible or intangible;
- 39.2.2 an Asset shall be considered to have been financed by the Department if it has been acquired wholly or partly with funds provided by the Department;
- 39.2.3 the use of any Asset shall be considered to have changed if the Contractor uses it for any purpose other than for the provision or connected with the provision of Services under the Contract;
- 39.2.4 'the appropriate proportion thereof' shall be the proportion represented by the amount of Funding provided by the Department to acquire, develop or improve an asset in relation to the entire price paid for its acquisition, or its market value when its development or improvement have been completed.

- 39.3 The Contractor shall ensure that any Asset financed to any extent by the Department is adequately insured.
- 39.4 The Contractor shall inform the Department if it proposes to dispose of, or change the use of, any Asset that has been financed by the Department.
- 39.5 The Contractor shall not dispose of any Asset financed by monies provided by the Department unless it has first obtained the written consent of the Department to such a disposal.
- 39.6 Where the Contractor disposes of the Asset it shall pay to the Department whichever is the greater either the amount of Funding provided by the Department in respect of the Asset or the net proceeds of any disposal of an Asset, or the appropriate proportion thereof, to the Department unless otherwise agreed with the Department.
- 39.7 If the Contractor changes the use of any such Asset it will be treated as a disposal and the Contractor shall make a payment to the Department in accordance with Clause 39.6 above.
- 39.8 In the event of the Contractor being taken over or merging this will be deemed to be a disposal and the provisions of Clauses 39.4, 39.5 and 39.6 will apply. The Department reserves the right to permit the Contractor to continue to use the relevant Asset or Assets after it has been taken over or merged.
- 39.9 In the event of the Contractor going into liquidation, this Clause 39 will have the effect of a title retention clause and all Assets financed by the Department, or the equivalent portion of their market value will, become the property of the Department.
- 39.10 The provisions of this clause shall apply during the continuance of this Contract and for a period of six (6) years after its expiry or termination howsoever arising.

40 Effective Date

40.1 The terms and conditions set out in this document will take effect from 1 January 2018 and will be reviewed on or before 31 March 2019 ("the Initial Contract Period) and on or before each 31 March while the Contract remains in force".

41 Continuing Obligations

41.1 Save as otherwise expressly provided in this Contract:

41.1.1 the termination or expiry of this Contract will be without prejudice to any accrued rights and obligations under this Contract as at the Expiry Date or the Termination Date; and

41.1.2 the termination or expiry of this Contract will not affect the continuing rights or obligations of the Department and the Contractor under the clauses in the table below and/or under any other provision of this Contract which is expressed to survive expiry or termination or which is required to give effect to such expiry or termination or the consequences of such expiry or termination for a period of six (6) years:

42.3 The parties acknowledge that this Contract has not been entered into wholly or partly in reliance on, nor has either party been given, any warranty, statement, promise or representation by the other or on its behalf other than as expressly set out in this Contract.

1 Transfer of Undertakings (Protection of Employment) Regulations 2006 and Pensions Aspects

1.1 Definitions

- 1.1.1 "Admission Agreement" means an agreement between the Department and the Contractor and a Public Sector Pension Scheme, so that each Transferring Employee may continue to participate in that employee's respective Public Sector Pension Scheme, after the Employee Transfer Date;
- 1.1.2 "Employee Transfer Date" means in respect of any particular Transferring Employee the date on which the part of the Services to which they are assigned transfers from the Previous Contractor to the Contractor;
- 1.1.3 "Fair Deal" means the guidance issued by HM Treasury in October 2013 or any subsequent guidance on fair deal for staff pensions for staff transferring from the public sector under the control of Central Government
- 1.1.4 "Final Pay Details" means the information set out in Appendix D;
- 1.1.5 "Future Transfer Date" means the date of termination or expiry of this Contract;
- 1.1.6 "Future Transferring Employees" means those employees of the Contractor who are at the Future Transfer Date employed under a contract of service or Apprenticeship or otherwise in the relevant part of the undertaking which transfers on the termination or expiry of this Contract pursuant to TUPE or the Acquired Rights Directive 187/77/EC or otherwise to any Successor Contractor;
- 1.1.7 "Initial Staff Information" means the information set out in Appendix A;
- 1.1.8 "Original Transfer Date" means [];
- 1.1.9 "Prescribed Particulars" means in respect of each of the Future Transferring Employee the information set out in Appendix B;
- 1.1.10 "Previous Contractor" means the Contractor engaged in providing services substantially the same as the Services set out in this Contract prior to the coming into force of this Contract;
- 1.1.11 "Public Sector Employee" means a Transferring Employee who immediately before the Employee Transfer Date was employed by an employer covered by a Public Sector Pension Scheme;

1.1.12 "Public Sector Pension Scheme" means:

- 1.1.12.1 The Teachers Pension Scheme (TPS)
- 1.1.12.2 The Local Government Pension Scheme (LGPS)
- 1.1.12.3 The Principal Civil Service Pension Scheme (PCSPS).

as applicable;

1.1.13 "Relevant Legislation" means any statute or regulations or the EC Treaty (or any directives or regulations made there under);

1.1.14 "Relevant Personnel Documentation" means the information set out in Appendix C;

1.1.15 "Relevant Transferring Members" means those Transferring Employees who were members of the LGPS or TPS or who were eligible to join the LGPS or TPS;

1.1.16 "Required Information" means the information set out in Appendix A to Appendix F;

1.1.17 "Successor Contractor" means the person nominated by the Department to undertake the services substantially the same as the Services after the termination of this Contract;

1.1.18 "Successor Contractor's Scheme" means:

- 1.1.18.1 the LGPS or TPS or PCSPS; or
- 1.1.18.2 any other retirement benefit scheme established by the Successor Contractor or to which the Successor Contractor is party,

as applicable;

1.1.19 "Transferring Employees" means those employees of the Previous Contractor or the Department who are employed in the performance of services substantially the same as the Services; and "Transferring Employees" shall be construed accordingly; and

1.1.20 "TUPE" means the Transfer of Undertakings (Protection of Employment) Regulations 2006, as amended from time to time.

1.2 Transfer of Undertakings (Protection of Employment) on Commencement

1.2.1 The Contractor shall on the Employee Transfer Date become the employer of the Transferring Employee and, whether or not by virtue of TUPE, or as a term of this Contract, all the respective employer's rights, duties, powers, liabilities and obligations in respect of the contract of employment of the Transferring Employee shall transfer to

the Contractor. The Parties shall respectively comply with all the requirements and obligations, which TUPE imposes on a transferor and transferee in respect of such transfer whether or not as a matter of Law TUPE applies;

- 1.2.2 For the avoidance of doubt, the Contractor assumes full responsibility for any claims made by a Transferring Employee in respect of their terms and conditions of employment and will indemnify the Department and the Previous Contractor in respect of any claim brought by any Transferring Employee which arises from operation of this Paragraph 1.2; and
- 1.2.3 Where the Transferring Employee is a Public Sector Employee the Contractor must comply with the Cabinet Office Statement of Practice.

1.3 Protection of Pensions – Public Sector Employees

- 1.3.1 The Contractor shall:

- 1.3.1.1 In respect of service from the Employee Transfer Date and at a date not later than one month prior to the Employee Transfer Date;
 - (A) Establish, or have become party to an employee's retirement benefit scheme that makes retirement provision which is approved or capable of approval by the Inland Revenue as an exempt approved scheme under Chapter 1 of Part XIV of the Income and Corporation Taxes Act 1988 and capable of receiving a transfer payment from the Public Sector Pension Scheme and certified by the Government Actuary's Department or other actuary to be agreed between the Parties, to be broadly comparable to the Public Sector Pension Scheme ("The Contractor's Scheme"); or
 - (B) Have entered into an Admission Agreement in respect of, or otherwise be able to provide a Relevant Transferring Member with membership of, a Public Sector Pension Scheme, where permissible by the rules of that scheme or in accordance with Fair Deal, or
 - (C) Establish, or have become party to an employee's retirement benefit scheme that makes retirement provision which is accepted in writing by each individual transferring employee as being adequate for their personal retirement provision.

Admission of the Relevant Transferring Members to the Contractor's Scheme

- 1.3.1.2 Procure that the Relevant Transferring Members shall be automatically admitted to the Contractor's Scheme with effect from the Employee Transfer Date unless any of the Relevant Transferring Members elect within three (3) months of the Employee Transfer Date by notice in writing not to become members of the Contractor's Scheme from such date;
- 1.3.1.3 Invite those Relevant Transferring Members who elect to join the Contractor's Scheme to request that a payment is made from the Public Sector Pension Scheme to the Contractor's Scheme in respect of the retirement benefits accrued in the Public Sector Pension Scheme on behalf of those Relevant Transferring Members;
- 1.3.1.4 Procure that the Contractor's Scheme will accept a cash payment equal to the Transfer Value made from the Public Sector Pension Scheme to the Contractor's Scheme;
- 1.3.1.5 Procure that the Contractor's Scheme will provide [x] years of reckonable service in respect of each year of a Relevant Transferring Member's period of reckonable service under the Public Sector Pension Scheme to those that each Relevant Transferring Member respectively had under the Public Sector Pension Scheme as at the Transfer Date;

Admission of the Relevant Transferring Members into a Public Sector Pension Scheme

- 1.3.1.6 Where the option set out in 1.3.1.1(b), applies ensure that each Transferring Employee may participate, or continue to participate in their respective Public Sector Pension Scheme; and

Continuity of Schemes

- 1.3.1.7 Neither by voluntary act or omission either prevent the Contractor's Scheme from continuing in full force and effect throughout the term of this Contract, or where the Contractor selects the option set out in 1.3.1.1(b), at any time end the participation of a Transferring Employee of a Public Sector Pension Scheme.
- 1.3.2 Within a reasonable time prior to the Employee Transfer Date the Contractor shall notify each of the Transferring Employees in writing of the terms and conditions upon which they will be employed by the Contractor on and after the Employee Transfer Date and the details of the Contractor's Scheme, or Public Sector Pension Scheme and the

proposed organisation of the undertaking after the Employee Transfer Date.

- 1.3.3 The Contractor shall procure that an amendment shall only be made to the Contractor's Scheme which could reduce the value of the benefits of any Relevant Transferring Member which have accrued to the date upon which the power to amend is exercised, if any such amendment is required by legislation or is made with the written consent of the Relevant Transferring Member. The value of the benefits shall make explicit allowance for expected future salary growth as determined by the actuary of the Contractor's Scheme as if the Relevant Transferring Member had continued in employment with the Contractor.
- 1.3.4 At the expiry or termination of this Contract, the Contractor shall procure that the Contractor's Scheme shall offer members of the Contractor's Scheme who were Relevant Transferring Members and whose employment transfers to the Successor Contractor, the option to transfer their accrued pension rights to the Successor Contractor's Scheme on an actuarial basis certified by the actuary as no less favourable than the Transfer Value. The value of such accrued pension rights shall not be reduced because of inadequate funds being available in the Contractor's Scheme.
- 1.3.5 The Contractor shall ensure that on a full or partial wind-up of the Contractor's Scheme, the benefits of any Relevant Transferring Member who is currently employed by the Contractor and accruing benefits immediately before such winding up have been increased to those which could be provided by a past service reserve. The past service reserve is to be calculated with regard to projected final pensionable pay at the assumed date of retirement, or earlier death, or leaving service and not the final pensionable pay at the date of wind-up or earlier date of leaving the Contractor's Scheme and each reserve is to be calculated on a basis determined by the actuary of the Contractor's Scheme.
- 1.3.6 Where any Relevant Transferring Member transfers to a Subcontractor engaged in the provision of the Services, the Contractor shall ensure that in any such transfer, the Subcontractor shall establish, or have become party to an employee's retirement benefits scheme on the terms set out in Paragraph 1.3.1.1 ("the Subcontractor's scheme"). The Contractor shall procure that the Relevant Transferring Member is invited to join the Subcontractor's scheme on the terms set out in Paragraphs 1.3.1.2 to 1.3.1.7. The Contractor shall ensure that the Subcontractor's scheme shall include the conditions set out in Paragraphs 1.3.3, 1.3.4, 1.3.5 and 1.3.6.

1.4 Expiry of Contract

- 1.4.1 The Department and the Contractor shall act on the basis that TUPE applies on expiry or termination of the Contract where the Department

is proposing re-contract for services which are substantially the same as the Services.

- 1.4.2 During the period of 18 months preceding the expiry of the Contract or within 21 days after the Department or the Contractor has given notice to terminate the Contract, the Contractor shall disclose to the Department and shall permit the Department to disclose to any tenderer for services which are substantially the same as the Services, the Initial Staff Information provided that prior to so doing any such tenderer shall have executed in writing a confidentiality undertaking in favour of the Contractor.
- 1.4.3 During the period of three months preceding the expiry of this Contract or within 21 days after the Department or the Contractor has given notice to terminate the Contract, the Contractor shall, subject to the provisions of the UK GDPR and Data Protection Legislation, provide and thereafter keep updated at monthly intervals, to the Department and to the Successor Contractor information equivalent to the Relevant Personnel Documentation and the Prescribed Particulars in respect of each employee whom the Contractor reasonably believes will be a Future Transferring Employee provided that prior to so doing the Successor Contractor nominated by the Department shall have executed in writing a confidentiality undertaking in favour of the Contractor.
- 1.4.4 The Contractor shall make reasonable endeavours to assist the Successor Contractor to communicate with, meet and inform and consult with the employees whom the Contractor reasonably believes will be a Future Transferring Employee and their trade union or other employee representatives for the purposes of complying with TUPE.
- 1.4.5 The Contractor shall immediately prior to the Future Transfer Date provide to the Department or the Successor Contractor a complete and accurate list of the Prescribed Particulars and Identification Details of all employees whom it reasonably believes will be Future Transferring Employees.
- 1.4.6 Within a period of 21 days following the expiry or termination of this Contract the Contractor shall provide to the Department or the Successor Contractor in writing Final Pay Details of the Future Transferring Employees.
- 1.4.7 The Contractor warrants that it shall supply complete and accurate information pursuant to Paragraphs 1.4.2, 1.4.3, 1.4.5 and 1.4.6 in all material respects and the Contractor shall indemnify and keep the Department indemnified fully now and in the future in respect of all or any costs whether arising in contract or under any Relevant Legislation suffered or incurred by the Department or the Successor Contractor nominated by the Department by reason of any proceeding, claim or demand arising from or in connection with the provision of information and/or the failure to provide complete and

accurate information under Paragraphs 1.4.2, 1.4.3, 1.4.5, and 1.4.6, and/or the provision of assistance and/or failure to provide assistance under Paragraph 1.4.4 of this Schedule.

1.4.8 After receiving notice of the termination of this Contract and for six (6) months preceding expiry of this Contract the Contractor shall promptly notify the Department or the Successor Contractor:

- 1.4.8.1 of the period of notice given by the Contractor or received from any employee whom THE Contractor reasonably believes will be a Future Transferring Employee regardless of when such notice is to take effect;
- 1.4.8.2 of the termination, for whatever reason, of the employment of any employee whom the Contractor reasonably believes will be a Future Transferring Employee; and
- 1.4.8.3 of any other change to any employee whom the Contractor reasonably believes will be a Future Transferring Employee and their terms and conditions of employment, their Prescribed Particulars and their Relevant Personnel Documentation.
- 1.4.8.4 the Contractor warrants that it shall supply the Required Information completely and accurately in all respects at the time of supply and shall indemnify and keep the Department and/or any Successor Contractor indemnified in respect of all and any costs suffered or incurred by the Department or the Successor Contractor by reason of any proceedings, claim or demand arising out of or in connection with:
 - (A) any claim against the Department or the Successor Contractor by any Future Transferring Employee so far as it relates to any act or omission of the Contractor after the Employee Transfer Date and prior to the Future Transfer Date; and
 - (B) any claim against the Department or the Successor Contractor by any Future Transferring Employee whose name is not included on the list provided by the Contractor pursuant to Paragraph 1.4.5 so far as it relates to the dismissal of such Future Transferring Employee within two Months of the Department or Successor Contractor becoming aware of the transfer of such Future Transferring Employee.

1.4.9 For the purposes of Paragraph 1.4.9, in the event that the Department or the Successor Contractor incurs costs, liabilities or expenditure in respect of Future Transferring Employees which is greater than would have been the case if the Required Information supplied by the

Contractor had been accurate and complete, then such (net) greater costs, liabilities or expenditure shall be deemed to be costs suffered or incurred by the Department or Successor Contractor and included within the indemnity provided by the Contractor.

- 1.4.10 The Department or Successor Contractor shall be entitled to recover from the Contractor in full any legal, accountancy and other costs actually and reasonably incurred by the Department or Successor Contractor in connection with the costs and liabilities indemnified by the Contractor.
- 1.4.11 This Paragraph 1.4 shall continue in effect for six months following the expiry or termination of this Contract.

- 3 The Contractor must ensure that proposed Subcontractors are of adequate financial standing and have sufficient capacity and capability to deliver the services that are to be subcontracted.
- 4 When appointing and working with Subcontractors the Contractor must have regard to "The written agreement between the main provider and each employer" of the latest Funding Rules, in relation to conflicts of interest.
- 5 The Contractor must enter into a direct contractual relationship by way of a Subcontract with all of its Subcontractors before any Subcontractor commences the delivery of the subcontracted services, and such Subcontracts shall comply with the requirements set out in Paragraph 8 below.
- 6 The Services to be delivered with the Funding provided under this Contract may only be subcontracted to one level. Accordingly, the Contractor must ensure that its Subcontractors do not further Subcontract any of the Subcontractor's Services to other suppliers.
- 7 The Contractor must not enter into any agreement for Brokerage in relation to the services under this Contract.

Requirements for Subcontracts

- 8 The Subcontract must include:
 - 8.1 terms and conditions substantially the same as those set out in this Contract, including but not limited to the right for the Contractor to terminate the Subcontract if the Subcontractor does not pass the annual due diligence checks and such other matters as are set out in "The written agreement (the subcontract) between the provider and the subcontractor" of the latest Funding Rules.

- 8.2 where applicable, terms that comply with the requirements of Clause 9.19.2 (Modern Slavery);
- 8.3 an obligation for the Subcontractor to comply with the Department Policies and Subcontractor Policies;
- 8.4 where a Contractor is a contracting authority as determined by Procurement Law, provisions that comply with the requirements of such Procurement Law;
- 8.5 payment provisions such that the Contractor must pay the Subcontractor within 30 days of receiving a valid invoice, unless compliance with Paragraph 8.4 will require otherwise;
- 8.6 an obligation on the Subcontractor to obtain express written permission from the Contractor before enrolling any Apprentices;
- 8.7 a requirement for the Subcontractor to co-operate with the Contractor if the Subcontract ends for any reason to make sure that there is continuity of learning;
- 8.8 an obligation on the Subcontractor to participate in any rectification plan as appropriate in the event that the Subcontractor has committed an act which would constitute a material breach of this Contract (whether or not it is also a breach of the Subcontract); and
- 8.9 sanctions on the Subcontractor for material breach of the Subcontract substantially the same as those set out in this Contract.

9 Subcontracts must be available at all times for the Department to inspect on request.

Contractor Obligations

- 10 The Contractor must make payment to any Subcontractor in accordance with the required provisions of the Subcontract set out at Paragraph 8.5 of this Schedule.
- 11 The Contractor must make a Subcontractor Declaration by using the [Manage your education and skills funding](#) (MYESF) service twice during the academic year. The first declaration must be made by 31 October and the second declaration must be made by 30 June. If the Contractor does not have any Subcontractors at the specified date it must submit a nil return. If after submission of its most recent Subcontractor Declaration the Contractor enters into any Subcontract within the Funding Year, it must submit an updated Subcontractor Declaration to the Department. Further information can be found in the guidance: [How to declare subcontracting for post-16 education and training - GOV.UK](#).
- 12 The Contractor must carry out annual due diligence checks on its Subcontracting arrangements, including but not limited to reviewing its Subcontracts and the rationale for entering into each Subcontract, any fees and

charges involved in the delivery of its subcontracted services and whether each cost is reasonable and proportionate in accordance with the due diligence requirements as set out in "Subcontracting" of the latest Funding Rules.

- 13 The Contractor must publish a policy statement on its public facing website summarising the information in Paragraph 12 of this Schedule by 31 October in each Funding Year. The policy statement must accord with the provisions of "Requirement to provide a rationale for subcontracting" in the latest Funding Rules.
- 14 The Contractor must have a contingency plan in place to ensure that there is continuity of services for existing Apprentices in the event of any circumstances that may arise that render a Subcontractor unable to deliver the subcontracted services including but not limited to the expiry or termination of the Subcontract.
- 15 If a Subcontractor does not pass the annual due diligence checks set out at Paragraph 12 of this Schedule, the Contractor must take action in accordance with the latest Funding Rules.
- 16 The Contractor must ensure that a Subcontractor that has committed an act which constitutes a material breach of this Contract (whether or not it is also a breach of its Subcontract) participates in any rectification plan as appropriate.
- 17 The Contractor must carry out an investigation at its own cost if there is any evidence of a Subcontractor having irregular financial or delivery activity and notify the Department of this and of the outcome of any such investigation.
- 18 The Contractor must not enter new Subcontracting arrangements or increase the value of existing arrangements if any of the following circumstances apply:
 - 18.1 Ofsted has rated the Contractor's leadership and governance as Urgent Improvement (or Ofsted has rated the Contractors management and leadership as Inadequate if the inspection was before 10 November 2025);
 - 18.2 the outcome of the Contractor's annual financial health assessment is inadequate, unless the Department has provided its written consent to the proposed Subcontracting arrangement in advance of a Subcontract being entered into;
 - 18.3 a Subcontractor has been inspected and any evaluation area at provider or apprenticeship provision level, has been judged as Urgent Improvement (or Inadequate if the inspection was before 10 November 2025) by Ofsted; or
 - 18.4 a Subcontractor is subject to ongoing intervention or investigation by the Department.

Subcontracting Thresholds

- 19 The Contractor must continuously review the size of its subcontracted Services and ensure this does not exceed 25% of the services provided by the Contractor.
- 20 The Contractor must promptly submit a request for an exemption if it anticipates that its Subcontracting will exceed 25% ("Exemption Case"). The Contractor must submit such Exemption Case no less than twelve (12) weeks prior to exceeding the threshold. The Department may consider Exemption Cases that are submitted later if the Contractor provides evidence of exceptional circumstances. The Department reserves the right to decline the Contractor's Exemption Case.
- 21 If the Contractor has previously submitted an Exemption Case, it should continue to seek permission to exceed the threshold set out in Paragraph 20 above and must submit an Exemption Case to the Department by no later than 11.59pm on 31 March in each Funding Year. The Department may consider Exemption Cases that are submitted later if the Contractor provides evidence of exceptional circumstances. The Department reserves the right to decline the Contractor's Exemption Case.
- 22 The Exemption Case and the Contractor's submission of it must comply with "Subcontracting threshold and exemption cases" of the latest Funding Rules.
- 23 The Department will consider any submitted Exemption Case in accordance with the provisions of "Subcontracting threshold and exemption cases" of the latest Funding Rules and will notify the Contractor as to whether or not the Exemption Case is accepted.
- 24 The Department expects that any fee retained by the Contractor as a management fee for a Subcontract will not exceed 20% of the overall value of the Subcontract. In the event that the management fee is in excess of 20% of the overall value of the Subcontract the Department reserves the right to require the Contractor to provide further information in relation to the rationale for the management fee and why it represents good value for money.

Financial Thresholds

- 25 Where the annual value in any Funding Year of this Contract exceeds £5 million and the Contractor wants to Subcontract one or more of the services it must comply with the provisions set out in Funding Higher Risk Organisations and Subcontractors Policy, which can be found in the following link [Funding higher risk organisations and subcontractors policy - GOV.UK](#).
- 26 If the aggregate total of all Subcontractors delivering the Services that are Funded on the Contractor's behalf exceeds or is anticipated to exceed £100,000 in any academic year, the Contractor must meet the requirements detailed in [DfE subcontracting standard - GOV.UK](#). The £100,000 threshold includes Apprenticeships, DfE administered Adult Skills Fund and 16 to 19 provision subcontracted by the Contractor.

Department Rights

- 27 In the event that the Contractor fails to comply with any of the requirements set out in this Schedule the Department reserves the right to take such remedial action under this Contract as it considers appropriate in the circumstances, which may include but is not limited to requiring the Contractor to terminate an existing Subcontract and/or prohibiting the Contractor from entering enter into any new Subcontract to deliver the services under this Contract.

SCHEDULE 6

APPRENTICESHIP ACCOUNTABILITY FRAMEWORK

1 Introduction

- 1.1 The Department has published the Apprenticeship Accountability Framework at [Apprenticeship training provider accountability framework - GOV.UK](https://www.gov.uk/government/publications/apprenticeship-training-provider-accountability-framework).
- 1.2 The Apprenticeship Accountability Framework consists of Quality Indicators and Supplementary Indicators.

2 Quality Indicators

- 2.1 The Quality Indicators include those informed through Ofsted Inspections and the Department intervention regime as set out in Clauses 18.21 to 18.28 of this Contract and include (but are not limited to) the following:
 - 2.1.1 the Contractor's own achievement rates and, where relevant, compared with other suppliers delivering similar standards or in similar sectors;
 - 2.1.2 the Contractor's own retention rates and, where relevant, compared with other suppliers delivering similar standards or in similar sectors;
 - 2.1.3 Employer ratings of the Contractor; and
 - 2.1.4 Apprentice ratings of the Contractor.

3 Supplementary Indicators

- 3.1 The Department will also take into account, amongst others, the following Supplementary Indicators:
 - 3.1.1 off-the-job training data (planned and actual hours);
 - 3.1.2 withdrawal rates and/or volumes;
 - 3.1.3 the number of Apprentices that are beyond the planned end date of their Apprenticeship;
 - 3.1.4 unusual changes in the Contractor's delivery pattern of Apprenticeships;
 - 3.1.5 the volume and duration of which breaks in learning occur in the Apprenticeships delivered by the Contractor; and
 - 3.1.6 the timeliness with which Apprentices are registered with an End-Point Assessment Organisation.

4 Apprentice Data Timeliness and Compliance

4.1 The Contractor must comply with Clause 17 (Submission of Apprentice Data) of this Contract in relation to the prompt and accurate submission of Apprentice Data to the Department.

5 Interventions

5.1 The Department will continually monitor performance against the Indicators set out in the Apprenticeship Accountability Framework and may contact the Contractor at any point in the academic year to discuss these. Intervention can be taken at any point in the academic year following any such management conversation and/or correspondence.

5.2 For the avoidance of doubt, where the Department is of the view based on consideration of the Quality Indicators and Supplementary Indicators that the Contractor is underperforming, the Department may take one or more of the following measures:

- 5.2.1 Require the Contractor to attend one or more meetings with the Department;
- 5.2.2 Require the Contractor to make use of the professional development support available through the government funded [Apprenticeship Workforce Development - The ETE](#);
- 5.2.3 Require the Contractor to agree with the Department milestones and targets to be achieved within a fixed period in relation to specific quality and/or supplementary indicators.
- 5.2.4 Serve on the Contractor a notice that details one or more failures and requires the Contractor to rectify the failure(s) specified within a given timeframe;
- 5.2.5 Inform Ofsted of concerns that the Department has about the Contractor;
- 5.2.6 Restrict the Contractor from delivering specific Standards;
- 5.2.7 Require the Contractor to cease to use a named Subcontractor by a specified date;
- 5.2.8 Impose a cap on the volume of new Apprentices, on specific occupational standards, either for a fixed or indefinite period;
- 5.2.9 Impose a cap on the Funding for delivery of new standards, either for a fixed or indefinite period;
- 5.2.10 Withhold or suspend the payment of Funding in accordance with the terms of this Contract;
- 5.2.11 Suspend Funding for all new Apprentices on specific occupational standards, either for a fixed or indefinite period;

5.2.12 Suspend Funding for all new Apprentices, either for a fixed or indefinite period;

5.2.13 Terminate the Contract in accordance with Clause 24.1.17 (Termination) which may also lead to the removal of the Contractor from Apprenticeship Provider and Assessment Register;

6 How the Department will take decisions to intervene based on the Quality Indicators and the Supplementary Indicators

6.1 The Apprenticeship Accountability Framework as referred to at Paragraph 1.1 will set out the trigger points that the Department may, at its discretion, choose to intervene.

6.2 In taking the decision as to what intervention, if any, to take, the Department shall act in accordance with the Apprenticeship Accountability Framework and take into account one or more of the following factors and/or any other factors that the Department considers to be relevant:

6.2.1 Whether it is a Quality Indicator or a Supplementary Indicator that the Contractor has failed to meet; and/or

6.2.2 Whether the data for the relevant Quality Indicator or Supplementary Indicator is in-year data or the final outturn for the relevant academic year; and/or

6.2.3 In relation to the Quality Indicators and Supplementary Indicators whether there are any specific circumstances that the Department considers are relevant to the Contractor's performance; and/or

6.2.4 Previous performance and track record of the Contractor including in relation to the prompt and accurate submission of Apprentice Data as set out at Paragraph 4.1; and/or

6.2.5 if the resource the Department must commit to manage this Contract is disproportionate to (i) the total number of Apprentices that are/were supported in the current, or prior academic year; and/or (ii) the total number of Apprentices that are/were supported in a growth or non-priority area in the current or prior Academic Year.
