b. 080715 CCoy. On information passed from the RMP C Coy investigated the hse of a suspected rapist at GR 66943 75890. The suspect was named as Mohammed Rhadi NAMAA. The hse identified was correct. The suspect was absent but the suspect's father was present. The hse was searched and various small arms ammunition was found along with a pistol holder but the pistol and small arms wpn were missing. On initial questioning the father gave a confused statement about his son. The father did not give a coherent answer to when his son left the hse and the C/S did not press the matter. **COMMENT:** The information about the suspect implicated him as an arms seller as well as a rapist. A computer was confiscated during the search, this will be passed to the DET. **COMMENT ENDS** After questioning, the father sat quietly in a corner while the C/S removed the ammunition and the computer. He then complained of illness and the C/S attempted first aid. The father then had a suspected heart attack and was taken to the Czech hospital. He was pronounced dead at the hospital. **COMMENT:** The C/S will return to the area 09 Apr to inform neighbours that the father is in the hospital. **COMMENT ENDS**

e. GR 686 798 C Coy launched a cordon, search and arrest operation on info from Bde TCC. The info pertained to a BP cell of 4 people arriving in BAZ from the north to assist a loyalist in attacking CF. Two targets IVO GR 686 798 were identified and one at GR 6906 7980. The operation commenced at 131730. Nothing found at Tgt one. 3 pax arrested, 2 x AK47, 16 magazines, 1 x 9mm pistol and 15 rds (and cleaning kit), 1 x Russian grenade and fuse, 1 x knife, 1 x leather ammo pouch and 2 x chest rig (IZ issue) at Tgt two. 2 x knives, 1 x AK47, 5 mags, 5 combat jkts, mil clothing, 1 x bag of 50,000 Dinar, no pax lifted at Tgt three.

Pax arrested:

- i. [REDACTED] SO107
- ii. Abd Al Jaiber MOUSIA
- iii. Beshar Abid AL JABAR (later died)

Following tactical questioning a further search op was launched 131930 to the same GR in order to search a further five houses. A suitcase full of money, a locked box and a pistol were found. At 131900 General Karim Mohammed HUSSAIN arrived at C Coy loc (he was an initial tgt and had turned himself in for questioning). He was detained with the 3 initial prisoners.

**COMMENT:** A full report will be written by C Coy. The detainees will all go to UK JFIT. However, it is unclear who is unaccounted for from the initial tgt list.

The initial list was:

- [REDACTED] - Currently in hospital
- [REDACTED] - Could well be one of the prisoners
- [REDACTED] - Not arrested
- Abdul JABBAR - Could well be dead prisoner
- General Karim - Arrested
- [REDACTED] - Not arrested
