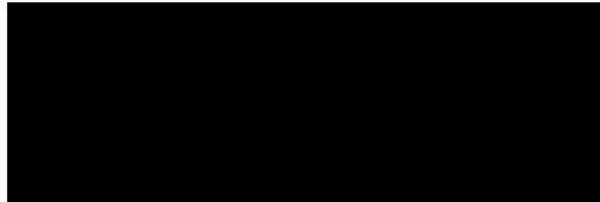

1. No more than 1,245 service users may be accommodated on the Order land at any time.

Reason: The details submitted pursuant to Schedule 3, Part 1, Condition 19 (Full OMP: establishment and review) relate to policies, procedures and standards of operation and for a maximum occupancy of 1,245 service users.

Annex 2 – Informatives

1. A further submission and approval pursuant to Schedule 3, Part 1, Condition 19 (Full OMP: establishment and review) will be required to secure service user occupancy in excess of 1,245 service users.
2. If any material changes are required to the Wethersfield Operational Management Plan (referenced 241113-HO-UP-Wethersfield-Operational-Management-Plan), the Home Office must make a subsequent submission and seek approval pursuant to Schedule 3, Part 1, Condition 19 (Full OMP: establishment and review).
