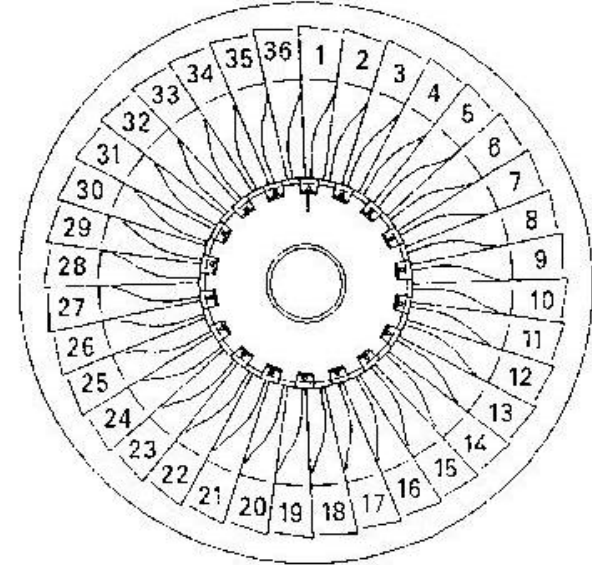

# Instructions for Use

## Pratt & Whitney Engine Blade Replacement Record - MOD Form 704FBRR(C17A)

1. This form is used to record details of the replacement of 1st Stage LP Fan Blade Sets. Actions for completion are detailed below.
2. MOD Form 704FBRR(C17A) is to be inserted into, and removed from, the MOD Form 700C in accordance with the instructions for controlled forms on MOD Form 799/1. Sheet numbers in the series 001 to 999 are to be used.
3. A new MOD Form 704FBRR(C17A) is to have the following information entered:
  - a. Aircraft Serial No.
  - b. ECU Position.
  - c. ECU Serial No.
  - d. ECU Hours at fitment.
  - e. Sheet No.
4. When an ECU change is carried out, the existing MOD Form 704FBRR(C17A) is to be removed and a new form inserted iaw with the instructions for controlled forms on MOD Form 799/1. The information stated in **Paragraph 3** is then to be populated.
5. The MOD Form 704FBRR(C17A) is to be used as follows.
  - a. When LP Fan Blades Sets are replaced, the following information is to be entered in **Table 2** of MOD Form 704FBRR(C17A):
    - (1) The date of the SNOW.
    - (2) The Blade Set being replaced.
    - (3) The Snow Number of the Maintenance Work Order replacing the Fan Blade Set.
6. When the 7th Blade Set has been replaced, a vibration run must be carried out iaw TO E71-00-0123-00001-340A-A. A new MOD Form 704FBRR(C17A) must then be inserted into the **Section 4** and the form serial number entered on the MOD Form 713. The completed MOD Form 704FBRR(C17A) should be removed and the MOD Form 713 amended. The removed form is to be retained iaw the retention category stated in MAM-D Part 2.
