## 5 Permit conditions of use and issue

1. The fishing permit is not valid until the front of the permit is completed in full.
2. The permit remains the property of the Environment Agency and must be produced on the request of an authorised officer.
3. The availability of fishing spaces is not guaranteed and refunds are not available for non-use of the permit.
4. Children accessing the sites under the age of 16 must be continuously supervised by an adult and both adult and child must have a valid fishing permit.
5. The permit allows the use of up to two rods and lines when fishing for coarse fish and eels (where byelaws allow) and only one rod and line when fishing for other species.
6. The permit is not transferable and access is only permitted to the fishing site over authorised routes.
7. The Environment Agency reserves the right to suspend or cancel a permit, refuse entry to any site or require you to leave without notice and can refuse to grant or renew applications.
8. The permit holder enters Environment Agency property at their own risk and the Agency accepts no liability in respect of accidents, loss or injury arising out of the use of this permission.
9. Permits are issued subject to existing fishing or other rights and the normal closed seasons, the Thames Conservancy Acts and Orders (1932 to 1972), Thames Navigational and General Byelaws, the Fisheries Byelaws and such other Rules, Regulations, Byelaws and orders made from time to time by the Environment Agency.

## 6 Privacy notice: how we use your personal data

We are the Environment Agency and we run the Thames lock and weir fishing permit service. We are the data controller for this service. A data controller determines how and why personal data (personal information) is processed.

Our personal information charter ([www.gov.uk/government/organisations/environment-agency/about/personal-information-charter](http://www.gov.uk/government/organisations/environment-agency/about/personal-information-charter)) explains how we deal with your personal information. ### The data we need

The personal data we collect about you includes:

- name
- address
- contact details (including email address)
- rod licence number

We are allowed to process your data in order to prepare for entering into a contract with you at your request. This contract gives you permission to fish at named sites owned by the Environment Agency, subject to certain conditions. The lawful basis for processing your personal data is that it is necessary for taking steps at your request prior to entering a contract and for performance of a contract.

If you do not give us all information requested then we will not be able to process your application or provide a permit and you will not be able to fish at the sites listed.

## 6 Privacy notice, continued

### What we do with your personal data

The personal information you give us to process your application and issue your lock and weir fishing permit. We use your personal data you give us to contact you about our service.

We do not use your personal data to make an automated decision or for automated profiling.

We will not share or disclose your personal data to any party outside the Environment Agency without your explicit consent unless we are lawfully able to do so.

### How long we keep your personal data

We will keep your personal data for 6 years from receipt of your application, in line with our standard information retention policy.

### Where your personal data is processed and stored

We store and process your personal data on our servers in the UK.

We will not transfer your personal data outside the European Economic Area.
