REQUEST FOR INFORMATION: Livestock Density Data GIS data request

Thank you for your request for information of 6th November about Livestock Density Data GIS data request. APHA have handled your request under the Environmental Information Regulations 2004 (EIRs).

The EIRs apply to requests for environmental information, which is a broad category of information defined in regulation 2 of the EIRs. Public authorities are required to handle requests for environmental information under the EIRs. They give similar access rights to the Freedom of Information Act 2000 (FOIA).

“To support this project, I require the livestock density data for Wales (sheep and goat population density), as utilised in [this report](#), or something more recent, if available. If you would prefer, I can share a shapefile of the boundary we are interested in to reduce the amount of data shared. Any GIS format would be appreciated.”

Please see the attached Appendix01 for the goat population 2023 to 2024. Please also find attached Appendix02 which shows the sheep population 2023 to 2024.
