modifying Appendix 1 to Annex XIII to the EU-Andean Countries Trade Agreement, as incorporated into and made part of the Trade Agreement between the United Kingdom of Great Britain and Northern Ireland, of the one part, and the Republic of Colombia, the Republic of Ecuador and the Republic of Peru, of the other part

THE TRADE COMMITTEE,

Having regard to the Trade Agreement between the United Kingdom of Great Britain and Northern Ireland (hereinafter, ‘the United Kingdom’), of the one part, and the Republic of Colombia, the Republic of Ecuador and the Republic of Peru (hereinafter, ‘Peru’), of the other part (hereinafter ‘the Agreement’), and in particular Article 13(1)(d) of the EU-Andean Countries Trade Agreement as incorporated therein (hereinafter ‘the Incorporated Agreement’),

Whereas:

- (1) The Agreement entered into force on 31 December 2020.
- (2) Article 1 of the Agreement indicates that the objective of the Agreement is to preserve the rights and obligations between the Parties as provided for by the Incorporated Agreement after it ceases to apply to the United Kingdom.
- (3) Article 2 of the Agreement indicates that the provisions of the Incorporated Agreement are incorporated into and made part of the Agreement, *mutatis mutandis*, subject to the provisions of the Agreement and the modifications in the Annex to the Agreement.
- (4) On 29 August 2024, Peru submitted to the United Kingdom within the framework of the Sub-committee on Intellectual Property its request to add six new geographical indications to Appendix 1 to Annex XIII to the Incorporated Agreement, in accordance with Article 209 of the Incorporated Agreement. On 26 September 2024, Peru submitted an additional request for the incorporation of a seventh new geographical indication. The United Kingdom completed the objection procedures and the examination of the seven new geographical indications of Peru.
- (5) On 16 July 2025, pursuant to Article 257(2) of the Incorporated Agreement, the Sub-committee on Intellectual Property, in a session between the United Kingdom and Peru, assessed the information in relation to the seven geographical indications and submitted a proposal to the Trade Committee to modify Appendix 1 to Annex XIII to the Incorporated Agreement to include those seven geographical indications in the Appendix.
- (6) The Trade Committee has evaluated the proposal of the Sub-committee on Intellectual Property and considers that Appendix 1 to Annex XIII to the Incorporated Agreement should therefore be modified.

- (7) The decision to modify Appendix 1 to Annex XIII to the Incorporated Agreement may be adopted in a session of the Trade Committee between the United Kingdom and Peru, pursuant to Article 14(3) of the Incorporated Agreement, as it relates exclusively to the bilateral relationship between the United Kingdom and Peru and does not affect the rights and obligations of another signatory Andean Country.

HAS DECIDED AS FOLLOWS:

Article 1

In the table under point (c) ‘Geographical indications of Peru for agricultural and foodstuff products, wines, spirit drinks and aromatised wines’ in Appendix 1 to Annex XIII to the Incorporated Agreement the entries in the Annex to this Decision are added.

Article 2

This Decision is signed by the Chairperson of the Trade Committee and shall enter into force on 13 May 2026.
