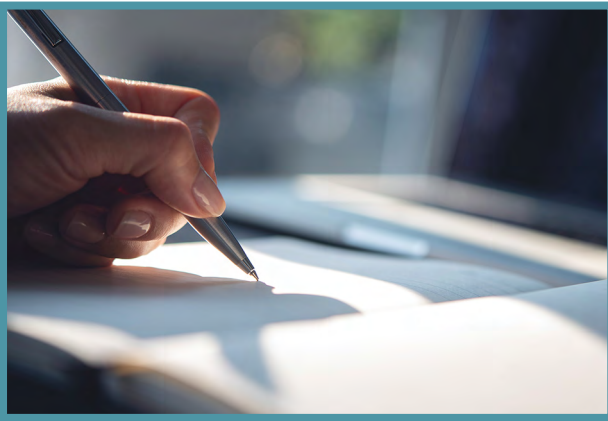


The Interim Report explains:

- what work still needs to be done.



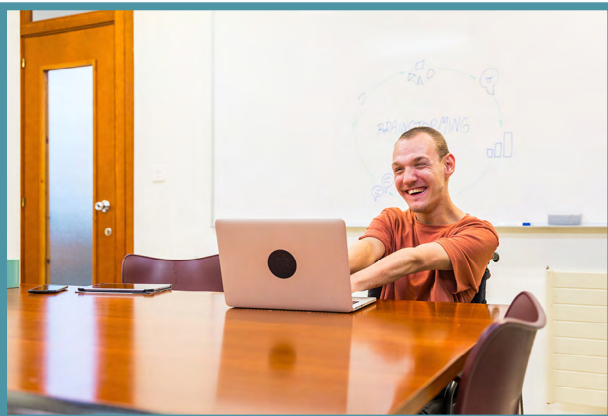
The Review will continue to collect and consider new evidence and hear from people.

This was so people could choose the the best way for them to take part.

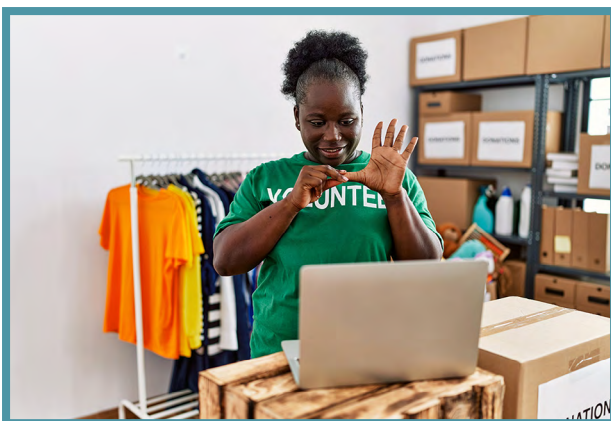
Workshop in a Box



Organisations can use the 'Workshop in a Box' to talk to people about PIP



These workshops help people share their experiences with the Review.



This includes, but is not limited to:

- d/Deaf and Disabled People's Organisations (DDPOs)
- disability or health charities



- community groups
- elected representatives.

Elected representatives are people that other people have chosen to represent them, like Members of Parliament.

Expert sessions



The steering group is meeting with different types of experts across different areas.

- legal professionals.

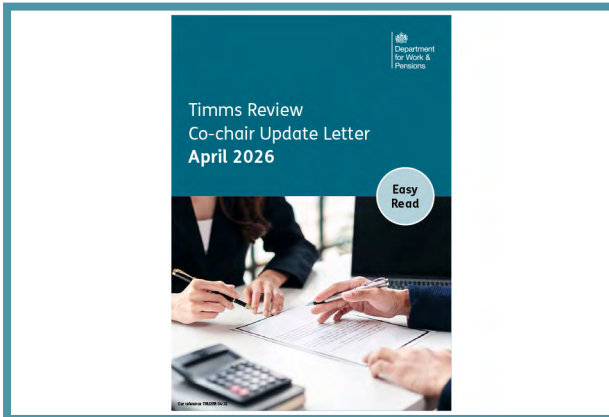


These sessions will help the steering group think about how a future PIP system could work.

Survey



We mentioned in our April update that a survey will take place later this summer.

The survey will use a group of people who have already agreed to take part in research.



This group is managed by the National Centre for Social Research.

The steering group will look at the survey findings in September 2026.

The survey results will then be published later in Autumn 2026.

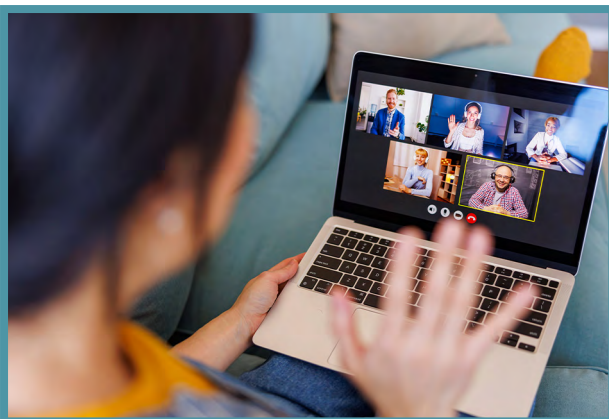
‘Shaping Recommendations Workshops’
