The amendments add a note to refer to the removal of restrictions on claiming UC for mixed-age couples, add a note about the National Living Wage, add qualifying benefits to the list of partners who are regular carers and treated as not in remunerative work, and update the NMW rate for 2023.

Note added under paragraphs 46301 and 46363 read as follows–

Note: Whether it is in the interest of the claimant or their family to apply a deduction or not, the claimant must be given the opportunity to make representations regarding whether it is in their interest before deductions are imposed. For further information please refer to operational guidance.

DMG Memo 15/21 incorporated – payments disregarded when considering the income of non-dependants (para. 44611).

DMG Memo 02/21 incorporated – living in other accommodation because of fear of violence – one of them may attract owner-occupier payments (para. 44256).

Up-rating DMG Memos 04/21, 07/22 and 4/23 incorporated (Appendix 3).

DMG Memos 09/21 and 03/22 incorporated – when considering whether a non-dependant deduction for housing costs is appropriate CDP added to the list of benefits to consider when deductions should not be made (para. 44606).

DMG Memo 12/22 incorporated – ADP commences/converted from PIP/DLA whilst a claimant is in hospital – entitlement to SDP will have to be considered (para. 44179).

DMG Memo 06/22 incorporated – definition of terminally ill (para. 44005).

Para. 44180 Example 2 amended to make clear a couple in respect of lower rate SDP will not lose their entitlement after 28 days when one member goes into hospital.

DMG Memo 3/22 incorporated – ADP added to the list of benefits when considering entitlement to premiums and the effect on non-dependants when considering housing costs (paras. 44101, 44112–44114, 44116, 44118, 44181, 44606, 44611).

Note added to para. 44139 to make clear it is the date of the claimants/partners right to occupy the dwelling that we consider.

Para. 44102 amended to make clear housing costs are included in any calculation of entitlement to ESA(IR). ESA(IR) does not have to be in payment before housing costs can be considered.

DMG Memo 09/22 (IS, SPC, IR ESA, IB JSA - Temporary cease on third party

deduction request by fuel suppliers for ongoing consumption) originally would have ceased to have effect from 6 April 2023 but will now be revoked effectively from when The Social Security Benefits (Claims and Payments) (Amendment) Regulations 2023 (SI 2023/232) makes a permanent change to the process for requesting deductions from benefit for ongoing consumption payments from 1 April 2023. It will require new requests, or requests for increased deductions, to be made by energy suppliers and such deductions will only be made with the claimant's consent. Paragraphs 46310 and 46326 have been updated to reflect the new changes effective from 01/04/2023.
