PNEUMOCOCCAL MENINGITIS

The disease

Pneumococcal disease is the term used to describe infections caused by the bacterium *Streptococcus pneumoniae* (also known as the pneumococcus).

S. pneumoniae is an encapsulated Gram-positive coccus. The capsule is the most important virulence factor of *S. pneumoniae*; pneumococci that lack the capsule are normally not virulent. Over 100 different capsular types have been characterized. Prior to the routine conjugate vaccination programme, around 69% of invasive pneumococcal infections were caused by the ten (14, 9V, 1, 8, 23F, 4, 3, 6B, 19F, 7F) most prevalent serotypes (Trotter *et al.*, 2010).

Some pneumococcal serotypes may be carried in the nasopharynx without symptoms, with disease occurring in a small proportion of infected individuals. Other serotypes are rarely identified in the nasopharynx but are associated with invasive disease. The incubation period for pneumococcal disease is not clearly defined but it may be as short as one to three days. The organism may spread locally into the sinuses or middle ear cavity, causing sinusitis or otitis media. It may also affect the lungs to cause pneumonia or systemic (invasive) infections including bacteraemic pneumonia, septicaemia and meningitis.

Transmission is by airborne transmission or inhalation, or direct deposition and usually requires either frequent or prolonged close contact. There is a seasonal variation in pneumococcal disease, with peak levels in the winter months.

History and epidemiology of the disease

Invasive pneumococcal disease (IPD) is a major cause of morbidity and mortality. In 2005/06, prior to routine pneumococcal conjugate vaccination, there were 6,346 IPD cases in England and Wales (Ladhani *et al.*, 2018). IPD particularly affects the very young, the elderly, and those with impaired immunity and other underlying medical conditions. Recurrent infections may occur in association with skull defects, cerebrospinal fluid (CSF) leaks, cochlear implants or fractures of the skull.

There are several pneumococcal vaccines approved in the UK which provide protection against different serotypes (Table 1). The vaccines are inactivated, do not contain thiomersal and do not contain live organisms, so cannot cause the diseases against which they protect.

Pneumococcal polysaccharide vaccine (PPV23)

PPV23 contains purified capsular polysaccharide from 23 common capsular types of pneumococcus. Most healthy adults develop a good antibody response to a single dose of PPV23 by the third week following immunisation. Children younger than two years of age show poor antibody responses to immunisation with PPV23 and there is no evidence of effectiveness of PPV23 in this age group (Grabenstein *et al.*, 2017).

In the UK, PPV23 has been recommended for risk groups since 1992 and for all people aged 65 years and over since 2003. During the first two years after vaccination, PPV23 has a moderate short-term effectiveness of 41% against IPD caused by the vaccine serotypes in adults aged 65 years and over with vaccine effectiveness being higher among healthy individuals compared to those with underlying medical conditions (Djennad *et al.*, 2019). There is some evidence for PPV23 offering protection against non-bacteraemic pneumococcal pneumonia (Diao *et al.*, 2016).

In early 2026, the UK began to move from PPV23 to PCV20 in at-risk groups and adults when they turn 65 years. PPV23 is no longer available to order as part of the UK national immunisation programme.

Pneumococcal conjugate vaccines (PCV)

PCVs have been developed using polysaccharides from the most common capsular types. Conjugating the polysaccharide to proteins, using similar manufacturing technology to that used successfully for *Haemophilus influenzae* type b (Hib) and meningococcal conjugate vaccines, improves the antibody response, particularly in young children from two months of age.

In September 2006, the UK introduced the 7-valent PCV (PCV7) into the infant immunisation programme at a 2+1 schedule (2 doses given at 8 and 16 weeks of age with

a booster from 12 months of age), alongside a catch-up for all children up to 2 years of age. The programme achieved very high vaccine coverage (>90%) and resulted in a rapid and sustained reduction in IPD across all age groups due to the PCV7 serotypes. This was because the vaccine provided direct protection, as well as indirect (herd) protection achieved through the prevention of pneumococcal carriage in the vaccinated child's nasopharynx and onward transmission to others (Miller *et al.*, 2011). This decline was partially offset by small increases in non-PCV7 type IPD across all age groups.

In April 2010, PCV13 replaced PCV7, which led to further reductions in IPD due to the additional 6 serotypes in PCV13 (Waight *et al.*, 2015). Since 2013/14 an increase in overall incidence of IPD has been observed, largely due to increases in non-PCV13 serotypes (especially serotypes 8, 12F and 9N) and mainly in older age groups (Ladhani *et al.*, 2018).

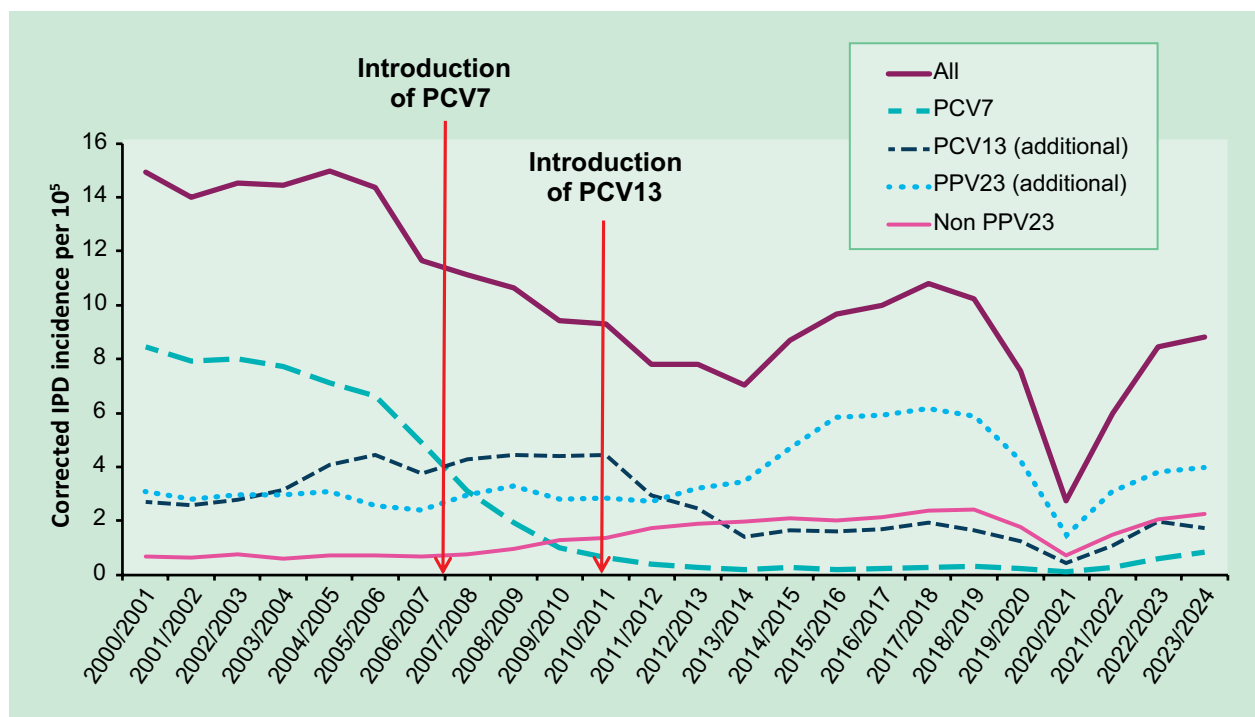


Figure 1. Corrected IPD incidence in England between 2000/01 and 2023/24 by serotype group

In January 2020, the UK moved to a 1+1 infant schedule, with vaccinations given at 12 weeks and 1 year of age (Goldblatt *et al.*, 2018; Choi *et al.*, 2019; Ladhani *et al.*, 2020). In 2020/21, following the COVID-19 pandemic lockdown and restrictions, IPD incidence decreased by 65% across all age groups (Figure 1) (Amin-Chowdhury *et al.*, 2022). As restrictions were eased, IPD incidence gradually increased, initially in young children then followed by older children and adults (Figure 1).

From 1st July 2025, the first PCV13 dose will be given at 16 weeks of age to allow for earlier administration of the second meningococcal B vaccine (4CMenB) dose at 12 weeks of age. Changing the PCV13 dose to 16 weeks, from 12 weeks, has the potential to provide infants with earlier protection against meningococcal disease (two doses at 8 and 12 weeks versus 8 and 16 weeks), without compromising pneumococcal protection because PCV13-type IPD is very rare in infants as a result of the excellent indirect (herd) protection offered by the current PCV programme. The second dose of PCV13 will continue to be given at 1 year of age.

PCV15 and PCV20 are licensed for use from 6 weeks of age. In February 2023, the JCVI considered the use of PCV15 in the childhood schedule and initially agreed that the available evidence indicated it could be used in a 1+1 schedule. PCV15 is currently not included in the UK national immunisation programme. In June 2023, the JCVI advised that either PPV23 or PCV20 could be used in the adult and at-risk programmes. PCV20 started to be used in adults from 65 years of age and the at-risk programme in early 2026.

PCV21 is licensed for use from 2 years of age and is not currently included in the UK national immunisation programme. PCV10 was previously licensed in the UK for use in infants and children from 6 weeks up to 5 years of age but was never included in the UK national immunisation programme.

Presentation and Storage

[Chapter 3](#) contains information on vaccine storage, distribution and disposal.

The summary of product characteristics (SPC) may give further detail on vaccine storage.

PCV13, PCV15, and PCV20

Storage can cause these vaccines to separate into a white deposit and clear supernatant. The vaccines should be shaken well to obtain a white homogeneous suspension and should not be used if there is any residual particulate matter after shaking.

PCV21 and PPV23

The vaccines should be inspected before being given to check that they are clear and colourless.

Dosage and schedule

PCV13

For children and adults in risk groups, refer to Table 2 and the Risk Groups section below.

Routine immunisation for infants under one year of age:

- a single priming dose of 0.5ml of PCV13 at 16 weeks of age
- a booster dose of 0.5ml of PCV13 at one year of age (on or after their first birthday) given at the same time as the other vaccines recommended at that age (see [Chapter 11](#))

Doses of any PCV given before 12 weeks of age should be discounted. The PCV dose at 16 weeks of age should then be given at the same time as the other vaccines recommended at that age.

Additional PCV13 doses are not recommended for routine immunisation but may be indicated for some risk groups (refer to Table 2 and Table 3 below).

PPV23 and PCV20

Adults aged 65 years and over, and clinical risk groups aged 2 years or over:

- a single dose of 0.5ml of PPV23 or PCV20

PCV20 became available to order for adults from 65 years of age and the at-risk programme in early 2026. Locally held stocks of PPV23 should be used up first.

Children under 2 years of age with asplenia, splenic dysfunction, complement disorder or severe immunocompromise should also receive PCV20. See Table 3 for details.

Antibody levels are likely to decline rapidly in individuals with asplenia, splenic dysfunction (including sickle cell disease) or chronic kidney disease (Giebink *et al.*, 1981; Rytel *et al.*, 1986) and, therefore, re-immunisation with PPV23 or PCV20 is recommended every five years in these groups. Testing of antibody levels prior to vaccination is not required for these or any other risk groups.

Revaccination with PPV23 or PCV20 is currently not recommended for any other clinical risk groups or age groups.

If an individual has already received PCV20 or PPV23 because they are in a clinical risk group, they do not require another dose at 65 years of age, irrespective of the interval since they received PCV20 or PPV23.

Administration

[Chapter 4](#) covers guidance on administering vaccines.

Most injectable vaccines are routinely given intramuscularly into the deltoid muscle of the upper arm or, for infants 1 year and under, into the anterolateral aspect of the thigh.

Pneumococcal vaccines can be given at the same time as any other vaccines required. The vaccines should be given at a separate site, preferably into a different limb. If given into the same limb, they should be given at least 2.5cm apart (American Academy of Pediatrics, 2021). The site at which each vaccine was given should be noted in the individual's records.

Disposal

[Chapter 3](#) outlines storage, distribution and disposal requirements for vaccines.

Equipment used for immunisation, including used vials, ampoules, or discharged vaccines in a syringe, should be disposed of safely in a UN-approved puncture-resistant 'sharps' box, according to local waste disposal arrangements and guidance in the [technical memorandum 07-01: Safe and sustainable management of healthcare waste \(NHS England\)](#).

Individuals with unknown or incomplete vaccination histories

Unless there is a reliable history of previous immunisation, individuals should be assumed to be unimmunised. The full UK recommendations should be followed.

Unimmunised children who present late for vaccination before the age of one year should receive a single priming dose of PCV13, followed by a PCV13 booster at one year of age (on or after their first birthday) ideally allowing a minimum 4 week interval between the priming and booster dose to ensure appropriate boosting of the immune response. If the first PCV dose is given late (within 4 weeks of the first birthday) then a minimum interval of 4 weeks should be observed before the booster dose. However, if in the opinion of the healthcare professional, allowing an interval may lead to further delays in administration of the booster dose, then dose two can be administered after the child's first birthday, at any interval after the first dose to bring the child up to date with the UK schedule as soon as possible.

An unimmunised or partially immunised child aged between one and under two years of age should have a single dose of PCV13.

Routine immunisation with PCV is not offered after the second birthday.

Any child less than one year of age and eligible for PCV vaccination who has received one or more doses of PCV10 in another country should be offered a dose of PCV13 after their last dose of PCV10 (allowing for a 4-week interval where possible) from 16 weeks of age and before their first birthday. This ensures that these infants are protected against the same pneumococcal serotypes as those vaccinated in the UK. These infants should then receive one PCV13 booster dose at one year of age (on or just after their first birthday), allowing a minimum 4 week interval between the two UK-administered PCV doses. Allowing a minimum 4 week interval will result in boosting of protection against the ten serotypes that are in both the PCV10 and PCV13 vaccines. However, if, in the opinion of the healthcare professional, allowing an interval may lead to further delays in protection against the additional three strains, the vaccine may be administered at any interval to bring the child up to date with the UK schedule as soon as possible. If the child is over one year when they present for vaccination, they should be offered a single dose of PCV13.

Risk groups

Children and adults in clinical risk groups (Table 2) will require additional pneumococcal vaccination depending on their age when first diagnosed with a clinical risk condition or presenting for vaccination, their vaccination status and underlying condition (see Table 3).

For a child in a clinical risk group, if their PCV dose in the routine programme is given very late (for example at 23 months), then a minimum interval of 4 weeks should be observed before giving a PCV20 booster.

Primary care staff should identify patients for whom vaccine is recommended and use all opportunities to ensure that they are appropriately immunised, for example, when immunising against other diseases, at annual reviews or at other consultations, or on discharge after hospital admission.

Table 2 Clinical risk groups who should receive pneumococcal immunisation

Clinical risk group	Examples (decision based on clinical judgement)
Asplenia or dysfunction of the spleen	This also includes conditions such as homozygous sickle cell disease, hereditary spherocytosis, thalassemia major and coeliac disease with evidence of splenic dysfunction.
Chronic respiratory disease (chronic respiratory disease refers to chronic lower respiratory tract disease)	This includes chronic obstructive pulmonary disease (COPD), including chronic bronchitis and emphysema; and such conditions as bronchiectasis, cystic fibrosis, interstitial lung fibrosis, pneumoconiosis and bronchopulmonary dysplasia (BPD). Individuals in whom respiratory function may be compromised due to neurological or neuromuscular disease (such as cerebral palsy). Asthma is not an indication, unless so severe as to require continuous or frequently repeated use of systemic steroids (as defined in Immunosuppression below).
Chronic heart disease	This includes those requiring regular medication and/or follow-up for ischaemic heart disease, congenital heart disease, hypertension with cardiac complications, and chronic heart failure.
Chronic kidney disease	Nephrotic syndrome, chronic kidney disease at stages 4 and 5 and those on kidney dialysis or with kidney transplantation.

¹ Examples of severe immunocompromise include bone marrow transplant patients, patients with acute and chronic leukaemia, multiple myeloma or genetic disorders affecting the immune system (such as IRAK-4, NEMO). Note that bone marrow transplant recipients under 2 years of age require 2 doses of PCV20 given at least 4 weeks apart, followed by a further dose of PCV20 at 2 years of age (and at least 4 weeks after their previous PCV20 dose), while those aged 2 years and over require 2 doses of PCV20 given at least 4 weeks apart.

² For individuals with asplenia, splenic dysfunction (including sickle cell disease) or chronic kidney disease, re-immunisation with PCV20 is recommended every 5 years.

Timing of vaccination for those requiring splenectomy or commencing immunosuppressive treatment

Because of the high risk of overwhelming infection, particularly for pneumococcal disease, vaccination is recommended for all individuals with asplenia or splenic dysfunction, including individuals with coeliac disease who are diagnosed with splenic dysfunction and all individuals with haemoglobinopathies such as homozygous sickle cell disease. See [Chapter 7](#) for a complete schedule including other vaccines indicated for this group.

Those requiring splenectomy or commencing immunosuppressive treatment should be vaccinated according to the age-specific advice above. Ideally, the vaccines should be given 4-6 weeks before elective splenectomy (for example in patients with chronic disorders such as hereditary spherocytosis) or initiation of treatment such as chemotherapy or radiotherapy. Where this is not possible, it can be given up to two weeks before treatment. If it is not possible to vaccinate beforehand, splenectomy, chemotherapy or radiotherapy should never be delayed.

If it is not practicable to vaccinate two weeks before splenectomy, immunisation should be delayed until at least two weeks after the operation because functional antibody responses may be better from this time (Shatz *et al.*, 1998). If it is not practicable to vaccinate two

weeks before starting chemotherapy/radiotherapy, immunisation should be delayed until at least three months after completion of therapy to maximise vaccine response.

Immunisation of these patients should not be delayed if this is likely to result in a failure to vaccinate.

For leukaemia patients, pneumococcal vaccination should be given according to their age from six months after completion of chemotherapy (Table 3). Bone marrow transplant patients will require additional different vaccines including pneumococcal vaccination which should begin 9-12 months after transplantation.

Individuals at occupational risk

There is an association between exposure to metal fumes and pneumonia, particularly lobar pneumonia, and between welding and invasive pneumococcal disease (Wong *et al.*, 2010). PPV23, PCV20 or PCV21 (single dose for those who have not received PPV23, PCV20, or PCV21 previously) should be considered for those at risk of frequent or continuous occupational exposure to metal fumes (such as welders) taking into account the exposure control measures in place.

Vaccination may reduce the risk of pneumococcal disease but should not replace the need for measures to prevent or reduce exposure.

Contraindications

There are very few individuals who cannot receive pneumococcal vaccines. When there is doubt, appropriate advice should be sought from the relevant specialist consultant, the local Screening and Immunisation Team, or local Health Protection Team rather than withholding vaccine. The risk to the individual of not being immunised must be taken into account.

The vaccines should not be given to those who have had:

- a confirmed anaphylactic reaction to a previous dose of a pneumococcal vaccine
- a confirmed anaphylactic reaction to any component or residue from the manufacturing process

Specific advice on management of individuals who have had an allergic reaction can be found in [Chapter 8](#).

Precautions

[Chapter 6](#) contains information on contraindications and special considerations for vaccination.

Minor illnesses, without fever or systemic upset, are not valid reasons to postpone immunisation. If an individual is acutely unwell, immunisation may be postponed until they have fully recovered. This is to avoid confusing the differential diagnosis of any acute illness by wrongly attributing any signs or symptoms to the adverse effects of the vaccine.

[Chapter 8](#) covers vaccine safety and the management of adverse events following immunisation.

Pregnancy and breast-feeding

Pneumococcal vaccines may be given to pregnant women when the need for protection is required without delay. There is no evidence of risk from vaccinating pregnant women or those who are breast-feeding with inactivated viral or bacterial vaccines or toxoids (Plotkin *et al*, 2018).

Premature infants

Premature infants should be offered pneumococcal vaccination at the appropriate chronological age. They do not require additional doses unless they have a condition which places them in a clinical risk group (see Table 2). See [Chapter 11](#) and [Chapter 7](#) for more information.

Immunosuppression and HIV infection

Individuals with immunosuppression and HIV infection (regardless of CD4 count) should be given pneumococcal vaccines according to the recommendations above. The potential benefit of PPV23 (and PCV20 when available) in preventing pneumococcal disease outweighs any potential risks in HIV- infected adults.

People experiencing homelessness

JCVI have advised (June 2024) that, given the high comorbidity rates in individuals experiencing homelessness, it was reasonable to have a universal offer of pneumococcal vaccination for this cohort, as defined in Table 2.

Adverse reactions

[Chapter 8](#) covers vaccine safety and the management of adverse events following immunisation.

Anyone can report a suspected adverse reaction to the Medical and Healthcare products Regulatory Agency (MHRA) using the Yellow Card reporting scheme (<https://yellowcard.mhra.gov.uk/>).

PCV13

The most commonly reported adverse reactions in clinical trials in children 6 weeks to 5 years of age were vaccination-site reactions, fever, irritability, decreased appetite, and increased and/or decreased sleep.

PCV15

In infants and children aged 6 weeks to less than 2 years the most commonly reported adverse reactions in clinical trials were fever, irritability, somnolence, vaccination site reactions, and decreased appetite.

PCV20

Irritability, drowsiness/increased sleep, decreased appetite, fever and vaccination site reactions were the most commonly reported reactions in children in clinical trials. In adults, the most commonly reported reactions were pain at the injection site, muscle pain, fatigue, headache and joint pain.

PCV21

The most frequently reported adverse reactions in individuals 18 years of age and older were injection-site pain, fatigue, headache, and myalgia. The most frequently reported adverse reactions in children and adolescents 2 to less than 18 years of age were injection-site pain, injection-site erythema, fatigue, injection-site swelling, headache, malaise, and irritability.

PPV23

Mild soreness and induration at the site of injection lasting one to three days and, less commonly, a low-grade fever may occur. More severe systemic reactions are infrequent. In general, local and systemic reactions are more common in people with higher concentrations of antibodies to pneumococcal polysaccharides.

Management of cases, contacts and outbreaks

Cases of invasive pneumococcal disease (IPD)

Any case of IPD or lobar pneumonia believed to be due to *S. pneumoniae* should prompt a review of the patient's medical history to establish whether they are in a recognised risk group and whether they have been appropriately immunised. Unimmunised or partially-immunised individuals who are eligible for pneumococcal vaccination because of their age or underlying conditions should be vaccinated upon discharge from hospital whenever possible.

Cases in children under five years of age

Clinicians should ensure that children diagnosed with IPD have completed the recommended national immunisation schedule. Infants who are younger than 12 months of age at the time of IPD and who are unvaccinated or partially vaccinated should complete the recommended immunisation schedule.

Isolates from all cases of IPD should be referred to the national reference laboratory for serotyping. All new cases of IPD in children aged less than 5 years, regardless of serotype, will be followed up by the UK Health Security Agency, Public Health Wales, Public Health Scotland or the Public Health Agency for Northern Ireland.

Contacts

Close contacts of IPD are not normally at an increased risk of pneumococcal infection and therefore antibiotic prophylaxis is not indicated. Clusters of IPD should be discussed with local health protection teams.

Outbreaks

Outbreaks of pneumococcal respiratory disease in hospitals and residential care homes need prompt investigation. Control measures including vaccination may be appropriate; these should be agreed in discussion with local health protection or infection control teams.
