Form requesting information for movement from the Bluetongue Restriction Zone or Temporary Control Zone to Scotland to live

Outlined supporting evidence must accompany the animals and checks will be made against this form.

Information within this form and associated evidence of a negative PCR test and/or evidence of vaccine purchase and administration will form an information pack that will be checked to confirm conditions of the general movement licence have been met.

Requests to move animals to live from the Bluetongue Restricted Zone or Temporary Control Zone to Scotland require either a valid pre-movement test or, in the case of cattle only, completed vaccination course with the Bultavo-3 vaccine. For cattle that meet the vaccination requirements for movement, the licence will only be valid from 21 days after the second vaccine dose. All requests for movement of sheep require them to be pre-movement tested, even if they are vaccinated. It is not advisable to test an animal within 7 days of any Bluetongue vaccination having been administered.
