Background to the Genetic Modification Inspectorate audit programme

The Genetic Modification (GM) Inspectorate for England liaises with seed importers, producers and merchants in order to undertake a programme of audits of seed material available for planting in England. Audits are voluntary and are intended to help seed companies ensure they have suitable controls in place to minimise the risk of adventitious GM presence (AGMP) in seed of at-risk crops, in accordance with Part VI of the Environmental Protection Act 1990. 'Detailed audits' take place approximately once every 3 years and assess the risk of AGMP, and the controls in place to minimise this risk, throughout the seed production and procurement chain. Detailed feedback is provided to the company. 'Basic audits' take place in the intervening years to determine whether there has been any change in the company's risk status. In cases where an audit identifies factors requiring further clarification or investigation a 'targeted audit' is conducted. The GM Inspectorate seed audit programme is undertaken on behalf of the Defra Varieties and Seeds Policy Team.

Seed audit summary information

On completion of an audit a report is sent to the Defra Varieties and Seeds Policy Team showing the species and varieties imported or produced by the company and the types of assurances provided for each seed lot or batch. In the interests of public knowledge, and in accordance with the government's commitment to openness and transparency, summary information from seed audit reports is published below. Publication does not include material solely intended for trials work. Information is displayed alphabetically, based on company name, and chronologically, based on the date of the audit report.
