DECISION

Summary of the Decision

1. **The Applicants are granted dispensation under Section 20ZA of the Landlord and Tenant Act 1985 from the consultation requirements imposed on the landlord for remedial works to the fire doors at Cedar Court, Sir Bernard Lovell Road, Malmesbury, SN16 9GG (the Property) provided that the Landlord serves a copy of this decision on all of the leaseholders.**

The application and the history of the case

2. The Applicants seek dispensation under Section 20ZA of the Landlord and Tenant Act 1985 from the consultation requirements imposed on the landlord by Section 20 of that Act. The application was received on 19 February 2026.
3. The Property is described as a purpose-built block consisting of 30 flats. The Applicants are the owners of the freehold.
4. The Applicants explain in their application that:
 - a. The subject fire door remedial works were urgently required.
 - b. Sally Rymer, a Fire Safety Officer, carried out a Fire Audit on site on 13 January 2026
 - c. Ms Rymer stated that the Fire Door remedial work was overdue and needed to be actioned immediately.
 - d. Certain fire doors were found to have been compromised to the point that replacement was necessary.
 - e. Ms Rymer indicated that the block would have a Fire Enforcement Notice placed on it if this did not happen, which could involve residents being decanted from their homes.
 - f. The contractor Twenty4 have completed the work,
 - g. The contractor started on the 2 February 2026.
 - h. The works cost £15,243.30.
5. The Tribunal gave directions on 23 July 2026 that respondents should complete a reply form and return it to the Tribunal and to the Applicant; and, if they opposed the application to include a statement setting out why, evidence of what they may have done differently (if the Applicant had to comply with the full statutory consultation process) and to provide copies of all documents to be relied upon, if such were not already included in the Applicant's bundle.
6. The Tribunal determined that the application would be decided on the papers without a hearing in accordance with rule 31 of the Tribunal Procedure Rules

2013 not having received an objection on that point.

7. The Tribunal has not been notified of any objections as advised in an email to the Tribunal of 28 August 2026 received from Ringley Law LLP.
8. The Tribunal has given careful consideration to the information provided to it.

The Law

9. Section 20 of the Landlord and Tenant Act 1985 (“the Act”) and the related Regulations provide that where the lessor intends to undertake major works with a cost of more than £250 per lease in any one service charge year the relevant contribution of each lessee (jointly where more than one under any given lease) will be limited to that sum unless the required consultations have been undertaken or the requirement has been dispensed with by the Tribunal. An application may be made retrospectively.
10. Section 20ZA provides that on an application to dispense with any or all of the consultation requirements, the Tribunal may make a determination granting such dispensation “*if satisfied that it is reasonable to dispense with the requirements*”.
11. The appropriate approach to be taken by the Tribunal in the exercise of its discretion was considered by the Supreme Court in the case of Daejan Investment Limited v Benson et al [2013] UKSC 14.
12. The leading judgment of Lord Neuberger explained that a tribunal should focus on the question of whether the lessee will be or had been prejudiced in either paying where that was not appropriate or in paying more than appropriate because the failure of the lessor to comply with the regulations. The requirements were held to give practical effect to those two objectives and were “*a means to an end, not an end in themselves*”.
13. The factual burden of demonstrating prejudice falls on the lessee. The lessee must identify what would have been said if able to engage in a consultation process. If the lessee advances a credible case for having been prejudiced, the lessor must rebut it. The Tribunal should be sympathetic to the lessee(s).
14. Where the extent, quality and cost of the works were in no way affected by the lessor’s failure to comply, Lord Neuberger said as follows: “*I find it hard to see why the dispensation should not be granted (at least in the absence of some very good reason): in such a case the tenants would be in precisely the position that the legislation intended them to be- i.e. as if the requirements had been complied with.*”

15. The “*main, indeed normally, the sole question*”, as described by Lord Neuberger, for the Tribunal to determine is therefore whether, or not, the Lessee will be or has been caused relevant prejudice by a failure of the Applicant to undertake the consultation prior to the major works and so whether dispensation in respect of that should be granted.
16. The question is one of the reasonableness of dispensing with the process of consultation provided for in the Act, not one of the reasonableness of the charges of works arising or which have arisen.
17. If dispensation is granted, that may be on terms. 14. The effect of *Daejan* has been considered by the Upper Tribunal in Aster Communities v Kerry Chapman and Others [2020] UKUT 177 (LC), although that decision primarily dealt with the imposition of conditions when granting dispensation and that the ability of lessees to challenge the reasonableness of service charges claimed was not an answer to an argument of prejudice arising from a failure to consult.

Decision

18. The application explains that the works were required as an emergency measure as directed by a Fire Safety Officer.
19. The Tribunal is satisfied that it is reasonable in the circumstances for consultation regarding the proposed remedial works to be to be dispensed with on this application, because the Tribunal does not consider that the Leaseholders will be prejudiced by the proposed works being carried out.
20. In reaching its decision the Tribunal has taken account of the fact that no objections have been received, and because the leaseholders may still challenge the reasonableness and the charges for the works in due course.
21. The Tribunal therefore directs that the dispensation is conditional upon the Applicant or their agent sending a copy of this decision to all the leaseholders so that they are aware of the same.
22. For completeness the Tribunal confirms in making this determination that it makes no findings as to the liability to pay or the reasonableness of the estimated costs of the works.

RIGHTS OF APPEAL

1. A person wishing to appeal this decision to the Upper Tribunal (Lands Chamber) must seek permission to do so by making written application to the First-tier

2. The application must arrive at the Tribunal within 28 days after the Tribunal sends to the person making the application written reasons for the decision.
3. If the person wishing to appeal does not comply with the 28-day time limit, the person shall include with the application for permission to appeal a request for an extension of time and the reason for not complying with the 28-day time limit; the Tribunal will then decide whether to extend time or not to allow the application for permission to appeal to proceed.
4. The application for permission to appeal must identify the decision of the Tribunal to which it relates, state the grounds of appeal, and state the result the party making the application is seeking.
