NOTICE OF PROPOSAL TO PUBLISH

**of references to standards in support of The General Product Safety
Regulations 2005 (S.I. 2005/1803)**

1. This notice sets out proposals that:
 - (a) the references to the standards listed in Part 1 of Annex I to this notice are published for the purposes of regulation 6 of S.I. 2005/1803 pursuant to that regulation in relation to England and Wales and Scotland. The list of published standards set out in Part 2 of Annex I to notice 0111/25 is amended in accordance with Annex I to this notice from the date of this notice.
 - (b) the references to the standards listed in Annex II to this notice (which have previously been published for the purposes of regulation 6 of S.I. 2005/1803) be removed from publication from the date set out in that Annex, and that the list of references for removal from publication set out in Part 2 of Annex II to notice 0111/25 be amended in accordance with Annex II to this notice. Accordingly, each of those standards would cease to give rise to any presumption of conformity on or after the date specified in respect of it.
2. The references to standards are proposed to be published under regulation 6 of S.I. 2005/1803 at 00.01 on the 29th day beginning with the date of this notice unless this notice is withdrawn or amended before that date. ANNEX I

The list of published references to standards in Annex I to notice 0111/25 is proposed to be amended as follows:

- (1) references to the following standards are removed: EN 581-1:2006, EN 12491:2001, EN 1651:1999 and EN 1273:2005.
- (2) references to standards EN 915:2008, EN 12196:2003, EN 14988:2017+A1:2020 and EN 16156:2010 are moved to Annex II to this Notice and replaced by references to EN 915:2024, EN 12196:2023, EN 14988:2017+A2:2024 and EN 16156:2024.
- (3) rows 1 to 73 inclusive, including rows previously identified by suffixes to row numbers, are renumbered consecutively to create a single numbering sequence from row 1 to row 74 inclusive.

ANNEX II

The list of references to standards for removal from publication, as set out in Part 2 of Annex II to notice 0111/25, is proposed to be amended as follows:

- (1) rows 1 to 3 inclusive are deleted.
- (2) the following references to standards are added to Annex II in sequential order and will continue to confer a presumption of conformity with the corresponding essential requirements until the removal from publication date of 27 October 2027: EN 915:2008, EN 12196:2003, EN 14988:2017+A1:2020 and EN 16156:2010.
