All applicants must provide one of the following documents as evidence of name and address dated within the last year, and one document showing photo identity (if a passport is not being submitted):
<ul style="list-style-type: none"> • National identity card or equivalent (or colour photocopy) • Visa or residence permit (or colour photocopy) • Tax record eg a letter from a tax authority • Educational record eg school report • Employment record eg official letter from your employer • Letter sent to you from a central, regional or local government department.

Applicants born or adopted in the UK – parents’ or adoptive parents’ documents
Born before 1 January 1983
For both of your parents, please provide the following evidence: <ul style="list-style-type: none"> • full birth certificates • their marriage certificate.
Born on or after 1 January 1983
For both of your parents, please provide evidence under <u>either</u> 1 or 2. We need to see:
1. <ul style="list-style-type: none"> • full birth certificates; or • certificates of registration or naturalisation; and • their marriage certificate (this does not apply for those born or adopted on or after 1 July 2006 or same-sex adoptions).
2. <ul style="list-style-type: none"> • their foreign passports showing indefinite leave to remain at the time of your birth; and • their marriage certificate (this does not apply for those born or adopted on or after 1 July 2006 or same-sex adoptions).

Habitual residence is their normal home, the place where they have the strongest personal connections.

This does not apply if our parent's British nationality is based on registration, naturalisation or their immigration status.</p> <p>Uncancelled passports: We strongly prefer to receive the passport. However in exceptional circumstances where you may need to retain the passport, we will accept a full colour photocopy of the entire passport (including visa pages). We reserve the right to request the passport at a later stage as we examine your application. Please provide an explanation as to why you need to retain your passport.</p>
